3 bank MDs axed for hundi links

Loans to Agarwal, Modi undermined depositors' interest, BB says

The Bangladesh Bank vesterday removed managing directors of three private commercial banks for involvement in hundi transactions and irregularities in sanctioning loans to three business groups.

The three MDs - Mirza Ejaj Ahmed of One Bank Limited, Anwar Ahmed of National Credit and Commerce Bank Limited (NCCBL) and Mokhlesur Rahman of Dhaka Bank Limited - cannot have links with any bank for the next two years.

Two years over, they will have to seek the central bank's permission should they want any position in any

The action came after the BB found out these three banks and National Bank Limited (NBL) had flouted rules in foreign exchange transactions and failed to properly monitor the loans sanctioned to Giridhari Lal Modi and his Uttara Group, Om Prakash Agarwal and his business enterprises and Ashok Kejriwal and his Doel Group.

The central bank is still investi gating the case of NBL MD Rafigul Islam Khan, who has recently retired, and has not taken any action

against him.

The BB removal order says the MDs as the chief executive officers have failed to protect the interest of the banks in sanctioning and monitoring loans. They have sanctioned loans to four different organisations against the guarantee of a single person and not sent the loan information to the cnetral information bureau (CIB) of the BB.

"In this context to ensure the interest of the bank depositors, stop harmful activities and in the interest of the people for ensuring proper management at those banks," the MDs are removed for under the Bank Companies Act, it says.

The BB governor yesterday gave the order as per a probe of a standing committee of the central bank formed under clause 48 (1) of the Bank Companies Act. However, the removed MDs have the chance to appeal

BNP ward leader killed in Adabar

A ward unit leader of the ruling BNP was hacked to death in front of his newly married wife at Adabar in the city's Mohammadpur area yesterday afternoon.

Noor-e-Alam Babu, 30, general secretary of ward No. 43 of the BNP, was killed some 100 yards away from his residence.

Local people said three unidentified miscreants swooped on Babu who along with his wife was returning home from the local Shaheed Ziaur Rahman Adarsha Primary School on a rickshaw.

Babu founded the school at Adabar Bazar soon after the BNP returned to power in 2001. His wife. Soheli Hossain Sunny, is the assistant headmistress of the school. "Babu went to the school about

half a kilometer away from his residence at about 2:30pm to pick up his wife. He hired a rickshaw and was almost half-way to his residence when a gang of three swooped on him," said a local youth. He said the miscreants pulled

BAPEX gets block 11

The government has decided to award oil and gas exploration block No. 11 to the Bangladesh Petroleum Exploration Company (BAPEX).

"No production sharing contract for block No. 11 has been signed so far. So, we have decided to award this block to BAPEX," State Minister for Energy and Mineral Resources AKM Mosharraf Hossain told a seminar yesterday.

EC busy as **UP** polls fuel fervour

With the whole country gripped by election fever in the run-up to the forthcoming Union Parisad (UP) polls, election officials across the country spent a hectic day yesterday scrutinising a huge number of nomination papers filed by candidates vying for the offices of UP chairmen and members.

However as of yesterday Flection Commission (FC) officials only got a partial picture of the filing of nomination papers, although the official election campaign kicked off on Wednesday, the last day for submission of candidature.

The Election Commission (EC) could not finish ascertaining the number of nomination papers validated until late last night, according to officials receiving election messages from different parts of the country. As per the information provided

by the EC secretariat yesterday, a total of 2,16,878 candidates have submitted their nomination papers against 54, 899 posts in 4,223 Union Parisads while reports from 11 more Union Parisads were yet to reach the EC secretariat. In the 4,223 UPs, a total of

23,997 candidates filed nomination papers for chairmen, 1,50,616 for general members and 41,878 for women's reserved member seats.

Until last night, the election officials were busy scrutinising the nomination papers at their respective lection stations. After the scrutiny, they are expected to send the lists of candidates to the EC secretariat by today, EC officials said.

Candidates have the option to appeal to their respective Returning Officers/Upazila Nirbahi Officers in case their nomination papers are rejected. The authorities concerned would settle the cases before January 9, the last date for withdrawal of candidature

SSC, HSC grading modified

Higher studies shut to F-graders

upgraded the existing grading system to more accurately measure the aptitude of students in both the Secondary School Certificate (SSC) and Higher Secondary Certificate (HSC) examinations this year, a key ministry official said.

Introduced in the 2001 SSC exams, the grading system is likely to be introduced in the HSC

The new grading system will have an additional letter grade of A-(minus). Unlike in the existing system, a student with an F (below pass mark) in any subject cannot enrol in higher studies. The highest grade point average (ĞPA) remained the same at 5.

He said the new system will have a difference of 20 marks from 80 to 100, putting students at A+. There will be a 10 marks difference in every letter grade after the A+ Students will get letter grade A by securing marks between 79 and 70. A new cate-

FM claims success in foiling smear campaign

Bangladesh would continue to pursue a foreign policy that ensures national security and at the same time strengthens ties with its close neighbours, Foreign Minister M Morshed Khan said yesterday.

"We want to ensure national security within a stable regional context to project the image of Bangladesh as a responsible, peace-loving country and to counter efforts underway to depict Bangladesh as a fundamentalist country," he told a press conference at state guesthouse Padma in the

In the past one year, Morshed said, his government had largely been able to project Bangladesh's tolerant, democratic and moderate image abroad despite "concerted attempts to malign the country". "We strongly countered attempts to project Bangladesh as a sanctuary for fundamentalist militant outfits and a country lacking religious harmony. And, our efforts have so

Sources said that the contractual appointments of Principal Secretary to the Prime Minister Dr Kamal Uddin Siddiqui, Establishment Secretary Anwarul Bar Chowdhury, Local Government Division Secretary AYBI Siddiqui and acting Energy Division Secretary SM Shamsul Alam for the second time has further angered the officials.

They said the continued contractual appointments have forced many additional secretaries to go into retirement although they were in contention to become secretaries. Most officials said while thousands of mid- and junior-level officials who
