Man throws acid on wife, minor daughter

UNB, Moulvibazar A greedy man allegedly threw acid on his wife and his one-year-old daughter for failing to realise dowry money at village Shahbagh in Sri Mongol upazila on Tuesday.

Monohor Ali hurled acid on his wife Sharmin, 25, and the baby as house without the dowry money which he demanded time and again. They were first admitted to Sadar Hospital and later shifted to Dhaka in critical condition. A case was filed.

Demolition of brothel

Magura DC sued for violating court order

The Deputy Commissioner (DC) of Magura Mohammad Shafiul Alam was sued on Thursday for violating an injunction order regarding eviction of Magura brothel.

Rabeya and Shilpi, on behalf of the sex-workers filed the case with the Assistant Judge's court (Sadar) in Magura.

In the case, they alleged that the DC with the help of some other government officials bulldozed their houses in Natur Bazaar area in the district town on December 25. violating the injunction order.

Advocate Obayedur Rhman Advocate Ila Chandra and AZM Nurul Amin engaged by the two different non-governmental organisations (NGOs) Ain O Shalish Kendro and Naripakkha respectively moved for the plaintiffs.

Senior Assistant Judge Nitai Chandra Shaha served the notice to DC and asked him to submit if there is any objection regarding the case within February 27.

Over 400 sex workers had been engaged in their iob in some houses on the disputed lands in the Natun Bazaar area.

Last year, on April 25 the Magura district administration served notice to the sex-workers to quit the houses built on government land.

Sex workers Rabeya, Shilpi and Rahima filed a case with Assistant Judge's court against the notice. On September 7, 2002, the court issued an injunction order and asked to solve the matter after proper rehabilitation of sex workers.

But the district administration bulldozed the houses of the brothel turning the sex-workers jobless on December 25, 2002.

Despite repeated attempts, the DC could not be reached. But a high official of the local administration on condition of anonymity said, "It was only a part of the unauthorised structure demolition drive and not violation of injunction order.

When asked about the leagality of the demolition of the brothel where there is an injunction order. he said. "The part of the brothel on government land has been demolished only, but other part belonging to Zahangir Master, Anjuman Ara and Sandhya still remain untouched where the sex-workers have been

engaged in their job." Meanwhile, a mixed reaction has been prevailing over the demolition of Magura brothel in the Natun Bazaar area, by the district administration on December 25.

It's totally an inhuman action to evict the brothel without proper step to rehabilitate the sex workers", said Fakhrul Islam a human rights activist in Magura while Saiful Islam a businessman of Natun Bazaar welcomed the demolition of the

Over 400 sex workers had been living in some houses built by some local unscrupulous people on government land. Different organisations in Magura tried to evict the brothel from the renowned business

This year on April 25, the district administration served notice to the sex workers to leave the houses built on public land. Challenging the notice, Rahima, Rabeva and Shilpi, on behalf of the sex workers, filed a

case with Assistant Judge's Court. The court issued a temporary injunction order in this regard and ordered to solve the matter after proper rehabilitation of the sex workers.

But district administration bulldozed the brothel recently turning the sex workers jobless. Advocate Shahina Akhter said "As there has been a court order of temporary injunction, the eviction of the brothe is completely illegal".

Attack on motorcade of Khaleda Three accused granted bail

On the first date of hearing of the case relating to attack on the motorcade of the then opposition leader and now Prime Minister Begum Khaleda Zia, three accused Shafiqul Islam Taroon, Rezaul Karim and Masudur Rahman Bepari alias fool Masud who appeared before the court were granted bail.

The time extension petition of 21 accused including former minister Sheikh Fazlul Karim Selim, AFM Bahauddin Nasim, Khaled Hossain Yad, Kajal Krisna Dey, Shakilur Rahman Shohag, Alhaj Ferdous Jamader who are in different iail while some others are on bail by order of the High Court division have been granted for appearing later on.

Arrest warrant and order of attachment of property of 25 accused commissioner Ajgor Bepari, ex-commissioner Motaleb Gharami, Monowar Hossain, Sekander Munshi, Mosaraf Hossain and others who are still absconding, have been issued to by the court of first class magistrate MA Hakim here an December 19, court sources said.

The date of next hearing is January 29, 2003.

Court inspector Matiur Rahman stood for the government, while Advocate Sujit Chattergy Bappi, Advocate Emran, Advocate Saidur Rahman, among 30 advocates, defended for the accused.

Erosion renders lakhs homeless in Habiganj, Moulvibazar

Unabated erosion by the Kushiara River rendered lakhs of people homeless in Habiganj and Moulvibazar districts in the last 50

The erosion of the river began in 1946 and it has so far devoured thousands of houses, educational institutions, bazaars, religious institutions, post offices and vast forest areas

Water Development Board (WDB) took some measures to check the unabated erosion and rehabilitate the affected people some years back but these plans could not be implemented due to various reasons

The people of Nobigani, Jogonnathpur upazilas of Habiganj upazila and Moulavibazar Sadar upazila whose homes and lands were devoured by the river have been passing their days in sub-human condition as they are not getting any help from the government or any other non-government organisations.

Locals alleged that as the government did not take any initiative to save the age-old educational institution of Nobiganj upazila Digholbak High School it has recently been washed away by the river.

The erosion has also taken a serious turn in Bibiana-Dighalbak Gas filed area threatening its exis-

WDB office sources said a proiect was taken up at Dighalbak union to save the area from erosion in 1998 but it was not implemented due to mysterious reasons.

Local leaders and elite urged the government to take immediate steps to check erosion of the river They also demanded of the government to take necessary steps to rehabilitate the erosion-affected homeless people.
