Dhaka dubs Delhi's alien claims absurd

Buddha says centre did not inform Bengal

Dhaka has brushed aside New Delhi's claim of nearly 20 million illegal Bangladeshi immigrants in India as "baseless and absurd".

"There are no Bangladeshis residing illegally in India, nor had there been any in the past," Foreign Secretary Shamsher Mobin Chowdhury told reporters at the foreign ministry yesterday.

Meantime, according to our Kolkata correspondent Sakyasen Mittra, West Bengal Chief Minister Buddhadev Bhattacharja told the Kolkata press that "the decision is basically a decision of the centre and the fact is that the decision has

been taken without talking to us. We have not received any official intimation on this. So, how can we react

India on Tuesday decided to launch a special drive from April this year to detect and deport illegal immigrants from Bangladesh and Pakistan on "security grounds". Reuters put the figure of the wouldbe deportees at 20 million. However, Indian newspapers put the figure at 15 million.

The decision was taken at a meeting of top civil administration officials and heads of police forces of Indian states and senior federal intelligence officials, reports from

A West Bengal home department high official, talking on conditions of anonymity, described the decision as the BJP-led central government's bid to disturb peace in the state.

Bangladeshis who have entered Kolkata since 1971 have never any law and order situation, he said, "So why should we suddenly start hunting them down? It is easier to stop fresh infiltration rather than finding out illegal immigrants."

In Dhaka, the foreign secretary said. "We've seen media reports on the Indian move, but have not got it officially confirmed. We have asked our High Commission in New Delhi to let us know the context and basis

City cringes in mist and cold

Thin mists drifted lazily across nearempty city streets and life bitten by chilly wind went into hibernation vesterday. There was no sun to brighten up the grey cityscape with the mercury dropping to 12.2 degree Celsius.

The second spell of the cold wave also brought life across the country almost to a standstill.

At least 51 persons died in the last eight days owing to the cold wave, and more than 400 people suffering from cold-related ailments, were admitted to hospital in Jessore, according to unofficial

No sunlight was visible in the 16 northern districts, and heavy fog continued to disrupt normal life. Poor people are leaving their homes in search of warmer places.

Saber's remand order

stayed, bail granted

A division bench of the High Court yesterday granted an ad interim bail to Awami league leader Saber Hossain Chowdhury in the Mymensingh cinema blast case.

Also vesterday, another division bench of the court stayed for 15 days a magistrate's order that had placed the political secretary to AL president Sheikh Hasina on a seven-day remand.

While granting the bail, Justice Abdur Rashid and Justice Siddigur Rahman Miah asked the government to show cause why Saber was shown arrested in a criminal case after his preventive detention order had been declared illegal.

The judges also ruled that the former deputy minister would be on bail until the government explains its actions.

Meanwhile, as they stayed the remand order. Justice Hamidul

Chowdhury asked the government to show cause in four weeks as to why it should not be declared illegal.

Soon after the ruling, the state prosecutor moved for a stay on the order with the same division bench which was summarily rejected.

Earlier on Tuesday, a magistrate's court in Mymensingh put Saber on a seven-day remand for a case he was shown arrested in on December 28. Saber's lawyer, Mahbubey Alam

told The Daily Star last night that, if not shown arrested in any other case, there was no reason why the AL leader should not be released

Saber was arrested on December 8 without any specific charge and later detained under the Special Powers Act (SPA).

Partial army pullout begins in a week

The government is going to partially pull out troops from 'peaceful and rural areas' from third week of this month, as most soldiers will get busy with the winter exercise.

To start with, highly placed sources said, the pullout will take place at the 'grassroots level'. However, the government has decided to keep army in some upazila headquarters where situation still needs to be improved. If things improve in the trouble-prone areas, the troops would be stationed at district headquarters while the government will have a look at how things stand

Sources said the troops withdrawal goes along schedule and that it has nothing to do with the Union Parishad elections to get underway on January 25.

However the current 'Operation Clean Heart' anti-crime drive will

carry on as long as deemed fit There will be no let-up in the joint drive nor will troops be pulled out from 'crime-prone' areas, especially in Dhaka, Chittagong, Cox's Bazar Feni and some other cities and

Official sources said troops are to engage in the winter exercise which is crucial since their promotion and posting greatly depend on their performance in the exercise.

Around 24,000 army personnel have been drawn into the Operation Clean Heart that began across the country on October 17 last to catch criminals and recover illegal arms as the law and order dipped to a

menacing low. According to government policymakers, troops deployment has greatly contributed to a fall of crime incidents. However, the death of more than 40 people arrest and detention during the drive has

Water prices go up

UNB, Dhaka

Dhaka WASA (Water and Sewerage Authority), for the second time in last six months, has raised its water tariff by 5.5 per cent for domestic and 5 per cent for commercial users with . effect from January 1.

WASA water will now cost Tk 4.75 per 1000 litres, instead of Tk 4.50 for domestic and social holdings, and Tk 15.75 in place of Tk 15 for commercial users.

Dhaka WASA managing director Dr Khandaker Azharul Huq said the rise in water service tariff is due to growing operational costs, mainly because of power tariff increase.

Water pumps and Savedabad

Treatment Plant consume electricity worth over Tk 60 crore annually, and power tariff increase directly increases WASA's operational cost, WASA officials said every year

they opt for 5 per cent tariff increase as maintenance costs go up mainly due to increase of power tariff The last increase was made in

July last year, following power tariff increase in January 2002. Prior to the execution of the new tariff, Dhaka WASA informed its clients

Another death after army arrest

A middle-aged man, who was picked up by the joint forces on Sunday, died at a hospital in Gazipur yesterday morning.

According to police, a team of the oint forces picked Abdul Khaleq up from his Shafipur house at Kaliakoir after they failed to arrest his Jubo Dal leader brother.

The 40-year-old was taken to the army camp in the area for interrogation. Next day he was handed to the Kaliakoir police.

He was later produced before the court and sent to jail where he fell sick. As his condition deteriorated he was shifted to the Sadar Hospital

where he died yesterday morning. Also yesterday, the joint forces arrested a Union Parishad chairman candidate and five notorious criminals in Barisal, Patuakhali and Jhalakathi.

Sultan Ahmed, an activist of the outlawed Sarbahara Party who has filed UP chairmanship, is accused of several crimes including murder.

Two other Sarbahara activists Mukhles Munshi and Abdul Majid were also arrested.

Our Feni correspondent reports that the joint forces arrested a municipal commissioner.

An influential minister yesterday told The Daily Star that it is physically not possible to deploy army in thousands of polling centres many


"Army was not required in any

Cross-examination of Latifur Rahman finally ends

Cross-examination of Latifur Rahman, second prosecution witness in the Shazneen rape case and father of the victim, by lawyers of all the accused ended yesterday.
