## **RAT** starts operation today

The Rapid Action Team (RAT) begins its operation in the capital from today.

RAT has been formed as a follow-up measure to continue the anti-crime drive, after the withdrawal of the army, which was called out last October to tackle the growing incidence of crime across the country

RAT will start operation after the members take oath at the Rajarbagh Police Line at 11:00am today.

Sources said the RAT members will hide their identity while operat-



**BDR foils BSF** bid to push in hundreds

BDR foiled BSF attempts to push in over 1000 people through Jayantapur border in Sharsha upazila and Dhopakhola border in Benapole early morning vesterday BDR sources and local people said.

## Prices of essentials spiral

Cost of living in the city has increased significantly in less than a month due to price hike of essentials and fuel.

Commerce Minister Amir Khosru Mahmood will sit with representatives of retailers and wholesalers in the city today to discuss the situation. At the meeting, prices of some essentials may be fixed, sources said.

Prices of rice and vegetables have increased by at least Tk 2 to 3 per kilogram in the citv's kitchen markets in the last few davs. Prices of sovbean and eggs have marked sharp rise -by Tk 10 per litre and Tk 10 per dozen respectively.

## Lawyers demand withdrawal of ordn, trial for custodial deaths

Leaders of different bar associations and senior lawyers of the Supreme Court yesterday demanded withdrawal of the indemnity ordinance.

They demanded trial and punishment of the persons responsible for the deaths during Operation Clean Heart.

They called upon the government not to place the ordinance at the Jatiya Sangsad and pass it as a bill, and said that the lawyers of the country would go for a two-hour work abstention on the day it is placed at the Sangsad.
