No business problem with terror-risk list

US envoy says at trade show inauguration

Ambassador Mary Ann Peters yesterday reiterated Bangladeshi businessmen will not face any problem in doing business with the US following the inclusion of the country in the US terror-risk list.

"I don't believe that Bangladesh's image in the US will be influenced in any way by the decision," the US ambassador to Bangladesh told the inaugural ceremony of the three-day 12th US trade show, co-sponsored by the American Chamber of Commerce in Bangladesh (AmCham) and the United States Embassy at Dhaka Sheraton Hotel

Commerce Minister Amir Khosru Mahmud Chowdhury was present as chief guest at the function. AmCham President Aftab ul Islam,

Gafur and Counsellor for Political and Economic Affairs of US embassy Leonard Hill were also

Businesspeople consider Bangladesh as an investment destination on how Bangladesh treats investors and exporters operate here, Peters said defusing the concerns of local business

The US envoy said a US business firm will invest 30 million US dollars to set up an American cancer hospital in Bangladesh.

Bangladesh is now on the man of US investors." she said, viewing that the hospital project could be an encouraging example of US investment in Bangladesh when FDI flow dropped 60 per cent last year.

She said the number of partici

pating firms increased by 10 per cent, from 69 last year to 75, at the show and it is a clear indication of the existing bilateral trade relations between the two countries.

The commerce minister said some people may be affected by the decision but businesspersons of the country may not face problems.

He felt that the business people of the two countries can overcome the setback through increased partnerships.

Aftab ul Islam said the trade show will strengthen the existing trade relation between the US and Bangladesh.

He said the trade balance between the two countries is heavily tilted towards Bangladesh. From January to November 2002 the US exported products worth \$ 245.80 million to Bangladesh while it

imported goods valued at \$2024.80 million from Bangladesh, he added.

In her address, Mary Ann Peters said Radisson's presence in Bangladesh reflects yet another progress of strong business ties

"Bangladesh is a place where Americans can invest," she said,

adding that more service-oriented

businesses in this country will speed up economic growth. The SHDL is a concern of the Army Welfare Trust (AWT) and

Sena Kalyan Shangstha (SKS). AWT conceived the idea of the hotel project in 1995. The idea was materialised in the same year through a joint venture on 22 bighas

With changing market conditions, the AWT joined the SKS to set up the SHDL and the project was approved in May 2000.

About 88 per cent work on building the structure of the hotel at an estimated cost of Tk 90 crore has been completed while interior finishes, mechanical and electrical works are in progress, SHDL offi-

The hotel will have 211 guestrooms apart from two banquet ballrooms, nine meeting rooms, three restaurants, two tennis courts and a health club. There will be parking facilities for 240 cars in the hotel premises.

The hotel is only five minutes to Zia International Airport as well as five minutes from Baridhara diplomatic zone and just opposite to Dhaka Cantonment.

The recently inaugurated Army golf course opposite to the hotel will be made available for the hotel

Data show US economy making shaky progress

The US economy is making shaky progress as orders for big-ticket items edge higher but Iraqi war fears hit consumer confidence, economists said Tuesday

New home sales hit a new record in 2002, however, showing the sector is still the bedrock of the economy

The battery of mixed data were released just before Federal Reserve policymakers started a two-day meeting to ponder interest rates, already at a four-decade low.

Later in the day, President George W. Bush delivers his State of the Union address, confronting scepticism over a 10-year, 674billion-dollar stimulus built largely on scrapping taxes on dividends. Latest government figures

showed orders for durable items such as washing machines, cars and planes edged higher in December but shrank for the whole Durable goods orders expanded by a weaker-than-expected 0.2 per

cent in December alone, capping off a fragile 2002 in which orders shrank 0.2 per cent after an 11.6-per cent plunge in 2001. "Today's durable goods report is further evidence that the manufac-

turing sector is flat in the water," said Manufacturers Allliance president and chief executive Thomas Duesterberg. "Although the fundamentals are

positive, it will take a resolution of the international situation and positive momentum on the president's economic recovery plan to bolster confidence and achieve sustained growth.

Testing facilities needed to boost food export: EC

The country needs food quality testing facilities because big international corporate businesses cannot purchase many Bangladeshi food products in the absence of such facilities.

"One of the major issues that prevents the corporate businesses in the food sector from purchasing products of small and medium enterprises (SMEs) in Bangladesh is the lack of quality testing facilities," says European Commission (EC) sources.

A financing proposal for South Asia Enterprise Project Facility (SEDF), a joint facility of the World Bank and International Finance Corporation, identified the absence of testing facility as one of the major stumbling blocks in expanding export market, particularly in the Western countries, which follow stringent testing pre-condition for importing food items.

The proposal pointed out that the SEDF, which would receive larges financial support from the EC, had started and would expand the

programmes in quality management, including the introduction of testing facilities for all major food quality tests.

To develop testing facilities under the programme, the proposal said, the SEDF would network with other international and national bodies like the Scottish Enterprises Network or Board

The sources said that with the establishment of updated testing facilities the export of food items from Bangladesh, particularly to the European countries, would increase

The EC's financing proposal said that as the SMEs often operate inefficiently due to lack of professional management, the SEDF has developed a comprehensive programme to enhance the competence of the SMEs through various forms of training and system improvement, using local business service providers

Following the EC guidelines, the proposal said, the facility has assisting the SMEs to comply with the standard of environmental

Under the programme, all the SMEs will be assessed as to their compliance with environmental standards in Bangladesh.

Where needed, the SEDF will facilitate various national and international programmes and the EC's regional environmental programme to facilitate the compliance.

The SEDF will also have a proactive programme, assisting the SMEs with solid wastemanagement. Advice for these programmes will come from various EC-supported organisations in this field such as CEDRE of France, BMS of Denmark and ENSAC of the

Netherlands. The SEDF has already developed a strong linkage with the Women Entrepreneurs' Association and the Bangladesh Women Chamber of Business and Industry to support development of women

The SEDF will support the efforts of these organisations with busitechnical assistance to their mem-

India's precious metals only a dream?

"A diamond", according to the celebrated De Beers advertisement. "is forever". but it is taking forever to find deposits of these sparklers in India, the land of the Kohinoor. Not even after five per cent of India's territory was leased out to the mineral prospectors.

It is exactly three years since the amendment to the Mineral Concession Rules 1960, and since July 2000 the government has issued 119 reconnaissance permits to 20 firms, most of which are foreign-owned, to look for diamonds, gold and other metals. Some have gone to Indian subsidiaries of foreign firms or Indian firms. About 155,775 sq km or five per cent of the country's territory have been given over to prospecting companies but

government sources said since then, not a single company has applied for a mining licence as yet. Currently De Beers -- the world's premier diamond mining company -has over 20 permits, mostly in Andhra Pradesh, Chhattisgarh, Karnataka and Orissa. The total area where De Beers is prospecting is about 36,000 sq. km. Rio-Tinto has 16 permits and has operations in Karnataka, Andhra Pradesh, Madhya Pradesh and Chattisgarh spread over 30,800 sq. km. and Geo Mysore more than 20 permits in the same states. The total area Geo Mysore is involved with is about 14,000 sq. km. Most permits are for Karnataka (33) and Andhra Pradesh (32) with Rajasthan and Chhattisgarh in third and fourth place respectively with 21 and 15

A majority of the permits are for underdeveloped and poor tribal "The failure to ask for a mining lease suggests the prospectors have not found very much. If they have not found the gold or diamonds, they cannot set up plants. So, they cannot bring about economic growth," a senior official

Initially, the laws do not allow a permit to be for an area more than 5,000 sq. km. Also, no company is allowed more than 10.000 sq. kms in the country for aerial prospecting Later, the area restrictions would apply to a particular state and not the entire country. Furthermore, the firm can continue prospecting for two years after which the area under permit is reduced to 1,000 sq. km. or 50 per cent of the area granted whichever is less. After the third

year, a company should not have more than 25 sq. km. Two different companies can look for two different minerals in overlapping areas.

The aerial prospecting is supervised by the Civil Aviation ministry and a Defence clearance is required. A representative of the Geological Survey of India would have to be present. Also, all data collected would be made available to the Indian Bureau of Mines. Nagpur. There is currently talk of a high-level committee to monitor the progress of the reconnaissance operations and also joint-sector involvement in them. Currently, most firms are owned by leading multi-nationals or their Indian agen-Historically, gold and diamonds have been mined in India
