Bus fares go up

The government vesterday increased bus fare by 16 per cent. The new fare for minibuses is Tk 0.75 a kilometer and Tk 0.72 for large buses against the previous Tk 0.65 and Tk 0.62.

The fare re-fixing committee okayed the increases at a meeting yesterday at the conference room of the communication ministry. Communication Minister Nazmul Huda chaired it.

The meeting also decided to make it mandatory for all threewheelers plying the city roads to have fare meters from tomorrow. The autorickshaws namely Mishuk will get two more months to install

Earlier, the Bangladesh Road Transport Association demanded a 40 per cent increase in fare against a 14 per cent fuel price hike. The

Inflation to rise on fuel, water price hikes

ADB report says

Inflation is set to rise in the coming months on the back of fuel price and water tariff hikes, says the Asian Development Bank.

Prices of non-food items have continued to climb, up to 6.8 per cent in November from 6.4 per cent in September due to higher utility

Although rice prices remained at a relatively high but stable level, prices of vegetables came down due to the increased availability of winter crop, the ADB said in its latest Quarterly Economic Update (QEU) released yesterday

Point-to-point inflation has decreased marginally from a yearly high of 4.7 per cent in September 2002 to 4.6 per cent in November as the food price index moderated to 3.4 per cent from 3.8 per cent during

Dhaka mulls border trip for diplomats to see push-ins

BDR foils more BSF attempts

The foreign ministry may take foreign diplomats to border areas to show them the 'ground reality', if the ndian attempts to push its nationals nto Bangladesh persist.

The Indian Border Security Force (BSF) tried to push in some 150 people late last night.

The Bangladesh Rifles (BDR) foiled the attempts on the Jessore Anjulia border at around 4:30am yesterday, BDR sources said. The scheduled flag meeting

Bangladesh wants to put an end to India's repeated push-in bids through diplomatic channel, Foreign Secretary Shamsher Mobin Chowdhury said at a weekly press briefing at the foreign ministry vesterdav

Rajuk to sue officials for missing files

Rajuk will soon be filing criminal cases with four police stations for the loss of hundreds of building construction plans from its archive sources said

A top Raiuk official said, currently they were not naming anyone as accused. However, on filing the cases, the police would investigate to identify the culprits.

Following the disappearance of about 200 files, the Rajuk Board members approved the decision to file criminal cases. An organised gang of engineers, architects, bureaucrats and petty officials are believed to be involved in the scam, top Rajuk officials alleged.

The files went missing from the Rajuk archive to suppress the evidence of irregularities regarding approval of high-rise and other buildings in the city.

Sources said in most cases whenever Rajuk's top officials were required to investigate a building violating various construction rules, most of the files could not found in the archive.

Donors for joint watch on NGOs

Objection to proposals for service charge, registration

Donors want a role if the government keeps a watch on the nongovernment organisations (NGOs) for 'political links'.

They also objected to the government's intention to impose 1 per cent service charge on NGO fund.

The views were expressed at a meeting yesterday with a cabinet committee to discuss a proposed national policy for the NGOs.

The donors agreed that NGO activities should be monitored to get to know whether their funds are being used for political purposes. but said the watch should be from both sides.

"We want donors' participation in the monitoring," one of the donor representatives told the meeting.

The cabinet committee is now at the final stage of formulating a national NGO policy. In its 17-point proposal, the committee suggested imposition of service charge on foreign grants and monitoring of political activities' of NGOs.

Donors viewed that imposition of service charge would discourage them from channelling funds to Bangladesh. They said this amounts to imposition of tax on

The cabinet committee members however argued that the proposal was made in line with the existing NGO regulations.

One of the donor representatives then asked the government to explain how it defines the NGOs.

The government said the charge would not be applicable to international donors and is meant for the local NGOs.

The government also claimed that the proposal requiring NGOs to obtain certificates from the district administrations to get funds released from the NGO Affairs Bureau has been made to bring transparency in the NGO activities However, donors opposed the proposal Later, the government said if

League (AL) brought out the procession demanding immediate resignation of the four-party alliance government and in protest against graft charges against AL chief and former prime minister Sheikh Hasina in MIG-29 purchase case Witnesses said breaking police

barricade in front of the AL central office, the procession started marching ahead in the evening. Police resorted to baton charge as Jubo League activists hurled brickbats at them when the procession reached near Peer Yameni Market. Chasing the fleeing AL and Jubo

Mob beats four to death

Fleeing muggers shoot 2 guards

An alleged extortionist and three suspected robbers were beaten to death in separate incidents in Tikatuli in the capital and Munshiganj yesterday.

Nadim, 28, along with a few others, robbed the manager of the Madonna Hotel in Tikatuli of Tk 4.000 after they had lunch there at about 2:00pm.

The gang then went to the Motaleb Mansion a block away and demanded money from a trader of the market, threatening him with The trader with back-up from




