Cell phone firms demand shutdown compensation

The mobile phone operators have asked for compensation from the government for repeatedly suspending their networks and mounting their losses.

They are calculating lost revenue due to such shutdowns. Individual demand for compensation would be placed together to the government

very soon.

"If the government does not compensate as per the law, it will shatter investors' confidence," cautioned a major foreign telecom

directors of GrameenPhone, CityCell, Aktel and Sheba was sent in this regard to the secretary of the Ministry of Post and Telecommunications.

They also protested the fact that the state-owned fixed telephones were functional while the private mobile networks were suspended.

It has been "creating circumstances for our valued subscribers to feel discriminated and inconvenienced," the letter says.

The government has the prerogative to suspend the mobile networks as per the telecom law. But it also requires the government to compensate the operators for such temporary shutdown, which has never happened, the letter noted.

The caretaker government perceived cell phone as a tool of coordinated rigging and civil disobedience during the eighth parliamentary election. Accordingly, the ministry, which then used to be the telecom regulator, ordered countrywide shutdown of all mobile ser-

vices for 24 hours commencing from 6:00am on October 1, 2001.

Since then it has been a routine practice to shut down mobile networks during any election. However, the Bangladesh Telecommunication Act 2001 became effective in January 30, 2002 and the regulatory authority was transferred to Bangladesh Telecommunication Regulatory Commission (BTRC).

But the ministry has been ordering suspensions of mobile networks. Apart from the elections and by-elections of the eighth parliament, the mobile networks were kept shutdown altogether for 161 hours on account of city corporation and municipal elections.

The ministry also verbally instructed the operators to snap their services in Dhaka for six hours during the first four nights of the "Operation Clean Heart." Now the deputy commissioners of various districts are ordering the mobile companies to keep their network down in the Union

Parishad electorates during the polls.
"It is very difficult to comply with

such orders," complained a highly placed source of the mobile industry. Rolling out one after another "cell" of radio signals makes a mobile

of radio signals makes a mobile network. Such deployment of cells generally crosses over the administrative demarcations. If a network covering a constituency is required to shutdown, a large part of its surrounding area also faces communications blackout.

"We cannot justify such interruption to the peripheral subscribers and the government should protect us from such disruption," commented a source, requesting anonymity.

The telecom secretary could not be reached for comments.

"I have been told that the operators have given us a copy of the letter on this compensation issue and we will do the needful according to the law," said Syed Margub Murshed, chairman of the BTRC.

Permanent venue for trade fairs planned

Dhaka int'l trade fair concludes

The government is going to set up a permanent trade fair venue on a 35-acre of land near old airport area in

Dhaka.
Terming the present venue, where the Dhaka International Trade Fair is held, unhygienic, Commerce Minister Amir Khosru Mahmud Chowdhury said the Export Promotion Bureau (EPB) has already acquired 17 acres of land to construct the permanent

The minister was speaking at the concluding function of the Dhaka International Trade Fair 2003.

LGRD and Co-operatives Minister Abdul Mannan Bhuiyan attended the ceremony as chief guest while Commerce Minister Amir Khosru Mahmud Chowdhury and State Minister for Commerce Barkatullah Bulu were present as special guests.

Bhuiyan urged local manufacturers to improve quality to tap new markets and restrict smuggling of

He said after 2005, quota and preferential treatment in garment sector would be abolished. Quality and price will only determine the market leaders at that time, he added

Referring to smuggling of cheap foreign items, which rob gains of local products, he said if quality and competitive price are guaranteed consumers would surely switch to local goods.

"It's not possible to check smug-

gling by framing laws. Quality goods at comparatively low prices is the answer," he said, "If we offer eggs to consumers at competitive prices, those will not come from India," said the minister.

He advised local entrepreneurs

to follow this formula to earn consumers' confidence and acquire a healthy share in world trade volume.

nealthy share in world trade volume. Some 414 enterprises from 21 countries took part in the annual fair. Around 14 lakh people visited the fair against 20 lakh last vear.

For the first time, the organisers allocated stalls for tribal and rural women for only Tk 1,000 instead of usual fee of Tk 90,000 as a gesture to promote business of the underprivileged section of the society.

However, the organisers alleged non-co-operation by the police, which caused some mismanagement. The exhibitors also blamed police for some 'untoward incidents,' they said.

Bhuiyan distributed prizes among participants for their performance during the month-long fair, which was opened on January 7.

Basundhara Paper Mills got the first prize in the pavilion category while Asian Textile Mills Ltd bagged second prize. Star Particle Board Mills and Akter Furniture Ltd jointly received third prizes.

BRB Cable Industries got first prize in mini-pavilion category and Artisti Collection bagged first prize in stall category
