The judgement was pronounced on Sunday by Additional District Judge Didar Ali Fakir. The bottles of phensidy were recovered from the accused on November 3 in 2001. A case was recorded with Khulna thana on the same day, while chargesheet of the case was submitted on April 29 last

992 farmers in Magura face certificate cases, flee houses

A total of 992 farmers in four upazilas of Magura have fled their houses after being accused in certificate cases.

Official sources said, in the entire district, 992 certificate cases have been lodged by the Bangladesh Krishi Bank (BKB) authorities, against unrealised loan amounting to 1,09,35,865 taka.

In Sadar upazila, 738 certificate cases have been lodged against the loan of 25,72,908 taka, in Sreepur upazila, 81 certificate

29,14,950 taka, in Mohammadpur, 71 cases against 23,48,662 taka and in Shalikhal upazila, 102 certificate cases have been lodged against the unrealised loan of 30.99.345 taka.

Most of the farmers borrowed loans for agricultural work. Unfortunately they could not achieve their production target due to price-hike of seeds, pesticide and fertiliser, they said to The Daily

"I took 2,000 taka only which now

stands at 7,500 taka including interest", said Shiekh Jamil, an accused of a certificate case to this correspondent. Fearing arrest, he had to flee

Another accused of certificate case at village Niznanduali in Sadar upazila said to this correspondent, " I took 6,000 taka as agri-loan which I was compelled to spend for my daughter's treat-



40 hurt in separate clashes in Sirajganj

At least 40 persons were injured in two separate clashes at Rishidha and Dubil in Sholonga police station and at village Ekdala in Sadar police

According to police and eye witnesses, the clash erupted when the villagers at Rishidha assaulted Jahangir Hossain of Dubil. Then the supporters of Jahangir attacked them. Both the groups used lethal weapons during the clash. About 25

persons were critically injured. Ayenuddin, 30, Nasiruddin, 32, and Ibrahim, 45, of Rishidha and Jahangir of Dubil were admitted to Sirajganj General Hospital.

In another incident a group of villagers at village Ekdala locked in a clash. About 15 persons were critically injured. Two were admitted to Sirajganj General Hospital.

Crisis of insecticides hampers boro farming in Habiganj

Acute crisis of Furadon brand insecticides has been hampering the cultivation of high yielding Boro paddy in Habigani.

The current Boro cultivation has already been affected and delayed due to recent severe cold wave, according to farmers.

The farmers who are now very busy in planting Boro seedling have been hard-hit by the pricehike of TSP and Potash fertilisers and diesel.

Non-availability of Furadon granules insecticide has further

aggravated the plights of the farmers.

Furadon granules insecticide is very much effective to control mazra and other insects harmful to Boro paddy, the farmers said.

It also helps increase production, they said.

The farmers complain that there is no insecticide in the markets for the last few months. Some insecticide traders told BSS that Padma Oil Company which is the distributor of Furadon has been failing to supply insecticides to meet the demand of farmers
