# Irish, Bangladeshi relieve four children of certificate case

Because of noble gesture of two gentlemen, an Irish and a Bangladeshi, four innocent children in Magura were relieved of certificate cases

A story titled, "Innocent Victims of Certificate Case", was published on January 19 this year on the National Page of The Daily Star. It drew the attention of the Irish citizen named Mark Hurley who was on a business tour in Dhaka. He is the sales director of G P Kelso Limited, manufac-

turers and distributors of men's and boys wear, at Robinhood Business Park, Naas Road, Dublin, Ireland. Reading the article he at once went to the Head Office of BKB at Motijheel, Dhaka and talked to the

officials there. The loan amount was

settled at 11,200 taka which he paid on January 21. On January 22, Mahtab Rahim, a

Bangladeshi citizen and chairman of Rahim Aloy Steel Mills, Dhaka paid 10,000 taka to BKB. Both the noble men jointly repaid 21,200 taka. Rest of the total loan was exempted by the bank authorities, officials said. In January 2003 the loan including interest and expenditure of the case stood at 31,561 taka.

The story was that the children's father Nayeb Ali Molla of village Kalinagar in Sadar upazila. Magura borrowed agricultural loan amounting to 10,000 taka from the main branch of Bangladesh Krishi Bank (BKB), Magura on December

the loan was December 3,1990. He failed to repay the loan on time due to abject poverty. He died of hydrophobia in 1993. Before death he repaid 600 taka only. Ultimately four of his innocent children Moina, 9, Chaina, 10, Phool Mia, 12 and Rahela, 14, fell victims of the case as Nayeb's wife Hasina failed to repay the same

Hasina personally came to the residence of this correspondent and informed him with tears of joy that her children were finally relieved of the loan. She expressed her grati tude to him. The BKB authorities also handed over the copies of documents to this correspondent where it was stated that the four children were totally relieved of the case.
