Unilateral Iraq strike to be violation of UN Charter

Moscow warns Washington

AFP, Baghdad

Russia warned Washington Saturday that it would be violating the United Nations Charter if it attacked Iraq without a UN mandate, as Baghdad destroyed more banned missiles and warheads under UN supervision.

Iraq's push for disarmament compliance followed a draft resolution given the UN Security Council Friday by the United States, Britain and Spain, which would give Baghdad a March 17 deadline to fully disarm or face

Although the resolution -- with three of the five veto-wielding

council members against it -- stood little chance of passage, US President George W. Bush reiterated his resolve to go to war alone.

"We don't really need United Nations approval," he said late in the week, although his government says it would much prefer to have the approval of the international

Russia labelled the March 17 line in the sand unnecessary and unjustified and echoed a threat from France, which also has a veto on the council, to block any resolution authorising the use of force.

Russian Foreign Minister Igor States unilaterally launched a military strike on Iraq without a UN mandate, it would be in violation of the UN charter," in which case the Security Council would have to "make appropriate decisions."

In Baghdad, the UN inspectors' spokesman said Iraq had scrapped a further six of its banned Al-Samoud 2 missiles after a day's ause, raising to 40 the number of the missiles destroyed since the operation began a week ago.

"Six more Al-Samoud 2 missiles were destroyed, along with three warheads," spokesman Hiro Ueki

Iraqi officials have said about 100 of the rockets were made Bush derided those efforts as a

"willful charade" to thwart UN inspectors.

He also rejected an assessment by chief UN weapons inspector Hans Blix that the destruction of the banned missiles represented 'substantial" disarmament.

"Our intelligence shows that even as he (Iraqi leader Saddam Hussein) is destroying these few missiles, he has ordered the continued production of the very same type of missiles," Bush said in his weekly radio address.

5 Padma staff remanded

Five of the 13 employees of the Padma state guest house arrested in connection with the mysterious appearance of a person at the room of visiting Mayanmar Foreign Minister U Wing Aung on the night of March 2 were placed on two days' remand yesterday.

Police produced all the 13 before the CMM's court but sought remand for five of them. They are Alamgir Hosain, Nurul Islam, Nurul Amin, Golam Rabbani and Lutfor Rahman. The rest were sent to Dhaka Central Jail.

In the forwarding report, the investigation officer (IO) of the case said valuable information were gathered regarding the incident, but more interrogation of the accused was needed.

Wing Aung, who came to Dhaka on March 2 on a two-day visit, left the state guesthouse at about midnight, complaining that somebody entered his room.

On that night, he had told the security personnel at the sate guest house that he did not feel safe there and wanted to go to the residence

New trade deal likely to be finalised at Delhi talks

Bangladesh and India are likely to finalise a new bilateral trade agreement during the two-day commerce-secretary level trade talks scheduled for a March 24 start in

A bilateral investment agreement will also be tabled during the talks since New Delhi has long been asking for such a deal, according to commerce ministry sources.

The existing trade agreement, signed in 1980, was last extended for four months in last month. Dhaka had been seeking some changes in the agreement as it said the accord was not 'serving equally interests of both sides'.

Dhaka finalised the draft of the new trade agreement and sent it to New Delhi in 2001. But differences with New Delhi on the nitty-gritty of the draft delayed finalisation of

"We have narrowed down our differences on the trade agreement and expecting to finalise it during the talks," a source in the Indian High Commission in Dhaka said.

Apart from its demand for a zero-tariff access fore its goods, Bangladesh would press for removing the non-tariff and paratariff barriers on its products to Indian markets during the talks.

Dhaka would also ask New Delhi to allow it to open two trade missions and a few branches of the nationalised commercial banks $(NCBs)\ in\ some\ important\ towns\ in$ the northeastern Indian states.

Commerce Secretary Suhel Ahmad will lead a six-member Bangladeshi delegation for trade talks with the Indian side to be led by his counterpart Dipak

Commerce ministry meets today to discuss different issues that would come up during the trade talks. Officials of different ministries and business people will attend the meeting, according to

Opinions would be invited on New Delhi's proposal for opening a branch office of the State Bank of India in Chittagong and starting production of an Indian pharmaceutical industry in Bangladesh.

Meanwhile, businesses of the two countries today start a discussion In New Delhi on the bilateral trade and business issues ahead of the trade talks. A delegation of the Metropolitan Chamber of Commerce and Industry (MCCI) leaves the country for New Delhi SEE PAGE 11 COL 6

Tk 92 lakh goods, forex seized at ZIA

Customs officials at the Zia International Airport seized US dollars and electronic goods worth about Tk92 lakh Saturday night.

A team of customs stopped Ziaul Amin Khan, and recovered 20,500 US dollars from his possession. Khan, a Bangladeshi-British, was stopped at the boarding bridge 5, prior to his departure by a Singapore Airlines flight-- SQ-435 at

Khan told the customs officials that he was engaged in business with a Singapore company, Seba Vision, and was carrying the money to pay it to the company. Khan was holding a British passport (PGBR-025005648, dated November 27,

"The passenger was not carrying any declaration against the dollars, a customs official at the ZIA said.

The passenger was allowed to leave the country but the customs seized the money and deposited it to the customs warehouse. A departmental case was filed in this

In another incident, customs officials recovered 556 pieces of mobile phone, 58 mini cassettes and other electronic goods worth about Tk 80 lakh. Mobile chargers, mobile batteries and video camera batteries were among the consign-

The Dragon Air flight 110 landed at the ZIA at 1:00am. After clearing the luggage, a customs team found 21 unclaimed bags.

Later, those bags were opened in front of the representatives of different agencies at the airport, and a list of the goods was prepared.

The customs officials seized the goods and filed a departmental case n this regard.

Armed attack in Rupsha

OC closed, 10 arrested

Abu Bakr, officer-in-charge (OC) of Rupsha thana, has been closed to the police lines and suspended on charge of negligence of duty during Friday's armed attack in Bagmara village that left eight persons including a BNP leader critically injured, sources said.

The suspension order was issued from the DIG Range office on Saturday night.

OC Abu Baker is the third police officer suspended in connection with the incident; SI Abdul Majid and ASI Shafiqur Rahman were suspended earlier on Friday on the same charge.

Ten people have so far been

shown arrested in connection with the attack. They are Kamal, 20, Yunus Sardar, 40, Abu Shaikh, 40, Murad Shaikh, 20, Mahbub, 38, Akram Ali, 22, Saiful Islam Palak, 23, Babu Shaikh, 26, Juman, 30, and

Jumman and Billal are cadres of the outlawed Purbo Banglar Communist Party (PBCP), police A case was filed yesterday with

the Rupsha thana by a relative of the injured Rupsha upazila BNP leader Mohiuddin Shaikh. None however was accused in the case.

Local people say the attempt on the life of Mohiuddin is a sequel to an intra-party rivalry over the leadership of Rupsha-Bagerhat

Minibus Owners' Association. Mohiuddin, who is general secretary of the association, has had strained relations with his rival group for a year now over toll collection from minibuses plying the Rupsha-Bagerhat route.
