New Colony residents protest housing ministry's plan to eat up playground

Several hundred men, women and children joined hands over a demonstration against construction work on open spaces and the playground of New Colony at Asad Gate vesterday.

They shouted slogans for immediate cancellation of a housing department project covering every bit of open spaces in the colony area and one of the last remaining playgrounds of the city.

Housewives, the elderly, children, students and professionals from the New Colony, Lalmatia, Dhanmondi and Mohammadpur expressed their solidarity with the Bangladesh Paribesh Andolon and vowed to save the playground and open spaces from whom they called 'land pirates'.

Officials at the housing department under the Ministry of Housing and Public Works said they would build 500 flats to sell to government officials and employ-

The angry protesters termed the activities of the officials 'criminal, undemocratic and mindless'.

The government is violating "all norms of a civilised society" by grabbing playgrounds and open spaces, said a demonstrator.

Influential project contractors, allegedly backed by a brother of a minister, have filed false complaints against three frontline protesters with the Mohammadpur Police Station.
