# Brick kilns pose a threat Two students die in separate to environment in Panchagarh

Indiscriminate felling of trees by brick kiln owners has been threatening the environment

This phenomenon has posed a threat to public health also.

The owners burn bricks by using firewood as fuel

As a result, a large number of fruit bearing trees are vanishing fast.

There is a tendency among rural people to sell their fruit bearing trees to brick kiln owners. But they do not know  $its\,adverse\,impact\,on\,environment.$ 

Owners of brick kilns have been using firewood in their brick fields violating a ban imposed by the government on it. They are violating the law of the land under the very nose of the law

As per Brick Burning Control Act

 $According to the Act, a \, brick \, kiln \, can$ be set up on minimum 1.5 acres of land but many brick field owners use three to five acres of land for setting up a

According to rules, kiln owners are bound to install minimum 50 feet high chimney with filter in every kiln for

However, most of kiln owners use lower chimneys, giving rise to air

A circular from the Land Ministry in 1990 said Deputy Commissioners can only allow unfertile and fallow land for setting up of brick kilns, but in Panchagarh many brick fields have been set up on arable lands.


Some brick kiln owners, however said to BSS that crisis of coal had forced them to use firewood in kilns. Crisis of coal has been prevailing in the area for a long time, they added.

The brick kiln owners did not take approval from the Environment Department.

There are many brick kilns at Satkhamer, Vallaypara and Balampur under Atowari and Boda upazilas. Owners of the kilns use firewood while burning bricks.

Local people have demanded of the authorities concerned to take proper steps to stop the illegal practice.

Local people complained also that kiln owners used to buy trees from villagers taking advantage of their poverty. They do so in connivance with a section of dishonest government

Joypurhat Sugar Mill may incur a loss of Tk 6 crore as the target of sugar production was not achieved in the

A target was set to produce 18,600 metric tons (MTs) of sugar by crushing 2 lakh MTs of sugarcane, but only 13,705 MTs of sugar have been produced against the target.

The average rate of sugar collection from sugarcane was 6.87 per cent against the target of 7.6 per cent. The mill incurred a loss of Tk 4 crore in the last sugarcane-crushing season, mill sources said.

### No progress in Radhuram murder case

Seven months after the commission of the crime, none was arrested or any progress made in the sensational

Radhuram Barman of village Sukhanpuri in Sadar upazila was found hanging from a tree on August 14, 2002, two days after he filed a case for raping

A murder case was filed on the basis  $of \, severe \, injury \, marks \, found \, on \, the \, body \,$ of the Radhuran

Police are trying to weaken the case at the instance of local influential people and so far they failed to submit charge sheets of any of the rape or murder case.

Investigation officer SI Nur Mohammad had also been sent on forced retirement recently putting the case virtually in abevance.

Villagers said there has been a conflict between Radhuram and Shashi Mohon Barman over the marriage between Radhuram's daughter and Shashi's son Dilip Chandra Barman.

Dilip developed an illicit relation with the daughter of Radhuram and later he was forced to marry her in village arbitration, which his father refused to accept. Later she was sent to her father's

Locals said Dilip along with his accomplices recently raped her when she came out of her father's house at dead of night to respond to the call of nature and Radhuram filed the rape case against the culprits for which he had to

The employees have been working since 1992 at the medical college after approval of ECNEC. Five medical colleges in Bogra, Dinajpur, Faridpur, Khulna and Comilla started function-

According to a recent circular of the Establishment Ministry all the regular employees of five medical colleges would be re-employed or daily wage basis, they said.
