# Cantonment road reopened to public for limited hours

Military authorities yesterday said they were forced to revert to an earlier time schedule for civil vehicles to use main cantonment road as "alternative road" due to growing traffic pressure.

According to an Inter-services Public Relations ((ISPR) statement, civilian light vehicles would now be allowed to use the cantonment road during the construction of the Mohakhali flyover from 8:30 am to 12 noon and from 3:30pm to 11:00pm in line with an earlier decision taken at a coordination meeting.

The army authorities later relaxed the timetable allowing civil vehicles to use the road from 6:00 am to 11:00 pm for nine months in two phases hoping the other alternate passages would be

# Six arrested, hunt for other accused on

Police have so far arrested six people in connection with college girl Farzana Afrin Rumi suicide case

The arrestees are Saleha Begum, 40, Rahima Begum Shetu, 42, Arifur Rahman Russel, 28, Shahdad Hossain, 24. Mizanur Rahman, 30, and Bacchu Molla, 25, of them, Saleha Begum and Rahima Begum were taken on remand for quizzing. The two women are mothers of FIR-named accused Mizan and

Farzana Afrin Rumi, 19, only daughter of Abdul Bari of Pabla ward under Daulatpur Police Station, committed suicide by hanging herself from a ceiling fan in her bedroom on Monday.

According to Rumi's parents, drug

She was found hanging from the ceiling fan of her bedroom at 2.30 pm.

Her dead body was recovered by police on Monday afternoon and sent to the morgue for autopsy. She was buried at her family graveyard at Gazipara under Sadar Police Station of Piroipur

According to her father Abdul Bari, who is an accounts officer of BFIDC's Khulna office, drug addict Rony teased her daughter over the last five years.

"Daulatpur police never recorded my written complaint as GD about this matter. As a result, Rony and his associates were emboldened to tease my daughter," Abdul Bari said.

Abdul Bari and his wife Jahanara Akhter said that drug addict Rony wanted to marry Rumi. "We refused with consent of our daughter," they said. She received threats of abduction and acid attack several times while going to and returning from college for refusing to marry Rony, said her parents.

Abdul Bari has lodged an FIR with Daulatpur PS, accusing Rony and his associates of compelling his daughter to commit suicide. The case has been recorded under Sections 448/306/334 of

Meanwhile, Home Minister Altai Hossain Chowdhury has ordered the KMP commissioner to arrest the culprits responsible for compelling Rumi to commit suicide.

# Political jockeying hots up in post-Saddam Iraq

Iraq's confused post-war administrative landscape became even more blurred yesterday, as US forces denied sanctioning the appointments of two Iraqis claiming to be the governor and mayor of Baghdad. The political jockeying for position in

Iraq gathered steam as the United States prepared to bring in tens of thousands of new troops to stabilise the country after the fall of Saddam Hussein. On Wednesday, two close associates

of an Iraqi opposition leader said they had been elected governor and mayor of Baghdad by tribal and religious chiefs acting with the consent of occupying US But Captain Joe Plenzler, a spokes-

man for the US marines, shot down the claim. "Anyone declaring themselves as The US government has not appointed

"Anyone can call themselves anything they want to," Plenzler told AFP. "But future appointments like this will be handled through USAID (the US Agency for International Development).

Mohammed Mohsen Zubeidi, a veteran anti-Saddam politician, earlier looked official enough with a huge media entourage to boot as he proclaimed himself head of a new interim administration for Baghdad.

Zubeidi said Iraq's political life was reawakening, with 65 parties preparing to resume activities banned by the Saddam regime before the fall of Baghdad on April 9.

"We will be a model of democracy," the 51-year-old Zubeidi told a news conference at the Palestine Hotel before
