With the tough talking from Islamabad and New Delhi on the rise recently, the United States has once again taken initiative to diffuse tension between the $two\,perennially\,bitter\,countries.$

US Deputy Secretary of State Richard Armitage is set to visit India and Pakistan next month in a bid to reduce the hostility between the nuclearpowered South Asian neighbours. Dates of his visit are yet to be finalised. Armitage's visit will take place hot on

the heels of a trip to Washington by Brajesh Mishra, a top aide of Indian Prime Minister Atal Bihari Vajpayee and National Security Advisor, early next month. US Assistant Secretary of State Christina Rocca is also likely to travel to India and Pakistan soon after Armitage's

suicide case surrenders

Hasan, one of the three FIR-named accused in Farzana Afrin Rumi suicide case, surrendered to the CMM's Court here at 2-45 pm yesterday.

He was taken on a three-day remanded. Two other accused in the case -- Rony and Mizan -- are still at

"I have surrendered to save my innocent mother from being harassed by police", Hasan told his lawyers in the

His mother, Rahima Khatoon, was arrested on Tuesday, a day after Rumi's suicide. She was also taken on a two-day remand. On expiry of her remand, the

court sent her to the district jail. College student Farzana Afrin Rumi, 19, committed suicide in her bedroom after being sexually abused by the accused on Monday.

Relatives of Rumi and her father Abdul Bari have alleged that Rony has threatened them to withdraw the case or face dire consequence.

"I am helpless and feeling insecure due to threats," said Abdul Bari.

Meanwhile, there is no headway in the investigation of Bina Rani Mondol suicide case recorded with Paikgacha thana of Khulna district.

The prime accused Sanjoy Sana is vet to be arrested. But his mother Kabita Rani Sana, one of the three accused in the case, was taken into custody on Thursday midnight.

Foreign tourists turn back on Cox's Bazar ABUL KALAM AZAD, back from Cox's Bazar

Over the last couple of years, the world's longest sea beach at Cox's Bazar has seen a drastically reduced number of foreign tourists.

In addition to various other factors, this reduction of foreign visitors have mainly been attributed to the unfavourable atmosphere of insecurity that exists in and around the beach

According to local people, a large number of foreigners were seen in the area even two years back.

But the numbers started declining when untoward incidents occurred in which some foreign tourists were

Sources said several such incidents took place in the beach area over the last few years including the harassment of an Iranian lady. A group of youths allegedly teased her when she went to a money exchange shop. Many, however, believe the war on

Iraq is holding back visitors. "Precious few people came here during the last five months and the number is decreasing daily," said a seashore shopkeeper. On the flip side, atmosphere in and

around the beach area has improved a lot over the past few months following steps taken by the local administration. The district administration has

intensified security measures in the beach. Measures were also taken to keep the beach area clean. "There is now round-the-clock security to avert any untoward inci-

dent," said an official of an intelligence

Death of army man near JS

Tejgaon OC charged with murder

The arrested Officer-in-Charge (OC) of Tejgaon Police Station, Saud Islam. has been charged with murder following the death of army sergeant Mohammad Azimul Awal who was severely beaten up at Sangsad Bhaban area on April 9.

Saud was earlier charged with attempted murder after the incident which left the army person clinically dead for four days before his demise.

Chief Metropolitan Magistrate's Court, Dhaka issued an order to turn the attempted murder case into a murder case following a petition submitted by the investigation officer (IO) of the

In his petition, IO Assistant Superintendent of Police of the Criminal Investigation Department (CID) Khalequzzaman said the army sergeant succumbed to his injuries after fighting for life at the Combined Military Hospital (CMH) for four days.

So, the case should be turned into a murder case. After hearing the petition, Magistrate Kamrunnahar issued the

Police said Awal was picked up from Sangsad Bhaban area on the night of April 9 on charge of anti-social activities. He sustained severe head injuries when he jumped off the police van and was admitted to the CMH, Teigaon police

A clinically dead Awal was declared dead on Wednesday.

Army refused to accept the police claim and alleged that the OC along with some other policemen picked up the army officer when he was returning to an army camp from patrol duty

They tried to kill Awal to settle scores over harassment of some policemen during the Operation Clean Heart, army

After the incident, the OC was closed and interrogated by top police officials. He was later taken on a one-day remand on April 12. Later, he was sent to the Dhaka Central Jail

Saddam's former Shazneen Case finance minister, 2 others arrested

Officers from Iraq's newly revived police force arrested Saddam Hussein's former finance minister -- one of the 55 ex-leaders on the US most-wanted list and turned him over to the marines, the US Central Command said vester-

Hikmat Mizban Ibrahim al-Azzawi, who also served as a deputy prime minister, was apprehended Friday in Baghdad, the command said.

He was captured the same day that one of Saddam's top scientists -depicted as the mastermind of Iraq's nerve agent programme -- turned himself in to the Americans. The apprehension of Emad Husayn Abdullah al-Ani raised hopes of a breakthrough in the as-yet-fruitless search for banned chemical and biological weapons in Iraq.

But Abdullah al-Ani denied that Iraq

was developing weapons of mass destruction, a US official said. Other figures from the most-wanted

Kazi Rahamat Ullah, Judge of the Second Special Tribunal for Prevention of Women and Children Repression, Dhaka, yesterday adjourned the hearing following a time petition by the prosecution lawyers.

Earlier, victim's father Latifur Rahman and 10 other prosecution witnesses were cross-examined.

All the six accused -- Hasan Shahid, Badal, Shaniram, Minu and Parvin -- were produced before the court during the hearing.

Shazneen Tasnim Rahman, 15, the youngest daughter of Latifur Rahman Chairman of Transcom, was raped and murdered at their Gulshan residence on April 23, 1998

Latifur Rahman filed a murder case with Gulshan police station accusing Shahidul Islam alias Shahid, a domestic help at his house, the following day.
