### SAARC still has future, Jockeying for

The South Asian Association for Regional Cooperation (SAARC) can still be a strong forum for development, provided its member states and secretariat play proactive roles, said Sri Lankan President Chandrika Kumaratunga.

"There are political problems between two member states (of SAARC)," Kumaratunga said alluding to India and Pakistan

Despite all odds, the forum must move forward, she told the press at the Sonargaon Hotel yesterday afternoon prior to leaving Bangladesh after completion of a two-day visit.

Kumaratunga also spoke on the ongoing peace process in her country to put an end to decades of an ethnic strife.

The sixth attempt to have a negotiated settlement of the separatist move $ment\,of\,LTTE\,is\,now\,going\,on, with\,talks$ and a ceasefire for the longest time ever, she said.

## appointment of HC judges on

A fresh bid to appoint about 10 additional judges to the High Court has hit a snag due to intense lobbying by ministers and leaders of the ruling four-party alliance to get their closer

A law ministry source said the ministry was preparing a list of judges for appointment, but desperate lobbying was delaying the process.

However, the ministry has decided to finalise the list anyway -- whether some of the lobbyists are happy or not

For the 10 posts, three would be selected from judicial officials and the rest from government law officials and practicing lawyers.

The ministry is facing difficulties to finalise seven from the latter category.

Four-party alliance partner Jamaat is pushing for the appointment of one of its men while coalition leader BNP is pursuing the case of one of its closer one, a ministry source said.

In addition, some ministers from the legal profession as well as some senior lawyers are jockeying for their persons, a Bar member said

# US blocks relief in northern Iraq

UN arms inspectors must return to verify any WMD, says EU external affairs commissioner

The United Nations and international aid agencies accused the US military of deliberately hindering the relief programme by stopping relief flights from coming into northern Iraq.

The UN has 30 workers stuck in Larnaca, Cyprus, after failing to get security clearance from US military authorities for their own planned

Veronique Taveua, spokeswoman for the UN Office of the Humanitarian Coordinator in Iraq, said the delay meant the organisation could not oversee food, water, health care and demining programmes in the region.

She added: "This is slowing down the delivery of humanitarian aid. It's too long a process to return to an area where direct conflict did not occur.' Meanwhile, the first emergency

shipment of food reached Baghdad vesterday, as the UN significantly increases the scale of its aid to Iraq in an effort to avert an impending humani-

Cabinet decides on flag rule today

Local ship owners resent move

The cabinet would decide the fate of the Bangladesh Flag (protection) Ordinance (1982) today amidst continued protests by the local ship owners, according to sources.

The proposal contains claims, which the local ship owners dismiss as "misrepresentation of facts".

The proposal made for the cabinet meeting claimed that the ordinance ensuring at least 40 per cent of cargoes to national flag carrier vessels was outdated and not consistent with the present day world economic situation.
