Bangladesh's bowlers toiled under the sun as South Africa took a firm grip of the GrameenPhone first Test at the MA Aziz Stadium yesterday.

By the close of play, the tourists had replying to the home team's first innings total of 173.

The story of the second day was the application and mental fortitude displayed by Jacques Rudolph and Boeta Dippenaar (131). The third wicket pair who came together with the score 41 on Thursday, added another 323 runs without being separated.

Along the way the left-handed Rudolph (170) became South Africa's highest scorer on Test debut. He eclipsed Andrew Hudson's 163 scored against the West Indies in 1992.

Earlier, after surviving a stumping chance off the bowling of leg-spinner Mohammad Ashraful, the 21-year-old batsman had to wait until tea before pushing a single to backward point to bring up the magical three figures. Rudolph had then faced 223 balls and hammered 14 boundaries

Dippenaar, the right-hander, completed only his second Test century after the interval with a straight drive for four off leg-spinner Alok Kapali. His ton took 266 balls SEE PAGE 11 COL 6 Rifle looting in Khulna

Ansars were involved in Thursday's ooting of arms from the now-closed interrogation people told police yester-

Khulna Sadar Thana Ansar Commander Sheikh Haroon-or-Rashid was arrested vesterday on an order of Director General of Ansars Major General (retd) Manzurul Alam who arrived in Khulna from Dhaka.

Meanwhile, District Ansar Adjutant Nirmalendu Biswas filed an FIR (first information report) with the Khalishpur Police Station with mention of three ansars as accused along with 35 unidentified others. Shahabuddin-1, Shahabuddin-2 and Kamruzzaman are staffers of the ansar department under the Khulna Ansar Adjutant's Office.

Inspector General of Police (IGP) Shahudul Haq told BBC Radio last night that outlaws looted the arms in connivance with the ansars.

Cargo share row dogs Chittagong port

Conflict over share of cargo between two groups of local ship owners has dogged the Chittagong port.

The two groups are Singaporebased Chittagong Feeder Trade Committee (CFTC) and Bangladesh Ocean Going Ship Owners Association (BOGSOA)

The CFTC is creating pressure on the government to scrap the Bangladesh Flag (Protection) Ordinance,1982 while the BOGSOA is demanding full enforcement of it. Container handling was hampered

at the port from April 5 to 8 as the government made waiver certificate provision of the ordinance.

The situation eased following exemption of five major foreign flag vessel operators from the waiver certificate for 60 per cent cargo due to a High Court stay order.

"We are pressurised by both the groups," said Chittagong Port Authority (CPA) Chairman Commodore Zulfiquer Ali. "We need an immediate solution to the crisis," he

The CFTC claiming itself as foreign flag carriers is led by a local ship owner, Salahuddin Quader Chowdhury, who is chairman of QC Container Limited. Salahuddin is also parliamentary

affairs advisor to the prime minister. Out of 18 vessels under the CFTC

six are owned by QC. On the other hand, 30 per cent share of PIL having four container vessels is owned by Awami League leader Saber Hossain Chowdhury

The other main members of the CFTC are Sea Consortium, APL (NOL) and Orient Express Limited (OEL).

There are 13 container vessels under BOGSOA with nine of those owned by its chairman Sayeed Hossian Chowdhury alone.

The Awami League (AL) plans to hold long overdue councils of its grassroots level units and form their new committees by June before launching a move $ment\,for\,midterm\,parliamentary\,polls.$

Sources in the main opposition party said specific programmes to press home the demand for midterm polls would be announced after forming fresh committees of district and thana units of the party by June 30 at the latest.

The issues came up prominently at last Tuesday's meeting of the AL Central Working Committee (ALCWC) and also at a meeting of the AL Secretariat on

Low standard residential hotels mushrooming

The concept of residential hotels operating on a large scale is a recent phenomenon in our context. This is mainly due to the steady surge in city population. Previously, the city had a limited number of residential hotels which met the demand that was not so

The situation radically changed in recent times with the manifold increase in the number of new arrivals in the city, looking for temporary accommodation during their stay

here for various purposes. That has given impetus to the growth of new residential hotels in the city. According to observers, these new

hotels are run with no fixed principles or standards. Once the owners of these mushrooming establishments start their hotel business with a trade licence issued by the City Corporation, they don't care about taking any further measures for running them according to specific rules of hotel management. On account of utter indifference of the authorities concerned, these establishments are running their business without any control from any quarter. There is even no system for ensuring whether the payment of VAT and other government dues payable by them is duly made.

It is learnt that licences for conducting hotel business are issued by the deputy commissioner's office. Previously, the Parjatan Corporation was the issuing authority of such licences. The deputy commissioner's office, which currently exercises
