# Arms dump blasts kill 40 civilians in Iraq

Up to 40 Iraqi civilians were killed and many badly hurt in a series of explosions near Baghdad yesterday, an Iraqi medic said after an arms dump blew up on the outskirts of the capital.

US troops blamed unidentified attackers who fired four flares into the ammunitions store, sparking explosions that shot missiles as far as three km away. But local people turned their anger on the Americans, shooting and forcing them back from the scene,

Some soldiers were wounded, an Army sergeant-major told Reuters at Zaafaraniya, a mixed residential and industrial suburb on the southern edge of the capital.

"Hostile forces fired four flares into an ammunition storage area. One of the flares ignited an explosion and that set off a chain of explosions," US Army Captain Patrick Sullivan. from an engineering unit

#### In depths of despair

A distraught Iraqi man said 14 of his relatives were killed yesterday when a rocket shot out of an exploding arms dump in the southern outskirts of Baghdad and destroyed their home.

Tamir Kalaal said he survived because he was away from home when the rocket struck, killing his wife, father, brother and 11 other members of his family.

"I am the only one that survived. All I have left is her," Kalaal told Reuters, sobbing and pointing to his one-month-old daugh-

# Unite to uplift HR state in South Asia

Delegates from four South Asian countries including Bangladesh vesterday presented a gloomy picture of human rights situation in their respective countries and urged the people of the region to take a common stand for improving the situation.

On the other hand, former Indian prime minister of India and Chairman of South Asia Human Rights I K Gujral warned the people of the South Asia about the impact of an 'emerging neoimperialism in word politics'.

"The ominous shadow of the post-Iraq war is creeping in our direction and the purpose of neo-imperialism is not confined to acquisition of oil source only but is also to re-establish ears of hegemony," he said.

He urged the people of South Asia to face the emerging threat by standing

The delegates were speaking at an exchange of view meeting at the Supreme Court (SC) Bar Association

"It is time that we too take our destiny in our own hands and assert that no more wars will be fought on the soil of South Asia, and that the sacred soil of our ancient lands will never witness the murder of innocents by the terrorists," Gujral said.

## Criminals drug 3 cops to take away arms

Unknown miscreants took away three firearms and 60 rounds of ammunition from as many police constables on night patrol on Alwal Avenue in the city's Uttara area early Saturday in an apparent drugging case, police said.

They said the gang drugged the soft-drinks of Asaduzzaman, 25. Abdul Baten, 24, and Golam Dostagir, 25, and stole their arms when they fell unconscious in their patrol area at Sector-8 of Uttara Model Town. The police patrol was carrying two

Chinese riffles and a shotgun.

Shopkeepers found the intoxicated policemen in front of a row of shops on the eastern side of Alwal

Avenue at about 6:00am vesterday.

They drew the attention of police sub-inspector Wahab, who was on a morning walk in the area. He guizzed them to establish their identity. Special Branch Sub-Inspector Hamid, who resides nearby, also went to the spot and informed Uttara  $police\,of\,the\,incident.$ 

Uttara police rushed them to Rajarbagh Police Lines, from where they were shifted to Dhaka Medical College Hospital (DMCH) for treatment. They were later taken to the police lines yesterday evening.

### Ten HC judges take oath today

#### Bar Association set to boycott ceremony, hold sit-in

Ten newly appointed additional judges of the High Court Division of the Supreme Court (SC) would take oath today amid boycott of the ceremony by the SC Bar Association and also a sit-in demonstration by its members.

A number of senior lawyers and leaders of the bar met Chief Justice Mainur Reza Chowdhury yesterday.

Later, secretary of the bar Mahbub Ali told journalists that the senior lawyers requested the chief justice to process the files of 11 additional judges whose services were not confirmed by the government.

They also requested the chief justice to suspend the oath-taking ceremony till a final decision on the 11 non-confirmed judges is taken and to

hold a meeting with the full court. Mahbub Ali said the chief justice declined to suspend the oath-taking

ceremony. He (chief justice) said he had already delayed the oath-taking by a day to ensure transparency in this regard and also issued a letter announcing the ceremony.

On the proposal for meeting with the full court, the chief justice told the senior lawyers that such a meeting could not be held in a couple of days, the bar secretary said.

The chief justice however assured that he would do everything possible within the powers given by the Constitution to resolve the crisis, Mahbub added.
