## allegedly by husband

**UNB**, Lalmonirhat A housewife was beaten to death allegedly by her husband at village Bichhnadoi in Hatibandha upazila on Monday night.

The victim was identified as Morjina. Villagers said Suruzzaman, a polygamist, locked in a quarrel with Morjina over dowry and at one stage he beat her to death. An unnatural death (UD) case was filed with the local police station.

The incident occurred when a group of day labourers found a tincan while digging earth on contract basis near an abandoned brick kiln. Suddenly the tin-can burst with a bang when they tried to open it at around 1.30pm.

"The bomb was undoubtedly powerful and it was left abandoned", said Sayed Nazrul Islam, police superintendent (SP) of Natore to this correspondent.

Dr Reaz clarified that those orders were not of promotions, but orders to work at higher posts

The steps were taken following complaints by some employees lodged at the DG office. They complained that former director Dr Fazlur Rahman in collaboration with chief assistant Belal

Hossain initiated the promotion orders of the employees.

## **Outlaws-villagers** clash leaves one dead in Pabna

An activist of an outlawed party was killed and 30 villagers were injured in a clash among outlaws and local people at village Jalalpur in Sadar upazila on April 30.

Among the injured, three were admitted to Pabna General Hospital in critical conditions. Ten others were released after first aid.

The injured were Gomejan Bewa, 22, Hawa Begum, 40, Nurjahan, 40, Bulu Khatun, 50, Majĥar Mandal, 40, Harej Mandal, 32. Matin Mandal, 32, Fajel Mandal, 55, Islam Mandal, 23, Islam Mandal, 25, Jalal Mandal, 25, Abdul Mannan, 50, and Masud, 12.

Police and locals said the extremists attacked the houses of Mohammad Mandal, Shahar Mandal, Siraj Mandal, Akkas Mandal and Yusuf Mandal. They ransacked and looted the houses Police went to the spot and brought the situation under control.

# Road link snapped as bailey bridge collapses on Rajshahi-Naogaon highway

Dilapidated Nawhata Bailey Bridge on the outskirts of Paba upazila here collapsed in the Mahanada River on Wednesday morning closing vehicular movement on Rajshahi-Naogaon highway for several days.

The 25-year-old bridge crushed along with a cement-loaded truck and a passenger bus at around 9.30am while its 100 feet long spans in the middle of the bridge cracked due to overloading, police and

A truck carrying 600 bags of cement weighing about 40 tons was crossing the bridge when it collapsed. At the same time

another passenger bus was also to However, there was no casualty

as there was knee-deep water in the

However, a few passengers were injured. They took first aid treatment at different clinics.

"A baily bridge is normally fit for up to maximum 10 years, but Nawhata bridge, established in 1978, had a capacity to bear a load of 10 tons", Mukhtar Ali Gazi, additional chief engineer (ACE) of Rajshahi divisional Roads and Highways Department informed The Daily Star.

Asked why the bridge was not declared abandoned, Gazi told this correspondent that it was already

abandoned for movement of heavy vehicles. There had been cautionary signboards on both sides of the bridge.

He further said that restoration of the bridge would take at least 15 days as the Roads and Highways Department lacked facilities and necessary equipment. Gazi told newsmen that there was no government grant for repair of the

A source in the R& H Department further informed this correspondent that the govern-ment spent nearly Tk two lakh for maintenance of dilapidated bridges and roads. But no repair or maintenance work was done here
