Two more PWs cross-examined

Two more prosecution witnesses in the baby Naushin murder case were cross-examined in the Second Additional Metropolitan Sessions Judge's Court, Dhaka,

After the cross-examination for about an hour, Judge Hossain Shahid Ahmad adjourned the hearing till May 13.

Metropolitan Magistrate Jagannath Das Khokan, the 11th prosecution witness in the case, told the court that during the "Test of Identification Parade" (TIP) of the accused at the court hajat on May 22 last year, three prosecution witnesses identified accused Moslem alias Muslim Mia and Saiful Islam Ratan.

Marian Islam Naushin, 2, was shot in the head during indiscrimi-

nate firing by a gang of muggers at Uttar Badda in the city on May 9 last year. She was on the lap of her father Nazrul Islam.

Naushin was rushed to a local clinic and then shifted to the Dhaka Medical College Hospital (DMCH) here doctors declared her dead.

Later, a murder case was filed with Badda police station.

The Detective Branch (DB) of police submitted a chargesheet against four people on August 21

Outlaw murdered by rivals in Khulna

An outlaw belonging to 'Jabbar Bahini,' a breakaway group of New Biplobi Communist Party (NBCP), was murdered by his rivals at Shajiarha village in Dumuria upazila at midnight on Wednesday.

According to police, a group of armed cadres of NBCP abducted Abdul Mannan Gazi, 35, from his house at gunpoint. They took Mamun to a nearby primary school and stabbed him. He died on the

The same group swooped on the house of Omar Khaiyam, brother-in-law of Mannan and beat him mercilessly.

He was admitted to the Khulna Medical College Hospital (KMCH).

On May 4, this year, another cadre Ranjan Sarker of 'Jabbar Bahini' was shot and slaughtered by NBCP armed cadres at a fish farm at Bamandia in Dumuria upazila.

BCL strike passes off peacefully

A strike called by the Bangladesh Chhatra League (BCL), the student wing of the opposition Awami League, was held peacefully yesterday at all educational institutions across the country.

During the strike, all classes and university transport remained suspended; the central and science libraries of Dhaka University were closed. The strike also hampered the administrative activities of the Registrar's Office and the hall offices. The university authorities postponed all the scheduled examinations showing 'unavoidable

The BCL called the strike following the police attack on its workers on Tuesday, leaving at least 50 including its President Liakat Sikder and General Secretary Nazrul Islam Babu wounded.

The BCL brought out a procession and held a rally on the Dhaka University campus supporting the strike. Addressing the rally, the leaders said, they would not tolerate further tortures on their activ-

They also urged the student community to start a strong movement against the present government as it has failed to run the country peacefully. The BCL leaders also said the government failed to ensure adequate supply of electricity, gas and water.

The rally was presided over by the BCL DU Unit President Delwar Hossain, and was addressed by President Liakat Sikder.

The students of JCD hall units brought out processions and held rallies at residential halls of DU protesting the strike. The JCD unit of Jahurul Haque Hall termed the BCL's strike illegal adding that they were trying to disturb the congenial educational atmosphere.

Lack of coordination, commitment and proper planning, and corruption are spurring unplanned urban growth, speakers at a roundtable said vesterday.

The Department of Urban and Regional Planning, the Real Estate and Housing Association of Bangladesh (REHAB) and the Prothom Alo organised the roundtable on "Contemporary Urban Development Issues in Bangladesh" at the BUET auditorium in the city.

Academics from the Bangladesh University of Engineering and Technology (BUET), town planners, economists and senior government

officials attended the roundtable, moderated by Motiur Rahman, editor of the Prothom Alo.

Economist Dr Atiur Rahman said there should be more participation of people in the process of urban development and all agencies concerned should be more dynamic and effective.

"Seventy per cent of Dhaka's land is in the hands of 20 per cent people of the city," he noted.

Chairman of Rajdhani Unnayan Kartripakkha(RAJÚK)Iqbal Uddin Ahmed said more than 80 per cent of the buildings in the city have been built without RAJUK approval.

He admitted that there is widespread corruption in RAJUK.

Death in police 'brutality' sparks debate

Dhaka in critical condition. The bus driver and his helper fled the scene, leaving behind the forehead was split and the body bore bruise marks, raised questions about the credibility of the police statement.

Moreover, the victim's family was also allegedly paid Tk 50,000 by the police and were not allowed to talk to the press.

A three-member probe committee chief Arzul Haque told The Daily Star that they had collected doctors' prescriptions and other documents proving that the victim

had died of heart attack. "There is no need of an autopsy as it has been confirmed that he had died of heart attack," said the additional superintendent of police (SP) of the district. He also informed that the probe report would be submitted today.

About the injury marks on the victim's body, Haque said, the split forehead was the result of the victim's falling on a bamboo-fence. Besides, his body had signs of major operations and he had skin disease, he added.
