# Citizens threaten movement as RCC holding tax increased over three times

ANWAR ALI, Rajshahi

Rajshahi City Corporation (RCC) has imposed an additional tax of Tk 2.04 cr on 37,576 holdings in all its 30 wards for the upcoming fiscal.

The city dwellers have reacted sharply over imposition of the additional tax.

The RCC has targeted to realise Tk 2.93 cr holding tax in the coming financial year, which is 3.29 times higher than the existing amount of Tk 89 lakh, according to sources in RCC

Some 2,000 city dwellers have submitted written objections to the enhancement, the sources said.

Different citizens' forums gave an ultimatum for withdrawal of the decision within 15 days and threatened of movement for non-

compliance.

Rajshahi Nagorik Committee
(RNC) and Rajshahi Advocates' Bar
Association in separate press
statements on Wednesday termed

the rise 'inhuman'

Leaders of RNC and the bar in a meeting at the Bar Association Bhaban said RCC failed to provide basic civic amenities to its citizens, and fresh taxes would only multiply people's misery.

RNC advisor and Workers' Party politbureau member Fazle Hossain Badsha, RNC member-secretary Selim Sardar, bar president Advocate Ekramur Rasul, general secretary Advocate Mohammad Yahia, district Awami League General Secretary Tajul Islam Md Faruk, among others, spoke in the meeting.

Meanwhile, many city dwellers have alleged irregularities in the tax

evaluation.

Holding tax for Sonia Banu's three-room tin-shed house on 1,000 square feet land in the city's Darikhorbona area has been fixed at Tk 1,920 against Tk 1,400 earlier.

In contrast the tax for Dr Shamsul Bari's six-room one storied building on 3,000 square feet area in the housing estate was fixed at Tk 7,560 against Tk 1,200.

Awkat Ali of Ramchandrapur area told The Daily Star that the tax for his two storied building was fixed at Tk 19,200 against Tk 5,000

RCC Mayor Mizanur Rahman Minu MP, in a pre-budget meeting with newsmen at his office on Tuesday said no new tax was imposed on the city dwellers. "The ethics we followed during fresh evaluation is to bring equity, as there was no assessment of holdings since 1987", he explained.

Elaborating the mayor's contention, RCC Secretary Abdul Gaffar told this correspondent that the new evaluation was made considering current rental value of holdings.

However, the evaluation is not final, there is still scope for citizens to submit petitions for review, he added.

#### Pirates loot 27 fishing trawlers

# Housewife gangraped in Barisal

#### Two jailed in absentia in N'ganj

The court found Gulzar Hossain and Liton Mia guilty of snatching and handed down the verdict. Three others were acquitted for lack of evidence.
