## Two killed in two days in Pabna

**OUR CORRESPONDENT,** Jhenidah Two people were murdered while the limbs of another victim were severed in Pabna during the past two days.

Abul Kashem alias Tipu, 35, an activist of outlawed Biplabi Communist Party (BCP) was arrested hurt after a gunfight with police at Goalkhali village of Sailkupa upazila, Jhenidah in the earlyhours of Sunday. This takes the death toll in the district within the past 10 days to eight.

One victim has been identified Three policemen were also injured during the fight that lasted over an hour. as Mohammad Raja, 30. He was hacked to death in Alokdia village Cops recovered a Pakistan-made gun and 22-round ammuni-tion from the possession of Kashem. in Dhulauri union under the Sathia Police Station in the early hours of Saturday

Raja's head was severed and dumped in a nearby pond. It was later found floating.

In another incident in South Freekholpara in Shahidullahpur under sadar upazila, Khura Pramanik, 28, was hit on the head with an iron rod. He was rushed to a hospital where the doctors declared him dead.

Police said land dispute with neighbours might have led to the incident.

In yet another incident, miscreants severed the right hand and leg of Abdus Sattar,28, on Sunday morning in Badalpara village in Sadar thana

Sattar is now hospitalised and said to be in critical condition.

Diarrhoea has broken out in Barisal at an alarming rate claiming four lives in the last two days, sources at hospitals and office of the civil surgeon said yesterday. The organisations that won a judgement for Bangladeshi arsenic

Three of the four victims were children who died at the Sher-e-Bangla Medical College Hospital (SBMCH).

Sources said 42 children with diarrhoea were admitted to the SBMCH yesterday raising the num-ber of such children at the hospital to over a hundred.

On Friday, 70 children with diarrhoea were admitted to the hospital.

Twenty-six people were also admitted to the Sadar Hospital yesterday for treatment of diar-rhoea.

The office of the civil surgeon said 32 diarrhoea patients were admitted to different thana health complexes yesterday.

# Gas, power price

factors, not just economic factors. The ministry, under pressure from the donors to increase price, has already started working on a revised formula that is likely to be placed before the council for approval within a few weeks, sources said.

State Minister for Energy Mosharraf Hossain later told journalists that the council had a look at the proposed pricing but made no decision. The ministry would work on it further and come up with a revised pricing formula, he said

"We had prepared a permanent draft policy for pricing of gas, power and fuel," he said adding that there is no such policy in place. State Minister for Power Iqbal Mahmud said there is no reason to be concerned about this pricing issue

The energy ministry earlier PHOTO: STAF formed a gas pricing committee with experts from the Hydrocarbon Unit and Petrobangla that came up

with a six-yearly pricing formula on a 'commercial' basis.

The proposed new price sought to push up domestic gas rate to Tk 169.39 per 1000 cubic feet (cft) or per unit from the present rate of Tk 120. Gas rate for power plants under the Power Development Board (PDB) has been proposed at Tk 88.40 per unit instead of the present Tk 70. Fertiliser factories were to pay Tk 84.41 per unit instead of the present Tk 60.

The proposal however cuts down gas rate for small-scale private power plants to Tk 93 per unit from Tk 100. Price for captive power generation was also to come down to Tk 99.24 per unit from the present Tk 100. Gas price for industries would have been slashed down to Tk 99.24 per unit from the present rate of Tk 140.

Commercial consumers were to pay Tk 177.38 for per unit of gas instead of the present Tk 220 and brick kilns Tk 104.37 against the present rate of Tk 220.
