Spawning in Halda hit by netting of mother fishes

Spawn collection is declining by about 30 per cent annually in the country's lone natural fish breeding centres in Halda river in Raozan and Hathazari due to illegal netting of mother fishes.

Groups of unscrupulous people nets at the entry and exit points of the spawning centres at Sartterghat and Madhuna ghat and catch the mother fishes, sources

Such illegally caught mother fishes like Ruhi, Katal, Mrigel, and Kalaboush weighing 10 to 30 kilograms are seen on sale at fish markets in the port city, they said.

Mother fishes migrate to the spawning centres in Halda river from Karnaphuli, Matamuhuri and Sangu during the Bengali months of Baishakh and Jaishtha (April and

They usually release spawns during full moon, particularly at the first shower of the monsoon, in

the ten kilometre stretch of Halda from Sartterghat in Raozan to Madunaghat in Hathazari.

The mother fishes release pawns in two or three phases. The first phase of spawning this year took place on May 5. Mother fishes vere caught in a massive scale during and after the first spawning, the sources said. These fishes can be easily caught after spawning because they become weak.

Each phase continues for about twelve hours when hundreds of local people in small boats net the spawns (locally called renu) in conventional ways with cloths or

They preserve the spawns in small holes dug in the ground. Fish fries come out of the spawns within four days. The 4-day old fries are sold at Tk. 12000 to 14,000 per kg to fish farmers coming from different parts of the country.

Fish fries worth over Tk 20 crore can be produced if the illegal net-ting of mother fishes can be stopped and survival of the spawns

and fries is ensured, they said.

Substantial quantities of spawns are also destroyed during netting by cloth and conventional nets. Survival rate of the 4-day fries is also bellow 50 per cent, the sources said.

spawns were collected in two phases (on May 5 and May 27) and 598.68 kgs of 4-day old fries were produced from those. When contacted, District Fisheries Officer (DFO) Zafai

Ahmad said he heard about illegal netting of mother fishes and was investigating the matter. Prof Mohammad Ali Azadi, teacher of Zoology department at Chittagong University, said proper collection of spawns, preservation of fries and management of the breeding centres could increase fry

ducting a research on the breeding centres under SUFER (Support for University Fisheries Education and Research) project financed by a UK-based organization, DFID.

He said the Halda is the only river in the world from where spawns are collected for hatching. Halda fries are the best in the country. Fries produced in hatcheries grow 300gms to 500gms in six months while those from Halda grow up to 3kg each, he said.

He regretted that the rates of hatching and survival of fries are very poor due to lack of proper

Main witness 'absconding' in Mirabazaar murder case

Trial of a sensational double murder case in the Speedy Trial Court, Sylhet is being delayed due to non-appearance of the main witness before the court.

Shitol Ranajan Dey alias Shitol is the lone witness who identified the alleged killers of Anwara Begum, wife of businessman Ajab Ali Sheth and domestic help Jubeda Begum in Mirabazaar area of the city. They were killed on February 17, 2001.

The court issued warrant of arrest thrice against him because of his non-appearance before the

Shitol and his family members have been missing from their house since March 4.

Their neighbours said Shitol stayed at his house on the night of

lock and key since the morning of

March 4, they said. The murder case lodged with Kotwali police on March 5.

The Detective Branch (DB) of police submitted charge sheet in the court on June 15, 2002, accusing 10 people.

The charge-sheeted persons are Chamak, Salek, Hannan, Matlib, Kala Miah, Faruque Uddin, Tojoi Miah, Fakhrul Islam, Jainal Ahmed and Sattar Miah. Five of them are in jail hajat, four got bail and the other

accused -- Jainal Ahmedis yet to be nabbed. The court recorded depositions of 41 out of 55 witnesses.

Shitol is the main witness. All the 36 police stations in Sylhet division have been asked to

On April 19 this year, police made a futile attempt to nab him from his village home.

Meanwhile, the complainant, Ajab Ali Sheth, alleged that Shitol's cousin Fanindra Ranjan Dev sent three letters to him through a messenger demanding Tk 40,000 for producing Shitol before court for deposition. He however said Fanindra did this on pressure from the alleged

But Fanindra said the alleged killers forced Shitol to go into hiding or they kept him confined.

The delay in trial of the case was discussed at a May 12 meeting of the divisional committee for monitoring trial of sensational cases with Divisional Commissioner Nazrul Islam in the chair.

Road accidents in north kill 248 in four months

Incidents of road accident are on alarming rise in the northern

According to official sources, 248 persons were killed and 526 others seriously injured in 213 road mishaps in first four months of current year in 16 northern dis-

Local people and relatives of the victims blamed corrupt officials of law enforcing agencies, lack of fitness of vehicles plying on over 200 routes, improper application of existing laws and the 'damn care attitude' of the drives for the acci-

In almost all cases, owners of the damaged vehicles get compensations from insurance companies but relatives of the victims and injured do not get the same as owners do not insure seats of their vehicles though it is mandatory as per law of the land. The concerned

authorities seemed to be quite indifferent towards such major violation of rules for unknown reasons, they alleged.

Traffic police are blamed for collecting tolls from drivers and helpers of unfit vehicles instead of taking legal action against them.

As a result, road mishaps are on the rise in recent years.

According to police sources, a total of 67 persons were killed and 136 others seriously injured from 59 road accidents in January, 62 killed, 167 injured from 47 accidents in February, 57 killed, 73 injured from 50 accidents in March and 62 persons were killed and 150 others seriously injured from 56 road accidents in April here.

Another report from Tangail says: Bus journey in different routes of Tangail has become hazardous due to various reasons, including overloading and deplorable condition of roads

Passengers alleged that they are facing inconveniences due to overloading of passengers, reckless driving and lack of basic amenities.

Most of the buses, running in deplorable condition, are engaged in races to pick up passengers without considering the capacity of vehicles.

Sometimes, passengers are found travelling on the rooftops and even on the foot boards at the risk of their lives. The overloaded buses ply at maximum speed and very often cause road accidents.

Most of the buses, especially the old ones, go out of order on the way causing untold sufferings to passengers particularly to women and children. Passengers further alleged that the conductors very often misbehave with them over

Besides, vehicles that emit black smoke are also plying on roads without restriction.
