A speedy trial tribunal yesterday sentenced two brothers to death and their parents to life imprisonment for killing four members of a family two years ago in Patuakhali.

Judge Abdul Quddus of the Speedy Trial Tribunal, Barisal convicted Forkan Mistri and brother Lokman Mistri (absconding), father Khaleque Mistri and mother Hafija Begum of the murders but cleared Imam Ali, another accused, of the charge.

Khaleque and Hafija were fined Tk 10,000 each and have to serve one year more imprisonment in default to pay the fines.

Revenue (NBR) now mulls that such industries may be given the privilege if they made commercial transactions among associate enterprises at market prices.

"To prevent misuse of tax holiday through internal transfer pricing, I propose to make provision for considering transaction between associate enterprises as a disqualification for tax holiday,"

Job seekers turn to backwaters

Africa and the pacific regions have become new destinations for Bangladeshis to get overseas employment. They are now getting jobs in many far-flung areas in those regions.

The ministry of expatriate welfare and overseas employment sources said, "Several hundred Bangladeshis recently got job in these countries where any one hardly got employment earlier".

The countries are: Tonga of Pacific, Madagascar, Namibia and Botswana.

The sources informed that 35 Bangladeshis got job in Tonga, while 1200 employed in Madagascar on the month of February-March this year. On the other hand, 30 Bangladeshi engineers have been recruited in Botswana and 50 workers in

Namibia

"These countries are showing interest to recruit people from Bangladesh because they need a lot of workers," said, Daliluddin Mondol, secretary in-charge of the expatriate welfare ministry.

He also added, "The expatriate ministry, Bangladesh missions abroad and all other related government agencies are trying their best to increase overseas employment of our people".

When the secretary was asked about the possibility of resuming manpower export to Malaysia and South Korea, two major destinations of Bangladeshi workers, he has given a negative impression.

For last few years, the employment of a large- scale Bangladeshi workers remained suspended in these countries.

Sylhet mayor, 16 others get bail in graft case

The Mayor and 16 newly elected and former ward commissioners of Sylhet City Corporation were granted ad-interim bail for three months in a graft case yesterday.

A division bench of the High Court comprising Justice Goura Gopal Shaha and Justice Abdus Salam Mamun issued the bail order.

The graft case had been filed with the Sylhet Kotwali police station on May 8 by the District Anti-Corruption Bureau accusing mayor Badar Uddin Ahmed Kamran, and 16 present and former ward commissioners of illegally leasing out the third floor of the city's Shibganj kitchen market.

JCD clash stalls DMCH service

Clashes between two factions of the Jatiyatabadi Chhatra Dal (JCD) yesterday sent a wave of panic through Dhaka Medical College Hospital (DMCH) and brought the emergency unit's healthcare ser-

vices to a half-an-hour halt.

The clashes were triggered by another round of clash between the factions of the ruling BNP's student front, which left at least five activists injured on the Dhaka

University campus. The incident led to expulsion of five activists from the JCD.

Among the injured, Moazzam Hossain Liton of the Bangabandhu Sheikh Mujibur Rahman Hall JCD unit, was admitted to the DMCH where a rival gang of 12 went to beat him again. The JCD activists Pilot and Jibon of the Mohsin Hall unit beat up Liton at the DU Central Library, said campus

Kaptai cries for fresh

water

Kaptai Lake, the largest artificial waterbody, is under threat due to pollution and soil erosion of the barren hills surrounding it.

This has driven down fish population especially of the carp variety over the last few years.

There are 73 species of fish in the lake. According to the Bangladesh Fish Development Corporation (BFDC), catch of carp has decreased to 220 tonnes from as high as 972 tonnes in 1964.

Because of the fish stock depletion, the government now plans to ban fishing for a year or two.

"When we ban fishing, the government will support the fishermen for the period," said Moniswapan Dewan, deputy minister for Chittagong Hill Tracts affairs.

But fishermen from Jaulapara in Rangamati fear that the ban would seriously threaten their livelihood. They alleged that the BFDC was supposed to provide them Tk 5,000 in interest-free loan during offseasons, but they did not get the money. The Bangla months of Jaistha, Ashar and Shraban (May, June and July) are considered as off-season.

"We live in utter misery during the three-month off-season. God only knows what would happen if they slap the ban," said Nakul J a l d a s ,
