Write for regional peace, PM tells newsmen

Prime Minister Khaleda Zia yesterday called upon the journalists of the region to build up through their writings a powerful public opinion in South Asia in favour of peace, friendship, humanism and cooper-

"Sharpen your pen against the narrowness, limited vision, conflict and dispute," she told a special plenary session of the two-day Third South Asian Free Media Conference at Sonargaon Hotel in the afternoon.

Editor of The Weekly Holiday Enayetullah Khan presented the keynote paper at the session, also addressed by Editor of News Today Reazuddin Ahmed, Mushahid Hossain of Pakistan, KK Katyal of India, Laxman Gunasekhara of Sri Lanka, outgoing President of SAFMA Gopal Prashad Thapalia and Secretary General of SAFMA

3 brothers mowed down in Hathazari

Another gunned down in Anwara

An armed gang shot three brothers dead at Charia Kazipara area of Mirzapur union under Hathazari upazila in the district yesterday.

Five others were injured in the shootout and two persons were arrested, police said

The dead were identified as Abul Kashem, 50, Abul Bashar, 40, and Badsha Alam, 30. They were all sons of Abdul Khaleque.

The injured are Taher, 30, Junu Meaĥ, 45, Aiyub, 25, Jamal 32, and Nuruzzaman, 30. They are undergoing treatment at Chittagong Medical College Hospital (CMCH), sources said.

According to witnesses, a gang 10 suddenly stormed into the area, got hold of Kashem and shot him. Hearing gunshots the two younger brothers Bashar and Badsha came out from their shop

to be spayed with bullets as well. The miscreants also chopped the victims, witnesses added

Bashar and Basdsha died on the spot while Kashem died on the way to the CMCH.

Five of those who had gone to help the brothers were hit by bullets.

The incident may have been a sequel to the long-standing enmity between Abdul Khaleque and former chairman of Mirzapur union Abul Kalam regarding land dispute.

The three brothers had reportedly helped police arrest an alleged criminal Alamgir, son of Kalam, on April 5 this year, sources said.

Hathazari police has arrested one Abul Hossain Bhola and his son Sekandar in this connection. In yet another incident, a young

man was gunned down at Dutkumar village of Anwara upazilla in the district on Sunday The victim has been identified

as Mohammad Kalu. According to police, an armed

gang of some 15 persons led allegedly by one Habibur Rahman attacked Kalu's residence at around 1:30am. They shot Kalu from point blank range and left the spot.

The victim was rushed to Chittagong Medical College Hospital (CMCH) were the doctors declared him dead.

Stripping Rangamati forests bare

A rising tide of illegal logging is stripping the Rangamati forests of tion slumbers.

Fresh-cut teaks from Reankhyong, Alykhong Forowa, Shukkurchari, Arachari and Karnaphuli forest ranges under Chittagong Forest Department now flood Rajsthali log market in the district, despite a ban on felling of trees is in force.

Wheeler-dealer wood traders in connivance with mammonish forest officials are wiping out the forest, locals say.

Forest guards from the Kaptai Pulp Wood Range, abetted by nouveau riche traders from Chittagong, are engaged in the destruction, they alleged.

Meanwhile, scenes of high heaps of logs by roadsides and

trucks hauling those out of Rangamati town dominated the townscape.

But the army, Bangladesh Rifles, police and other departments concerned seem to be indifferent to illegal cutting of trees, locals

The government imposed a ban on cutting all sorts of trees from the natural forest in 1986. The embargo was later extended till 2005 under the Forest Resources Preservation Plan of 1997 that envisages sustainable forests for

But trees on 5,000 acres of Barkal Reserve Forest and on hundreds of acres in Reankhyong and Alikhyong ranges disappeared in the recent past.

Unauthorised woodcutters also hauled all the teak, Garzan, Mahogany, Gamari trees out of the Kasalong Reserve Forest in a frenzy

of theft over the years, making a mockery of the preservation plan.

The forest department, how-ever, dismissed the charge of its involvement in the theft, saying efforts to save the forest were hobbled by poor manpower and inadequate logistic support.

"We are seriously understaffed and under-equipped," said Salahuddin Ahmed, conservator of forest for Rangamati region. "Our staff strength stands at

1,200 against 2,400 people required to protect the forest in the entire Chittagong Hill Tracts (CHT)

"The loggers are equipped with sophisticated modern weapons and they easily outgun our guards, who carry anachronistic 303 rifles,'

Seven killed as nor'wester lashes Rangpur, Gaibandha

At least five people were killed and some 100 others injured as a severe nor'wester lashed eight upazilas of Rangpur district Sunday night.

Police control room said all five were killed on the spot at about 9:00pm when a big tree collapsed on the roof of a kitchen market at Baluyahat in Pirganj upazila where people had taken shelter to escape the violent storm.

The deceased are Shaju, 30, Abu Bakr, 35, Bimol, 40, Dulal, 35, and a 70-year old unidentified man.

Eyewitnesses said seven injured victims were rescued from inside the damaged structure and admitted to Pirganj Upazila Health Centre while 20 others were rushed to Pirgachha Health Complex.

Govt given four more months to separate judiciary

The Supreme Court yesterday gave the government four more months to implement its 12-point directive to separate the judiciary from the executive.

This is for the 15th occasion that

the Supreme Court awarded time extension to the successive governments since it delivered the directive in 1999. While the attorney general

sought four months' extension, Law Minister Moudud Ahmed recently noted that separation of the judiciary would take at least six to seven years.

Disposing of the government petition for extension of time, the court observed that the govern-

ment has not specifically pointed out in which respect the proposed rules and the bill for amendment to the CrPC (Criminal Procedure Code), if implemented, would cause serious difficulty in implementing the directives.

The court held that the government itself initiated four draft rules and the Bill for amendment to the CrPC. The court only made certain modifications to make them consistent with the directives as the government failed to come up with satisfactory drafts for implementation of the verdict.

India drops precondition for talks with Pakistan

India will not demand a complete halt to cross-border militant strikes before talks can begin on normalising ties with Pakistan, Foreign Minister Yashwant Sinha said in an interview published yesterday.

Britain's Financial Times newspaper said the remarks by Sinha represented a shift in policy. He described a halt to attacks as a precondition of a "successful outcome" to the talks, but not a requirement before talks can

"If this was a precondition

Vajpayee would not have extended the 'hand of friendship' to Pakistan last month," the paper quoted Sinha as saying "But for the dialogue to succeed

it is essential that cross-border terrorism comes to an end.

The two nuclear-armed neighbours came close to war after suspected Pakistan-based militants attacked the Indian parliament in late 2001. But they have announced steps in the past month to ease tensions.

Pakistan Prime Minister Zafarullah Khan Jamali said last

week that Islamabad and Delhi were moving toward the resumption of peace talks. India has demanded a halt to

attacks, but Pakistan says it cannot control all militants that operate across the Line of Control (LOC) that divides the disputed region of

Sinha suggested India could accept that Pakistan may not control all militants, provided Delhi was satisfied that Islamabad was reining in groups it did control,
