# IMF okays \$490m anti-poverty loan

International Monetary Fund (IMF) has approved a \$490 million concessionary loan for Bangladesh to be disbursed under its three-year Poverty Reduction and Growth Facility (PRGF).

The approval was given at the IMF Executive Board meeting held in Washington on Friday to support Bangladesh's economic reform programme for 2003-06.

The first disbursement of about \$70 million will be made immediately, said an IMF release here yesterday

The PRGF loans, meant for low-

income countries implementing their own poverty reduction strategies, carry an annual interest of 0.5 per cent and are repayable over 10 years with a five-and-a-half years grace on the principal amount.

Earlier on June 19, the World Bank (WB) approved "interest-free" loan of \$536 million to support Bangladesh's efforts to reduce poverty and facilitate three reform programmes

Of the total loan, \$300 million has been approved for implementing the first phase of poverty reduction strategy and \$236 million for improving rural roads, telecommunications and for strengthening the

Both approvals came after the WB-IMF board meetings formally endorsed Bangladesh's National Strategy for Economic Growth, Poverty Reduction and Social Development.

The strategy, commonly known as Interim Poverty Reduction Strategy Paper (I-PRSP) was acclaimed in the Bangladesh Development Forum (BDF) in Dhaka on May 17-18.

Sources said the WB and IMF approvals are the outcome of Bangladesh's recent macroeconomic successes and policy statements for poverty reduction

Bangladesh's economic performance strengthened over the last vear due to prudent macroeconomic management and renewal of structural reforms, IMF deputy managing Shigemitsu Sugisaki said after the Board's decision.

"The challenges facing Bangladesh now are to build on this record of policy implementation and to put the economy on a path of higher growth with faster poverty reduction," he said.

The IMF top executive appreciated the I-PRSP as, he pointed out, the document has been prepared through a broad consultative pro

### Rain rules country

# **Justice Hasan likely** to become next CJ

Chief Justice Mainur Reza Chowdhury is retiring today, whipping up a wave of questions about the selection of his successor.

The new chief justice who will take oath on June 23 was still an unsolved riddle yesterday. The invitation cards sent out for the occasion did not even name the incoming judicial chief.

Speculations are rife that the senior most justice of the Appellate Division of the Supreme Court may not be made the chief justice this time and they are fast gaining ground in the judiciary, Supreme Court Bar and of course, in the political arena.

It will be unprecedented if the government puts a judge ahead of two of his superiors in the chair of the chief justice. The constitution

stipulates the president to appoint the chief justice without even consulting the prime minister. This time he might well have to go the govern-

Justice KM Hasan is being tipped to take over from Mainur who retires today, although Justice M Ruhul Amin is next in line in terms of seniority. The government argues that Justice Hasan was the senior most judge in the High Court when M Ruhul Amin and Justice Fazlul Karim superseded him to be appointed to the Appellate Division during the Awami League (AL) government.

There is a notion in the government circle that if the AL government could appoint justices Amin and Karim ahead of Justice Hasan, then it is the coalition's turn to do justice

But constitutional experts say both Justice Amin and Justice Karim were appointed to the Appellate Division, not elevated from the High Court Division. So, Justice Hasan is not senior to both of them in the Appellate Division. Besides, Justice Ruhul Amin stands in for the incumbent chief justice when he is unavailable

One may ask why the government wants to appoint Justice Hasan as the chief justice and throw the appointment into controversy.

The Awami League (AL) took account of the fact that Justice Hasan served General Ziaur Rahman's government as an ambassador and played his part in floating the Bangladesh Nationalist Party (BNP). It also took stock that

### Gang holds guests hostage to rob hosts' house

Holding guests hostage at gunpoint, robbers forced their way into their hosts' apartment and looted about Tk 28 lakh in cash and goods in the city's Tejgaon area yesterday, police and the victims said.

As Riaiul inquired about their identity, they said they were there in the act of evading arrest by police.

Before the couple could move away, one of the gangsters whipped out a pistol, took them hostage and forced them back to the apartment of Ali Azam Khan, father of

As the couple pressed the calling bell, Azam's wife opened the door and the gangsters barged in.

The robbers broke the almirahs and looted about 200 tola of gold, a diamond set. a camera. a mobile phone, cash and other valuables worth about Tk 27,54500

"Hearing two gunshots, I turned around and saw three youths firing at a man on a rickshaw," a vendor who witnessed the killing said. "The man fell on the road and the killers continued firing.'

After firing eight to 10 shots, the youths left the spot.


The ruling BNP is in a dilemma over sending forces to Iraq, as its allies do not want to see Bangladesh troops being placed under American command.

Highly placed sources said the government is planning to send troops to Iraq following discussions between US Secretary of State Colin Powell and government leaders during his June 19 visit.

They said Bangladesh could send troops to Iraq under the Security Council resolution 1483 passed unanimously on May 22, which called on all member states to extend assistance to Iraq. It also discussed about Bangladesh's participation in the process of rebuilding the country
