Toxic fertiliser to be recycled 12 yrs after import

Bangladesh will recycle 2,754 tonnes of toxic fertiliser, the remaining portion of a 1991 import by staterun Bangladesh Agriculture Development Corporation (BADC) state Minister for Agriculture Mirza Fakhrul Islam Alamgir said yester-

Replying to a call attention notice


by BNP lawmaker Md Nurul Islam Moni in the Jatiya Sangsad, he said the BADC imported 6,300 tonnes of zinc oxisulfate fertiliser, of which 3,446 tonnes were marketed before the government found it poisonous.

He said the government would recycle the fertiliser, imported from US firm Stollar Chemical Company with an Asian Development Bank credit, under a contract signed with

Alamgir also told the House that a US court fined the producer of the toxic fertiliser US\$1 billion.

Pharmacy: Part Two

No control over drug price

Planned government changes in drugs policy do not include the imposition of price controls, according to Dr Abdul Gani, Director of Drug Administration.

He told The Daily Star that the department did not have the manpower or expertise to fix prices of the 700 drugs that are not on the essential drugs list.

"The pharmaceutical companies give us an invoice showing the product costing. We just

permit them to produce and sell those drugs. There's nothing we can do if they provide us with fictitious figures," he said.

Companies charge what they think the market will bear. Prices come down only when a manufacturer faces competition.

For instance, Square Pharmaceutical recently reduced the price of one of its drugs from Tk 85 to Tk 50 -- because another SEE PAGE 11 COL 1

Conversely, justices M Ruhul Amin and Mohammad Fazlul Karim were earlier appointed to the Appellate Division, superseding Justice Hasan.

Yesterday was the last workday for outgoing Chief Justice Mainur Reza Chowdhury. President lajuddin Ahmed will administer oath of office to Justice Hasan at the

Bangabhaban at 10:00am today.

But the Supreme Court Bar Association disapproved the appointment and decided to boycott his swearing-in ceremony.

Stung by a string of robberies in recent times, the Dhaka Metropolitan Police (DMP) held a meeting of the deputy commissioners (DCs) from all zones yesterday to hammer out a plan to improve the situation.

The meeting decided that all vehicles including rickshaws will be thoroughly checked from 2:00am till

Huda chaired the meeting. Police patrol teams will be put on 16-hour duty instead of 12-hour, Huda told The Daily Star

It has been found that criminals are using cellular phones for contacts and these phones are mostly procured using false addresses. Police will ask the cellular phone service providers to verify customers' address prior to selling phones.

Robberies have increased in recent times with the police failing to arrest any of the organised gang members.

Police records show 26 robbery and 51 theft cases were filed during the first 20 days of this month.
