Fresh invective adds fuel to JS stand-off

Uncertainty looms large over the prospect of an early solution to the parliamentary stand-off over recurrence of invective against the Leader of the Opposition even after the Chair expunged all unparliamentary words from the proceedings Thursday.

The crisis that the Jatiya Sangsad (JS) faced after State Minister for Housing Alamgir Kabir's alleged aspersion on Awami League President Sheikh Hasina last Wednesday, were defused to some extent following expunction of 'the offensive, indecent, libellous and unparliamentary words' by Deputy Speaker Akhtar Hamid

But the stalemate dropped several notches the following day when the prime minister's Parliamentary Affairs Adviser Salauddin Quader Chowdhury uttered fresh invective against Hasina as well as Bangabandhu Sheikh Muiibur Rahman.

The moment the deputy speaker

showed a good gesture by expunging the derogatory words amid the AL demands for expunction of the state minister's comments and an apology from him, Chowdhury's comments further pushed away the possibility of an early rapprochement with the opposition.

"After the deputy speaker expunged the unparliamentary words, what did we hear from Salauddin Quader Chowdhury in the presence of the prime minister in the House (on Thursday night)? His budget discussion was full of indecent words," Awami League

AL's day-long hartal today

The main opposition Awami League (AL) enforces a countrywide dawnto-dusk hartal today in protest against the 'tax-laden budget proposed for the fiscal 2003-04.

The AL presidium on June 15 decided to enforce the shutdown from 6:00am to 6:00pm, also to protest law-and-order slide.

The party also called an eighthour countrywide hartal on June 12 protesting the law-and-order tumble and lack of security in public life. The general strike coincided with the placing of the budget in parliament.

The Bangladesh Chhatra League, student front of the AL, enforced a half-day hartal on June 19, protesting the killing of its city unit leader Palash, the closedown coinciding with the visit of US Secretary of State Colin Powell. Addressing a press conference

"We've so far detected about 15 such dishonest physicians and

Law enforcers detect 15 dishonest

Owners of the clinics and labs in collusion with brokers and certain amoral physicians, lab technicians and staff of Pangu (orthopaedic) hospital, Suhrawardy Hospital and National Institute of Cardiovascular Diseases (NICVD) compel helpless patients to take treatment outside public hospitals at exorbitant prices.

Though government hospitals are equipped with pathological

facilities, some doctors send patients to get tests done in the labs of their choices. The physicians reportedly get commission, ranging from 40 per cent to 60 per cent of total costs from these

Investigators have already gathered enough evidence against the already bracketed doctors and owners of the clinics and labs. "We are still trying to find out if some others were involved in the nexus,

Landslides kill 8 more in Khagrachhari

Landslides killed eight more people in Khagrachhari, raising the number of dead in the hill district to 24 and the combined death toll in Chittagong and Khagrachhari to 31. police and security sources said vesterday

Five of the victims were killed in Pathachhara of Guimara and three in Palashpur.

A few more people also remained missing in the hill district, which, along with Chittagong, has been battered by landslides and

flash floods since Wednesday.

Ramgarh had worsened with the onrush of water from Feni River in full spate and about 2000 affected people had taken shelter at six relief centres at Khagrachhari.

'Confrontational politics hurdle to erasing poverty'

The law-and-order slide in Bangladesh is bred by confrontational politics and is the biggest hurdle to investment, the key tool in the fight against poverty, Cabinet Secretary Dr Saadat Husain told a roundtable yesterday

"All members of parliament want strict enforcement of law as long as it does not hurt them or their party colleagues. But it is not possible to apply law selectively," said Husain, who was home secretary twice under the present and past govern-

The roundtable, Governance Issues and Political Economy of Reforms, was the last session of a two-day seminar on 'Accelerating Bangladesh' that ended yesterday.




