# Woman unconscious for 3 weeks after operation

Official probe report says operation done by govt doctor 'without prior test' at 'unregistered clinic'

A housewife is unconscious for three weeks after operation by a government doctor at an 'unregistered' clinic in Rajshahi city.

An official probe report revealed that the doctor was not 'specialised' in surgery' in the field and that laboratory test was not done before the

The probe was done by a threemember body led by Rajshahi Civil Surgeon Dr. AK Fazlul Haque following a complaint by the patient's

The probe body was formed on August 12 and its report was sent to the Directorate of Health on August 26 for action, the civil surgeon told

this correspondent on Thursday. This correspondent during a visit to the clinic yesterday found her still unconscious. Shew is on saline only, sources at the clinic said.

Day labourer Mofiz Uddin brought her wife Rashida Begum to Rajshahi on August 7 in the evening men. They came from Sonadanga village under Bagmara upazila.

As in many other cases, they fell in the hands of a 'broker' engaged by a clinic. The broker took them to Nazma Clinic, owned by a former

Rajshahi divisional health director. The clinic authorities told Mofiz Uddin that that his wife had a tumor on her oval and that she would be

operated upon. In the following morning, she was taken to the operation theatre and given anaesthesia for operation.

But she was taken out of the operation theatre (OT) half an hour later as the doctor did not turn up in time, it was gathered.

At around 11 am, she was again taken to the OT and given anaesthe-Sarmin Sultana, medical

officer of Paba Upazila Health and Family Welfare Centre, did the But Rashida did not regain sense.

After three days, Mofiz Uddin complained to the civil surgeon. The probe body did a thorough

In its report the probe body said the patient developed 'celebral hypocria' due to anaesthesia within short interval

The report said the operation was a 'maior' one but laboratory test was not done before the operation.

The operation was done by a doctor "not specialised in surgery" and that the clinic was unregistered

The report suggested shifting of the patient to Rajshahi Medical College Hospital for better treatment but the clinic authorities kept her at the clinic till yesterday.

Talking to this correspondent, the civil surgeon confirmed the findings of the probe body.

When contacted, Riaz Uddin, the director of the clinic, claimed that proper tests were done before the operation, but he could not show any locuments in this regard.

He also failed to give satisfactory reply when asked about the allegation that the clinic was operating without any registration

## Poor jute prices in Nilphamari open floodgate of smuggling

Jute is being smuggled out to India at random due to poor price of jute in various local markets. Lack of jute purchasing centre

and absence of genuine jute trader have attributed to the situation.

People living in the border belt have revealed that many jute purchasing centres had been

established on the other side of the border. Jute purchasers are supplying money through their chan-

nels illegally and doing good profit. At present jute is being sold in different local markets at Tk 190 to 250 per maund (37.5 kilograms) which is much below the production cost.

An elderly farmer of Itakhola village under Sadar upazila, Abul Hossen.65. expressed his utter frustration to The Daily Star as he had sold two maunds of jute at Tk 390 only. He said." our production cost for a maund of jute is Tk 300, but I got Tk 195 for a maund . How can we proceed forward?"

District Jute office sources told this correspondent that the government rate of jute was Tk 345 per maund (37.5 kg) for C-bottom variety, Tk 315 per maund for Cross-Bottom variety and Tk 287 per maund for SMR variety. But farmers got Tk 250 for a maund of C-Bottom. Tk 225-230 for a maund of Cross Bottom and Tk 190-210

for a maund of SMR variety. "It is due to shortage of buyers" told Arindam Kumar Dhar, Chief

## 'Torture' on Khoksa UNO office employee: Investigations on

An allegation of torture on an employee of Khoksa UNO office is being investigated by two probe committees, one formed by the Kushtia district administration and the other by the government employees' association.

UNO's wife, Officer-in-Charge (OC) and Sub-Inspector (SI) of Khoksa police station tortured separately a UNO office employee named Noor Islam Manik on suspicion for theft'committed at the UNO's house.

UNO's wife Nigar Sultana on

August 21 handed over Manik to police on charge of theft. Police tortured Manik indiscriminately, but he denied the charge.

The next day Nigar again took charge of Manik from police and stabbed at his abdomen by knife at her kitchen.

Hearing the victim's scream, OC Badsha Mia and SI Abdul Kader along with UNO Gorges Mia himself rushed there and found Manik in a pool of blood.

announced that Manik stabbed

himself by knife.
