**Ashuganj-Habiganj pipeline project
GTCL-SDJV dispute ends**

Settling a dispute over the Ashuganj-Habiganj pipeline project, the Gas Transmission Company Ltd (GTCL) has agreed to disburse Tk 16 crore to Summit-Daiging Joint Venture (SDJV).

Former chief advisor of the caretaker government and former chief justice Muhammad Habibur Rahman settled the dispute out of the court.

The two organisations were having disagreements over delayed implementation of the 54-km 30-inch Ashuganj-Habiganj gas pipeline.

"The GTCL had refused to disburse the money to the SDJV as liquidated damage from the bill of pipeline project," said a GTCL source.

The GTCL signed an agreement with the SDJV, an associate company of Summit Group, on July 25, 2000 for design, procurement and construction of the pipeline at a cost of 23 million US dollars.

This was the first such contract with a Bangladeshi private sector company - Summit Pipeco - that holds 40 per cent equity of the SDJV.

The project, which was scheduled to be completed within June 30, 2001, was actually completed more than a year later due to various reasons. This led the GTCL to block payment.

But the SDJV claimed that the GTCL was responsible for the delay.

To resolve the matter, the government arranged an out of the court settlement mediated by Muhammad Habibur Rahman.

It was found that as per the contract, the GTCL was obliged to provide the project site and right of way (ROW) within a given time. But the GTCL delayed it by 14 months and handed over the ROW in January 2002.

This pushed the SDJV's job not only behind the schedule but also to interruptions by an early monsoon and hartsals.

The SDJV had applied for extension of time, but the GTCL declined.

Habibur Rahman in his mediation resolved that the SDJV was entitled to extension of time for 180 days for GTCL's delay in handing over the ROW, for 28 days for hartsal and for 153 days for inundation of the site due to flash flood.

He further held that the SDJV was entitled to get back the total sum of the liquidated damage with 8 per cent interest per annum.
