'Outlaws' gun down freedom fighter

OUR CORRESPONDENT, Kushtia A freedom fighter was gunned down in Jhenidah on Tuesday night by alleged outlawed party cadres.

The dead was identified as Fazlur Rahman of Gopinathpur village in the Sadar upazila in Jhenidah district.

Police said, at least eight armed men of outlawed New Bipplobi Communist Party (NBCP) went to Fazlu's house at about 12 pm and called him out.

As Fazlu came out, the miscreants picked him on gunpoint. They took him to a field nearby, slaughtered and shot

Police recovered the body and sent it to Jhenidah Sadar Hospital for

Fisherman kidnapped by Indian pirates for ransom

A fisherman has been kidnapped from Atharobeki canal in the Sundarbans allegedly by Indians pirates for ransom.

Abdus Sattar, 32, of village Kalinchi in Shyamnagar upazila, is now held hostage at Pashintala near the Indian border for Tk 50,000 ransom, police said quoting his ons with whom he had been fishing.

Sattar and two other fishermen were catching fish in the canal Sunday night when some Indian pirates attacked them and kidnapped him. The two others managed to escape.

They told police that the captors sent a message to them for payment of Tk 50,000 ransom for Sattar's release.

Floodwater enters Rajshahi city, C'nawabganj town

One lakh marooned in Kushtia, road links snapped

Flood situation in Rajshahi, Chapainawabganj and Kushtia worsened yesterday as fresh areas were inundated following further rise in the water levels of the Padma

Our Kushtia correspondent reported yesterday that the Roads and Highways Department suspended operation of Pakshi ferry ghat on Tuesday as pontoons on both sides were damaged by floodwaters, snapping road link between southwestern and northern districts.

Low-lying areas of the district have been inundated. The worst affected area is Daulatpur upazila where at least one lakh people are marooned in six unions. The unions are Chilmari, Maricha, Philipnagar, Pragpur, and Adabaria.

The Padma was flowing above its danger level at Herdinge Bridge.

reported from Rajshahi that floodwater entered low lying areas of Rajshahi city and Chapainawabganj town.

In Rajshahi city, flood water is gushing through drains and Bulonpur area is threatened with inundation as the Town Protection Dam (TPD) and the 'I' groven there have developed breaches.

Water Development Board (WDB) is dumping sandbags into the Padma at Bulonpur and Kadamtala areas in the city in a bid to mend the breach in the TPD.

The Padma rose by eight cms in Rajshahi and was flowing at 15 cms above the danger level. It rose by 17 cms at Pankha point in Chapainawabganj and was flowing at 1.42 metres above the danger

The Mahanada rose by nine cms and was flowing 20 cms above the danger level in Chapainawabganj. Floodwater entered Godagari

upazila Sadar and inundated three more unions. The three unions are Char Asharidaha and Mohonpur in Godagari upazila and Monigram in Bagha upazila.

With this, 14 unions in four upazilasGodagari, Paba, Bagha and Charghathave been flooded damaging about 3,000 houses and affecting 5,000 families. Some three kilometers area

Charghat upazila is also facing serious erosion and at least 100 houses here have already been washed away. In Chapainawabganj, the flood has taken a serious turn as floodwater entered the town and

Mohonpur and Char Mohonpur in

the municipality. A total of eight unions of Chapainawabganj Sadar and Shibganj upazilas have been affected

At least 50, 000 people are marooned in Shibgani upazila as about 90 percent of Pankha and Uiirpur unions and 80 percent of Monakosha and Durlovpur unions have gone under water.

Another 1400 families are marooned in Narayanpur union of the Sadar upazila, where crops on 100 hectares of land have gone Outbreak of diarrhoea were

Three get 44 years RI for gangrape in Barisal

Another jailed for 14 years in Netrokona

Three persons have been given 44 years' imprisonment for gangpare in Barisal and another given 14 years for raping a girl in Netrokona.

Our Barisal Correspondent reported that Judge Abdul Quddus Mia of Barisal Divisional Speedy Trial Tribunal sentenced Babul Molla, Kamal and rickshawpuller Maiibor of Amtali in Barguna to 44 years' imprisonment and fined them Tk 1.5 lakh each for gangraping a 14 year-old girl.

They had kidnapped the girl from Amtoli when she was returning home after seeing a puja festival on the night of October 15 last year.

She was confined at the house of one Hamed Munshi at Rawma village in the area and gangraped Kanchan Ali Molla, maternal

grandfather of the victim, lodged a GD with Amtali thana on the night of the incident, which was later turned into a criminal case. Local Union Parishad member

Shah Alam and Chowkider Mokhlesur Rahman rescued the girl from that house on October 17. SI Abul Hossain filed a charge sheet against the three accused on

November 30. The case was transferred to Barisal STT. The verdict was delivered on Monday after examining 12 wit-

nesses in 15 working days. The convicts were given life term and fined one lakh taka each under Section 9/3 of the Women and Children Repression Prevention Act for rape. They were given more 14

years RI and fined Tk 50,000 each under Section 7 of the same Act for abduction. The judge also ordered payment

of 25 per cent of the fine to the victim after recovery Our Netrakona

Correspondent reported that Additional District and Sessions Judge Mohammad Amirul Islam yesterday sentenced one person to 14 years' imprisonment and fined Tk 500 for abducting and raping a minor girl

The convict is Dulal Mia of Satashi village under Durgapur upazila.

The government's Social Welfare Directorate has dissolved the executive committee of a Rajshahi-based NGO for alleged irregularities and involvement in political activities.

The Directorate has also formed three-member comm by its official Zaituna Khatun to run the NGO Association for Community Development (ACD)-- till further decision is taken on it.

The action followed an order from the office of the Director General of the Directorate that detected "gross irregularities and political activities by the NGO authorities' Sources said ACD authorities

allegations of fund embezzlement. anti-constitutional activities and involvement in political activities. Earlier on June 16, the Directorate in a show cause notice asked the NGO authorities to explain

allegations that include showing

destitute children at its Drop-in Center and expansion of its work outside Rajshahi without approval of the Directorate. It was also alleged that ACD Executive Director Salima Sarwar drew Tk 74,350 as monthly payment without approval of its general council.

On June 23, the NGO authorities replied to the showcause notice, denying the allegations. But they failed to show necessary documents, the sources said. The DG's office conducted an

investigation into the NGO activities
