Lending rate cut

Bankers for reducing obligations to stash funds with BB

The commercial banks vesterday suggested the Bangladesh Bank to reduce the size of two key funds -statutory liquidity requirement (SLR) and cash reserve requirement (CRR) -- which the banks are bound to keep with the central bank.

The suggestion was made in the face of pressure from the finance ministry and business community to reduce interest on loans.

At a meeting with Bangladesh Bank Governor Dr Fakhruddin Ahmed, the Bankers Committee comprising chief executives of all commercial banks said they now have to maintain 16 per cent of their total deposit as SLR with the central bank, which reduces their lending

They also pointed out they have to maintain four per cent of their deposit as CRR with the central bank without any interest, meeting

The chief executives suggested interest on the CRR funds to reduce the cost of banks' funds as they borrow the funds from depositors, paving interest.

The bankers also sought reducing the SLR so that banks have more funds to lend.

Presently 49 banks in the country maintain a total of Tk 18,634 crore in SLR and CRR -- Tk 4,120cr in CRR and the rest as SLR. Meeting sources said the gover-

nor insisted the banks reduce interest rate to boost investment and industrialisation.

They quoted the governor as saying that he was ready to accept the idea of downsizing the funds if the banks reduce interest rate.

He called upon the chief executives to improve the money market and the skills in handling repurchase agreement (Repo) and reverse Repo

Talking to The Daily Star, Pubali Bank Managing Director KI Khalid said they made the suggestion regarding SLR to increase the funds for loan.

He suggested 're-discounting facility' under which the banks will have access to funds from Bangladesh Bank at bank rate.

"Such a facility is needed for the third generation banks since they take deposit with high interest due to absence of enough branches,' Khalid said.

According to Bangladesh Bank statistics placed at yesterday's meeting, the commercial banks have a total of Tk 8,072 crore in surplus liquidity.

Asked why the banks sought more funds while a huge amount is lying idle, MA Yusuf Khan, managng director of Premier Bank, said surplus funds vary from bank to bank and they wanted more funds to have a sustainable lending capacity.

BSF killed 32 Bangladeshis

Thirty-two Bangladeshi citizens were killed and 54 others wounded by Border Security Force (BSF) of India and armed Indian criminals in the last nine months, according to a report released yesterday by Odhikar, a human rights organisa-

The report also said the BSF and criminals from across the border also kidnapped 57 people and raped two women including a physically challenged young woman during the period between January 1 and September 30.

Besides, seven people went missing from the border area and 21 others were arrested by the BSF during the same period.

Based on newspaper reports and information from its own sources, the Odhikar report said the Indians also trespassed Bangladesh territory on many occasions, setting fire to houses, looting livestock, and attacking Bangladeshi citizens working near the border or fishing in bordering

Washington's efforts to get allies to share the burden of stabilising Iraq hits new setbacks, as two former Iraqi soldiers and one Marine have been killed in fresh spate of violence.

Unemployed former soldiers in Saddam Hussein's disbanded army clashed with occupying troops in Baghdad and the southern city of Basra yet in violent protests that left at least two Iraqis dead yesterday.

Late on Friday, the US army's 4th Infantry Division came under rocket-propelled grenade and gun attack that killed one and wounded another

The British army said one of its soldiers shot dead an armed Iraqi during an angry demonstration in Basra by hundreds of men who had gathered to collect redundancy payments after being laid off from the Iraqi military.

Major Simon Routledge said a British soldier heard gunfire and then shot and killed an Iraqi holding a weapon. British troops also fired rubber bullets to disperse the

Flora, fauna list being charted

Bid to save endangered species

The government is preparing a list of the flora and fauna to protect the endangered species.

The list, and a national action plan to save biodiversity to be mplemented within June 2004, will also ensure compliance with the Convention of Biological Diversity (CBD) signed in 1992.

The forest and environment ministry has initiated a project titled National Biodiversity Strategy and Action Plan'. The government would identify the problems and take necessary steps to preserve the flora and fauna, the speakers at a workshop of the project said yester-

The conservation policy will ensure people's participation in biodiversity conservation and management through awarenessbuilding and making best use of conventional wisdom.

The project is being implemented by the International Union for Conservation of Nature(IUCN) with logistic support from the Global Environment Facility (GEF).

The speakers at the workshop, held at the BIAM auditorium in the city, expressed their concern as the country's biodiversity is now threat-

At least 13 species of vertebrates have become extinct over the last one hundred years and 64 others are endangered, they told the meeting. As many as 40 species of mammals, 21 species of reptiles, 23 species of fish and 38 species of birds are critically endangered, they

The list, however, does not include the vulnerable plants and insect species. They said immediate steps must be taken to preserve the bio-diversity of the country.

Abdul Mannan Bhuiyan, the minister for LGRD and cooperatives, was the chief guest and Jafrul Islam Chowdhury, the state minister for forest and environment, was the special guest at the workshop. Sabihuddin Ahmed, secretary of the environment ministry, chaired the session and Ainun Nishat, country director of the IUCN, presented the working paper.

Bhuiyan said it is our responsibility as a signatory to the CBD to evolve a national strategy for maintaining biodiversity.

Zafrul Islam Chowdhury said now it is very important to manage the country's biodiversity on a sustainable basis, as we have been ruining it for years.

Tk 1,000cr income tax cases pending with HC

65 cases filed every month, but only one settled

A total of 1,335 income tax cases involving about Tk 1,000 crore have been pending with the High Court (HC) Division, according to a recent report of the National Board of Revenue (NBR).

The cases were filed between 1977 and August this year and only 44 of them involved more than Tk 422.57 crore, the report said.

About 65 income tax cases on average are now filed with the HC every month but less than one case a month is disposed of. Sources attributed this to non-

existence of a separate HC bench and lack of judges with necessary experience to deal with such

Of the pending cases, about 90 per cent are reference cases and the rest are writs.

NBR sources said 485 income tax-related reference cases involving about Tk 350 crore and 30 writs involving about Tk 150 crore were filed with the HC from January to August this year but only seven cases were disposed of during the period

"The High Court is now unable to dispose of even one income tax case a month due to non-existence of a separate bench and lack of judges, who have sound back-

ground with adequate experience

as income tax lawyer," Deputy Attorney General Mosharref Hossain Khan told The Daily Star.

He stressed setting up a separate bench immediately.

The NBR sources said they have long been persuading the Office of the Attorney General (OAG) to take steps to expedite hearing of the pending cases taking into consideration the government revenue earning.

On the other hand, the OAG has sought the law ministry's intervention for establishment of a separate HC bench for this. But no step has so far been taken by the ministry,

the sources said. The HC now has 62 judges and 35 benches -- 27 division benches and eight single benches. There are seven judges in the Supreme Court.

Some of the income tax cases involving big amounts of money concern Bangladesh Rural Advancement Committee (BRAC), Dhaka Wasa, Titas Gas Transmission and Distribution Company Limited, Eastern Bank Limited, Eastern Housing Limited, Chittagong Cement Clinkers and Grinding Company, Opsonin Chemical Industries Limited, Ashraf Textile Mills, Aleya Hossain Cold Storage and Ice Plant, Trade King Enterprise and City Bank
