Medicare is one of the basic needs of humanity. Bangladesh government has been spending millions of takas in the health sector for the common people and for medical education. The government hospitals, health complexes and other small medicare units throughout the country have been serving mostly to poor patients.

A huge amount of taka is being spent to purchase medicine. But it is an open secret that the poor patients in the government hospitals/ heath centres seldom get free medicine, something they are suppose to get regularly. Shahid president Ziaur Rahman declared to set up one essential drug factory in each administrative division to produce medicine and other items required for patients treated in government hospitals, health complexes, etc. So far, it is known that two essential drug factories have been set up in Dhaka and Rajshahi division. Four more factories need to be set up in other divisions. Illegal drainage of medicine and other medicare items from government health care units has to be stopped.

The drugs produced in government's essential drug factories must be supplied in generic names and should be packed in balk quantities, not in a strip of 8 to 12 tablets or capsule or as liquid medicine in 250 ml battles. Rather, those should be packed in 100 tablets or capsules in a plastic container. And, liquid medicines should be packed in 500 ml or 1 ltr. bottles

The nurses in hospitals will feed the medicine according to the dose suggested by doctors. Medical practitioners usually prescribe medicine in trade names. The patients other than from government health care units will receive prescriptions from doctors for medicine bearing trade names. They will purchase those from the chemist shop produced by private medicine producers. The private patients will not agree to purchase government made medicine in loose packets as well as in generic names.

It is estimated that about few thousands of boilers farms and husking mills dot the region where about one lakh labourers are working with least wages merely to ensure survival. Due to the existing laws in this respect not being applied to earn more profits, the owners of

For instance, a boiler explosion occurred in a husking mill at Bochagong of Dinajpur district where ten labourers were killed and one seriously injured. The injured one became crippled for life. On August 9, 2003, a day labourer name Sarwar (45) was killed by an explosion in a boiler at Dupchachia Upo-zila of

Bogra district. On inquiry it was revealed that the safety valve of the boiler was defective but the owner of the boiler did not care for it. The owner of the boilers escaped responsibilities by paying taka twenty one thousand only. It is also known that husking mills and boilers owners are enlisted in food department and they are allotted paddy from the government warehouses for making rice. In order to be enlisted in food department the boilers and

husking mill owners are required to obtain trade license, bank solvency etc. But they are reluctant to obtain the required license. A source in the factory

inspection team said, spot inspection on the technical experience of the workers, arrangements of health care, application of labour laws etc. is made, but, punishment for violating laws is very light or negligible. That is why the proprietors of the husking mills or Chatal (paddy drying yard) do not care for obtaining license..

PDB: spurious meter reading goes on

There are a lot of complaints against the government controlled electric utility agencies (PDB, DESA, DESCO)for several years now. Not only there are illegal connections, but meter readings are tampered with and faked. I had to go to Mohammadpur DESA office last year to sort out the inflated bills. Now spurious readings are creeping in once again .

The minister may review the image of these agencies and enforce a better public relations approach. For example, in my 12 years at a flat, no inspector ever came to ask the tenants if they had any comment on the service.

Visits to the offices are wasteful, as one has to run from table to table. There is no one-stop complaint/enquiry desk run by a senior officer, who can call any official from any section to face the client right in front of the officer.

Good governance means fast service with little wastage of time. There is always a slow follow-up after a complaint is lodged (passing on the buck). I left my telephone number, but received no call.
