# Buriganga hits a new pollution high



Chemical waste from factories in Rayer Bazar, Mohammadpur, is pumped untreated into the Buriganga every day, increasing toxicity of the river's already heavily polluted water.

Pollution in the Buriganga river has picked up an alarming pace in recent years with the dissolved oxygen (DO) level falling below the acceptable level in winter.

The average DO level in the Buriganga dropped to 3.78 milligram (mg) in a litre of water in 2002-03 from 4.43 mg in 2002-02, according to the Department of Environment (DoE).

"Pollution of the river runs low from November to April. At some points such as the main discharge drain of tannery waste, at Chadnighat and Dholaikhal, the DO level slips to zero," said Omar Faruque Khan, director general of the DoE.

"Water becomes so polluted that even bacteria won't survive." "In winter, the DO level ranges between 0 and 0.3 mg in a litre, far below the standards of 5 mg."

"In monsoon, the level of pollution is less as natural cleanliness and dilution keep the river flow normal," Khan said.

Apart from Hazaribagh and Dholaikhal, the average DO level

"The key pollutant choking the Buriganga is sewage. At least 70 percent sewage of the city stream into the river," Khan said.

"The tanneries at Hazaribagh are another major drag on the river. If they are shifted to some other places, the river may get some respite," Khan added.

The government has recently decided to shift 400 tanneries from Hazaribagh to Savar in the next three and a half years. A central treatment plant will treat the tannery waste to pre-

"Industrial waste of the city is also channelled into the river. The waste, laden with heavy metals like lead and chromium, also

contaminates the river," said Khan. An inter-ministerial committee is working to make the river clean and demolish illegal structures on it.

"We will have to raise the navigability of the river. The flow of the river will gather pace if it is free from pollutants," Khan said.

## Pre-paid tax for hosting over 150

The National Board of Revenue (NBR) has introduced a prepaid tax system for hosts treating more than 150 guests in a public place or community centre at a time.

The prepaid value-added tax (VAT) was introduced on Saturday under the Guest Control Order 1984 that had lost much of its effectiveness, and the government failed to earn revenues because of tax dodge.

NBR officials hope the new system in which the hosts have to pay before they throw parties would cut

According to the rule, 150 guests are allowed to be entertained without tax in a marriage ceremony or religious and cultural functions. Functions with 151 to 1,000 guests are subjected to a tax of Tk 20 a person. If the number of guests crosses 1,000, each additional person has to pay Tk 10. Violators are subjected to a fine of twice the actual amount

"Earlier the people were used to pay tax after the function, but now they have to pay before the function if it crosses the number of guests 150," a NBR senior official

The NBR, in a circular last month, handed the responsibility over to VAT and customs officials of enforcing the rule that was earlier implemented by the district commissioner (DC).

"The DC office lost a huge amount of revenues," the official

The law was amended last year while it allowed 100 persons without tax. A function entertaining between 101 and 500 persons were supposed to pay Tk 25 each.

Community centre managers said that at least 250 people attend any marriage or cultural function. Some occasions are attended by more than 1,000 people. They said that the guest control order is totally

Almost every marriage that takes place in the city entertains more than 150 guests without paying tax. In a recent ceremony in Dhanmondi, a rich businessman entertained more than 3,000 guests on the occasion of his son's wedding

without paying tax. Every weekend, lavish weddings are taking place in homes, community centres and big

It is often alleged that although owners of the premises where functions take place collect tax from customers, the state never gets it.

The customer is usually unaware of the expenses and makes a package deal with the owners of the premises. The owners simply do not pay the tax to the state.

Last year, the food ministry reformulated the Guest Control Order 1984 in a bid to stop waste. The authorities described the reformulated rule as time-befitting, pragmatic and people-oriented.

Earlier, the law allowed 100 guests without tax, but the ministry found the law unrealistic because of the small number of guests.

Dhaka City Corporation owns about 35 community centres, while there are nearly 100 centres run by the private sector. The managers of some centres said they are unable to pay tax, which might take away their

### Move for equal airfare for all Hajj pilgrims

A move is underway to equal airfare for both ballotee and non-ballottee Hajj pilgrims

The Parliamentary Committee on Religious Affairs Ministry at a recent meeting discussed the issue and recommended immediate steps to that end.

During the last pilgrimage, airfare for ballottees stood at US\$ 870 while for nonballottees at US\$ 1,050. The civil aviation ministry has raised the

fare for ballotees at US\$ 900 this year, but kept it the same for non-ballotees. Meanwhile, the deadline for money deposit for pilgrimage in 2004 as ballotees

has been extended till November 10 from

The National Hajj Management Committee at its meeting also decided to send a twomember high-level delegation to Saudi Arabia to arrange accommodations for the pilgrims. The final decision on housing arrangements and rent will be taken later. The meeting also decided to arrange

separate rooms for women pilgrims. Ten thousand ballottees and 40,000 nonballottees will perform Hajj in 2004.

Sources said Bangladesh Biman would control the Hajj flights and no local private airlines would be allowed to ferry pilgrims between Bangladesh and Saudi Arabia.

During the last Hajj, Biman carried 25,103 of the 40,000 pilgrims, while Saudia carried

Biman hopes to carry more than 30,000 of about 50,000 pilgrims next year.

The airline now runs  $\sin$  DC-10s and three Airbuses and another Airbus is expected to ioin its fleet in a few days. Biman will reschedule its flights on international routes for smooth operation of Hajj flights. It will run two extra flights from

Chittagong, if need be, sources said. Last year 10 direct flights took off for

Jeddah from the port city.
