leader Nurul Islam murder case begins

Argument in the sensational Laxmipur BNP leader Advocate Nurul Islam murder case began at the Divisional Speedy Trial Tribunal, Chittagong yesterday.

Additional Attorney General Barrister Abdur Rezak Khan, Deputy Attorney General Helaluddin Molla and Public Prosecutor Kamrul Islam Chowdhury Sajjad appeared for the state while Advocate Ahsanul Haq Hena defended the accused.

Barrister Abdur Rezak said all the information and evidences produced during the proceedings were enough to prove the fact that Nurul Islam was murdered in a pre-planned way.

He said a powerful and influential network was involved in the murder of Nurul Islam and he was killed for political reason.

Barrister Rezak pointed out references of 35 sensational cases, including the Bangabandhu Sheikh Mujibur Rahman murder case.

Defence lawyer Ahsanul Haq argued that the murder was a prearranged incident and 'the drama' was staged to help make much-talkedabout 'Sabash Bangladesh'

He said no specific evidences were found against the accused and the First Information Report (FIR) also did not mention the names of any accused, $witnesses \, or \, the \, details \, of \, the \, murder.$

The argument will continue today, court sources said.

A gang of armed criminals picked up BNP leader advocate Nurul Islam from his chamber in Laxmipur on the midnight of September 18, 2000.

Later, his mutilated body was found in the river Meghna.

Laxmipur Bar Association President AKM Tarekuddin Mahmud filed a case with the Laxmipur Sadar Police.

After the investigation, police submitted charge sheet against 31 people on July 30, 2002, and the trial began in the Sessions Judge's Court of Laxmipur.

The case was later transferred to the Sneedy Trial Tribunal, Chittagong on the order from the home ministry on November 21, 2002. And hearing of the prosecution witnesses was completed on November 9 this year.

A total of 13 chargesheeted accused, including prime suspect Laxmipur Awami League leader Abu Taher, were
