Anomalies, corruption rule Nalitabari health complex

Says TIB report

A report of the Transparency International, Bangladesh (TIB) found serious irregularities, corruption and mismanagement at Nalitabari Upazila Health Complex in Sherpur district.

It said the pregnant women have to pay money for treatment while giving birth at the health complex. And general patients become victims of neglect by the doctors as they remain busy with their private practice.

The TIB released the research report at the Nalitabari Nagorik Committee office before the journalists, public representatives, and district and upazila health authorities yesterday, said a press release.

The report said the doctors care

little for the patients unless they pay money. They examine only the well-off patients, ignoring the poor patients.

The staffs of the hospital take

money to test urine though it was supposed to be free of cost, it said. The outdoors of the complex is dirty and full of bad smell.

Patients are also forced to pay for minor operation while there is no

Even it is not difficult to get a fake medical certificate by paying money. It is also alleged that the unscrupulous officials and staffs sell the hospital's medicines. Besides, the supply of medicine to the health complex is not

The report said there are many brokers in and around the health

complex and they persuade the patients to go to the private clinics. A large number of medical representatives also visit the complex regularly.

The research was conducted at the end of last year in the form of group discussion and the researchers posing as patients also collected information.

M A Hakim Hira, president of the Nagorik Committee, presided over the report publication ceremony.

AZM Zohurul Islam, civil surgeon of Sherpur, Nazmul Hassan Khan, upazila nirbahi officer, Habibullah Siddique, health officer, Ekram Hossain, programme officer of TIB, and officials of non-government organisations were present.

'Media enjoys freedom,but not mediamen'

reedom, but the scenario is different for the working journalists of different dailies and electronic media, speakers at a roundtable said here vesterday.

They said the journalists in print and electronic media have little freedom to project what they perceive and experience from incidents as the owner-editors determine the ultimate fate of the stories.

The Bangladesh Federal Union of Journalists (BFUJ) and the Dhaka Union of Journalists (DUI) have nothing to do with the rights of the journalists because of the division within the forums, they said adding that basically business tycoons were holding the control of the entire media and reaping benefit out of it.

The Philosophy Department of

Jahangirnagar University organised the roundtable on 'Philosophy and The media by and large is enjoying Media' at the Jatiya Press Club marking the UNESCO Philosophy Day 2003. The department had a 15-day programme for the occasion.

Eminent columnist and intellectual Farhad Mazhar, Editor of the New Age Enavetullah Khan, Prof. Abdul Matin of Dhaka University, Prof. AFM Obaidur Rahman of Jahangirnagar University, spoke on the occasion. Chairman of the Philosophy Department of Jahangirnagar University Dr. Golam Dastagir presented the keynote paper in the roundtable.

"We see media in Bangladesh is absolutely free, but on the other hand we see a daunting picture that the journalists are not free at all," Dr. Dastagir said in his keynote paper. He also observed that the entire media

was gripped by the influence of party politics and by the tycoons.

Enayetullah Khan echoed the teacher and said the journalism had experienced its glory during mid sixties to mid seventies. But over the years, things have been changed because of the division among journalists and unwanted influence on newspapers.

Khan said the press freedom that has developed over a period of at least 100 years has been destroyed during US invasion in Iraq. The 'embedded' journalists had nothing to offer than writing stories about the success of the occupation forces, he said.

Farhad Mazhar said that the objective journalism was a controversial issue as no report could be objective because of many reasons. The things, a reader should expect from a journalist is that he or she should project the maximum truth.

Case under speedy trial act

Durrani gets bail

A court in Dhaka has granted bail to Shamshul Haque Durrani, editor of the daily Nowroj, accused in a case filed under Law and Order (Disruption) Speedy Trial Act.

Magistrate Nani Gopal Biswas granted the bail on Wednesday upon a bond of Tk

The bail was granted as the accused is an old man and a life member of the

National Press Club, the court said.

Durrani along with his lawyer Syed Shah Alam appeared before the court and prayed for bail. The prosecution opposed the petition for bail.

After hearing both the sides, the court granted the bail petition.

Kamrangirchar police filed the case against Durrani on November 9 on charge of filing a false case against three young men.

Durrani filed the case against Ripon and his friends -- Omar Faruq and Wahid alias Murad -- under the Speedy Trial Act on October 30 accusing them of extorting money from him and vandalising his house at Rasulpur in Kamrangirchar.

But the case proved false, fabricated and concocted during the investigation by Kamrangirchar police who submitted a final report of the case.

The court also issued an order to release Faruq and Murad from the jail.

On October 30, Durrani, his brother Idris, and staff reporter of Nowroj Kamal Chowdhury along with some locals beat up Ripon and handed over his friends -- Faruq and Murad -- to police branding them as extortionists.

Critically injured Ripon was rushed to Dhaka Medical College Hospital (DMCH) where he died on November

The victim's relatives said Durran first beat Ripon's nephew when his bicycle hit Durrani on Kamrangirchar embankment. Hearing the news, Ripon and his two friends went to the spot immediately.

Following an altercation with the three, Durrani called his brother Idris and some others from nearby area and started beating Ripon and his friends

Meanwhile, a division bench of the High Court on November 17 directed Durrani, an accused in the Ripon murder case, to surrender before the District and Sessions Judge's Court,

Dhaka within December 7 when he appeared before it for anticipatory bail. The court also directed police not to arrest or harass him during the period.

Three witnesses -- Murad, Omar Faruk and Tipu -- gave judicial statements to the metropolitan magistrate
