Free legal aid for Bangladeshis in India

BSS, Dhaka

Two non-government organisa-tions of Bangladesh and India have signed a five-year memorandum of understanding (MOU) to provide legal aid for Indian citizens in Bangladesh and Bangladeshi citizens in India free of cost.

Under the agreement, the Bangladeshi NGO will provide legal aid for Indian citizens while the Indian organisation will offer the Justice Naimuddin Ahmed and chairman of LASWEB Justice DK Basu signed the MOU, said a press release. same to Bangladeshi citizens.

The legal aid will also cover, if needed, cheaper travel expenses to the citizens up to crossing the border, subject to necessary gov-ernment permission. C'wealth Heads of Govt Meeting begins Dec 5

FM leaves for Nigeria

Foreign Minister Morshed Khan left for Nigeria yesterday to lead the Bangladesh delegation at the Commonwealth Heads of Government Meeting (CHOGM) in the Nigerian capital of Abuja from

December 5 to 8. Foreign Secretary Shamser Mobin Chowdhury is on the five-

member Bangladesh delegation. The special theme of this year's CHOGM is 'Development and Democracy: Partnership for Peace and Prosperity'

Dhaka will highlight the achievements in building demo-cratic institutions and establishing the rule of law, independence of judiciary and human rights in Bangladesh and share experience with the member states.

The Millennium Development Goals and multilateral trade issues will figure high on the agenda, officials said.

Morshed Khan will also take part in pre-CHOGM meetings, includ-ing the Commonwealth Ministerial Action Group (CMAG) meeting and Ministerial Group on Small States (MGSS) meeting.

The CMAG would discuss, among others, restoration of Common-wealth memberships of several countries, including Pakistan and Zimbabwe.

The Commonwealth summit would deal with the question of reconstruction of the CMAG as well as election of a new secretary gen-eral of the forum. The four-year

Armed robbers looted cash, orna-ments and other valuables from the residence of a lawyer in the city's Chandanpura area under Kotwali thana yesterday.
