PDB employees in 21 dists prepare for agitation

West Zone Power Distribution Company "violates" agreement, Barisal CBA leader says

The simmering discontent among officials and employees of Power Development Board (PDB) in 21 districts under Barisal and Khulna divisions may erupt into a move-ment as the newly formed West Zone Power Distribution Company has "violated" the tripartite agreement, CBA sources here said.

The government in a circular on October 1 this year turned PDB in the 21 districts into the West Zone Power Distribution Company.

The company has offered pay scales, benefits and service rules which violate the agreement it signed with the government and the PDB CBA (Collective Bargaining Agent) on October 4, they said.

Tension is mounting in all PDB compounds since the company put forward its proposals in the first

week of this month, PDB's Barisal CBA Secretary GM Faruk told this correspondent on Saturday.

The CBA has rejected the proproposals to the company authorities, he said.

The CBAs in Barisal and Khulna PDB zonal offices have urged the company not to implementation the new pay scale and service rules, he

"We have sent formal letters to the authorities in Dhaka and are awaiting a reply.

"We will announce a movement programme if the reply is not satis-actory", Faruk said.

The tripartite agreement said there would be no termination, salaries of all employees and workers will increase and post-service henefits given.

Huge public meeting protesting Lalmonirhat AL leader's murder

People from 42 unions in Lalmonirhat district came to Aditmari to join a public meeting on Saturday to protest the murder of popular Union Parishad Chairman Shamsul Islam Suruz, an Awami League leader and freedom fighter.

It was a huge public meeting, held on Giriza Shangkar High School ground in Aditmari.

Suruz, five times chairman of Kalambari Union Parishad, was killed my miscreants on December 21. A pall of gloom descended in the area after his killing.

Former minister and Awami League Presidium member Matia Chowdhury, its central publicity secretary Asaduzzaman Noor MP and organising secretary Sultan Mohammad Mansur were among the politicians who addressed the meeting.

Addressing the meeting chief guest, Matia said this government has to be dislodged to stop political killings. She called upon all opposition forces to unite to build a move-ment to oust the BNP-Jamaat gov-

None can think that a popular public leader like Suruz can be murdered, she said. The incident has stunned the nation.

No headway in probe into Ctg BCL leader Mortuza murder Strike called at CU on Dec 31

There has been no headway in probe into the murder of Ali Mortuza Chowdhury, vice presi-dent of Bangladesh Chhatra League (BCL) at Chittagong University (CU), even in two years after the incident.

The victim's family alleged that the killers are moving freely and threatening them to withdraw the case but police are not arresting Talking to this correspondent,

Mortuza's elder brother Ali Ajgor Chowdhury, Chairman of Journalism Department at Chittagong University, demanded shifting of the case to the Detective Branch (DB) of police from Hathazari thana police.

Relatives and friends will observe Mortuza's second death anniversary today.

Mortuza was gunned down on December 27 in 2001 near his house in Hathazari allegedly by some Islami Chhatra Shibir cadres.

Sources had earlier claimed that as he reached near the house, 10 to 12 Shibir cadres on board two autorickshaws allegedly led by Habib Khan encircled him and shot point blank.

Fatally injured Mortuza run into a saloon for shelter. The assailants caught him and fired in his head and chest and fled away. He died while being taken to Chittagong Medical College Hospital (CMCH).

During the last two years, the responsibility of investigation was shifted four times, but none of the investigation officers (IOs) did anything to probe the matter and arrest the killers.

The fifth IO, Sub-inspector-Aminur Rashid, now says he can not make any headway due to lack of witnesses, police sources said.

Hathazari thana OC Mahfuz Ahmed told this correspondent that lack of witness is delaying chargeframing. "But we are optimistic to end our task within a month", he

The six accused in the case are Didarul Alam Mozumder president of CU unit of Islami Chhatra Shibir, Saiful Islam and Towfiq Hossain.
