Sudden law and order slide in S-W districts

10 killed in 7 days, 2 BRTC buses robbed, 2 abducted

A slide in law and order marked the beginning of the new year in southwestern districts with at least ten people killed in the first week. The victims included three women.

Most of the killings were done allegedly by outlaws, according to police.

Two persons were abducted for ransom and passengers of two BRTC (Bangladesh Road Transport Corporation) buses were robbed during the period in the crime prone

area of the country.

The criminals also made three bomb attacks on law enforcers, apparently thwarting their anti-crime drive.

Some high police officials seeking anonymity admitted the slide in law and order, saying it 'a sudden phenomenon' just ahead of the Eid-ul-Ajah. The situation will improve soon, they hoped.

The first day of the year was marked with two murders, one in

Khulna and the other in Kushtia.
Police said outlaws abducted one
Lipi Khatun, 23, from Kartikpur village
in Daulatpur upazila in Khulna and
slaughtered her after rape.

In Kushtia, one Jahidul, 25, was shot dead at Kazihata village in Bheramara upazila.

On the same day, Jatyia Party Presidoum member Shaikh Akram Hossain came under a bomb attack, allegedly by outlaws. He survived the attack. Passengers of a BRTC bus were robbed 12 miles off Kushtia town on the Kushtia-Bheremara road.

On January 2, outlawed party cadres abducted trader Ripon Hossain, 33, son of Abdus Sattar of Shuvorazpur village in Gangni upazila in Meherpur and demanded Tk 1 lakh ransom. The victim is still untraced, polices id.

On the same day, criminals hacked to death a woman Chaburennasha, 45,-- at Bichali village in Narail Sadar

On January 3, a gang impersonating al Qaida activists exploded four bombs at Poradah Bazar in Mirpur upazila in Kushtia.

One the same day unidentified criminals shot dead housewife Majeda khatun, 30, at KhordoBhaluka village in Kumarkhali upazila in Kushtia over a previous rivalry with her husband.

On January 4 at night, miscreants hurled a bomb at Shiromoni police camp in Khulna. None was injured at it exploded on the sunshed of the building.

On the same day, miscreants belonging to notorious Lalchad

Bahini gunned downed jewelry shop owner Tanim Hossain Ranga, 35, at Juniadah Bazar in Bheramara, while outlaws abducted businessman Yunus Ali from Bhedura village in Alamdanga in Chuadanga for Tk 3 lakhransom. The Ali is still missing.

On the same day, criminals killed a nine year-old boy, Milton, son of Manik Lal Das at Mashni village in Kochua upazila in Bagerhat and slaughtered 60 year-old woman Surjabibi at Ambari village in Narail Sadar upazila and robbed passengers of a BRTC bus on the Khulna-Jessore

A leader of Bangladesh Chhatra League, Zahirul, was killed at Baitpur in Bagerhat on the same day.

On January 5, outlaws slaughtered Kushtia BRB Cable Company employee Rafiqul Islam, 40, at Sawstipur village in Kushtia Sadar upazila and strangled Manjura Khatun, 35, after abduction and rape.

On the same day, enraged people in Kushtia beat an unidentified cadre of outlawed Gono Mukti Fouz when he was fleeing after killing an alleged police informer near the Polytechnic Institute in Kushtia town.

A top cadre of outlawed Purbo Banglar communist Party (PBCP-ML), Selim Ahmed Tutul, was killed on January 5, allegedly by party rivals.

College principal beaten for toll in Patuakhali

Terrorists beat and injured Rehana Akhter, principal of S M Sekandar Ali Chowdhury College at Kalagachhiya in Galachipa upazila in Patuakhali district, Sunday morning as she refused to pay them Tk one lakh toll.

The miscreants also snatched her gold ornaments and ransacked her office

Police arrested two persons -Zia, 40, and Tuhin, 35, --after the principal filed a case with Galachipa thana.

In the case she alleged that a gang of five terrorists led by Shawkat Ali Chowdhury alias Zia entered her office at bout 11 am on Sunday and demanded a toll of Tk one lakh.

As she refused, they beat her with by iron rods, hurled a chair on her and also ransacked her office.

Hearing her screams, teachers, students and employees of the college came and rescue her. The miscreants escaped.

Mentionably, the same gang had earlier demanded toll from the college authorities and are illegally occupying lands and a pond of the college.

'No' to early marriage, dowry

Khulna under security blanket

JMB suicide attack feared ahead of Eid

Khulna city is under a security blanket and police and Rab (Rapid Action Battalion) are on 'high alert' following intelligence reports that JMB suicide bombers may carry out attacks on prime spots or key installations in Khulna city on the eve of Eid-ul-Azha.

Fifteen mobile teams, in addition to 25 parties, will remain vigilant in vulnerable areas and the security blanket will continue till january 13, said DC (Hq) Akbar Ali of Khulna Metropolitan Police (KMP).

KMP Commissioner told this correspondent that a manhunt for JMB men is going on following reports that 17 Islamist militants are in the city in the guise of workers and employees of Shiromoni Cable Factory.

The KMP Commissioner has

issued a circular banning sale of cold drinks at open places on the Eid day. Any body found selling the tiems will be prosecuted under KMP ordinance, the circular said.

Earlier, the Managing Director of the factory in a general diary filed

with Khanjahan Ali thana alleged

that some Islamist militants are

suing the name of the factory to hide their identity.

Inspector of City Special Branch of KMP Golam Mohammod is investigating into the allegation made by the MD of state-owned cable factory.

Rab members are desperately hunting for most wanted JMB 'operations commander' in Khulna division and its Majhis-e-Shura member Hafez Mahmud following intelligence reports that after he is hiding in Khulna along with some suicide bombers. Rab is following different tactics to net

Hafez Mahmud, the sources said.

Hafez Mahmud is now the main target of law enforcers including Rab to finish JMB's chain of command in the southwestern region, sources in intelligence agencies said.

The government has declared a bounty of Tk 10 lakh for his arrest.

"Our operations are going on to finish JMB network in this part of the country", said a senior official of KMP, who is one of those monitoring the drives to arrest Hafez Mahmud.

The drive began after arrested Ziaur Rahman alias Shabbir, 'second-in-command' of JMB in Khulna district, gave 'important information' to Rab on whereabouts of Hafez Mahmud, the sources said.

Police are also raiding students' hostels and messes in Khulna city. There are some 200 hostels and messes in the city.

All student hostels in Khulna city and residential halls of universities and colleges are under watch by intelligence agencies.

August 17 Blasts in Barisal Attachment of property of six accused ordered Sec 144 in Shahzadpur as AL factions

The Special Tribunal has rejected bail prayers of seven of the accused chargesheeted in August 17 bomb blasts in Barisal city and ordered attachment of property of the rest six who are absconding.

Judge Md. Shafiuddin gave the orders when seven of the accused persons were produced before the court on Sunday.

The accused are Ziaur Rahman Zia, Golam Morshed Chowdhury Reza, Jalal Ahmed, Hafez Saiful Islam, Abu Yusuf Majumdar and Abu Solaiman Sujan, all officials of Al Ikram Social Welfare Society; and Md. Maruf, Jasimuddin, Zahid Babu, Sultan Sharif, Rahim, Sobhan and Gias.

They are accused for blasting bombs at 18 spots in Barisal city on August 17 last year.

Of them, Zia, Babu, Yusuf, Sobahan, Rahim and Gias are absconding.
