Earlier on Monday evening, security personnel at Multi Purpose Berthing (MPB) Gate No. 1 recovered 11 replicas of DBBL gun from a truck and a container laden with imported cargo while passing out of Chittagong Port.

Five of the recovered "guns" were tied beneath the chassis of the truck carrying fabrics for a garment company while six others were found in a container carrying telephone accessories of the Dhaka Telephone Company Limited.

The security personnel in presence of CPA officials, customs, repre-sentatives from Dhaka Telephone Company and C&F agent Emess Shipping, and different law enforcement and intelligence agencies started searching the cargo loaded on 10 trucks inside the MPB jetties at 11:00am yesterday.

Engineer Mamunur Rashid of the Dhaka Telephone Company told The Daily Star that they imported telephone accessories and wireless phone sets in 971 boxes from Huyai company in China. With necessary clearance from the customs, the delivery of the cargoes duly started on Monday morning, he said.

"The cargoes were loaded on 30 trucks, 20 of which started for different destinations and 10 were supposed to leave the port by [Monday] night when we were informed of the

embarrassingmatter," he said. The representatives of the importer and the C&F agent con-cerned claimed that they knew nothing about the "gun-like things". The customs and security officials

believed that the attempt to take the replica guns out of the port must have been in the knowledge of the driver and helper of the seized truck.

Truck driver Liton, 34, and helper Kabir, 18, were arrested and are likely to be placed on remand for interrogation, sources said.

Meanwhile, the three-member probe committee headed by CPA Deputy Director (Security) Lieutenant Commander Shahed Karim started investigating the

internal resource mobilisation by the universities, providing Information Communication Technology (ICT) facilities to all higher education and affiliated colleges, establishing a national research council, setting up Research Coordination Cell in ministries, establishing a national research laboratory, supporting PhD and new researchers, setting up three new public universities, and rationalising the students fee structure in the public universities.

The mid term phase from 2014 to 2019 includes setting up Post Graduate University, adopting zero based budgeting, and setting up seven new public universities.

The long-term phase from 2020 to 2025 includes setting up 12 new public universities.

The UGC's 20-year plan for higher education stresses the need for rationalising the different university laws by developing a single legislation for public universities with a view to ensuring accountability of teachers, students and university administrators.

It urges actively discouraging direct involvement of the teachers with national politics for removing present division and polarisation among the university teachers due to partisan politics.

The UGC plan also urges building up a national consensus on discouraging the students' affiliation with the party politics.

It stresses the need for restricting the political meetings, slogans and processions on the university campuses and regular elections of student bodies based on students' representation in faculties.

The strategic plan also seeks to increase tuition fees, boarding and meal fees for the residential students of the universities in line with the present context.

The plan suggests accepting the international donor agencies for project based funding for further development of higher education in consideration of the government's fund constraint.

"We are very much optimistic that the 20-year strategic plan will bring about a significant change in the country's higher education," UGC Chairman Prof M Asaduzzaman said.

He said the strategic plan is very suitable for the time and logical in

the present context of the country's higher education that is plagued with problems and constraints such as poor funding, weak management, and involvement of the teachers and students with the state politics.

Terming the UGC plan's proposal to increase tuition and other fees for the university students as 'very logical', he said, "How do the universities claim themselves as autonomous bodies while they are almost completely dependent on the government funds?"

The universities should be real autonomous bodies by generating their own funds, he added.

The UGC has prepared the 20year strategy plan for higher education in six months in consultation with teachers, students, guardians, and people from different professional groups across the country, the UGC chairman mentioned.
