I spent the Eid holidays in a village far away from a town or city. It was a delightful interlude away from the noise and pollution of Dhaka. The major activities were gossiping, walking, taking rides in cycle vans, taking fresh tasty food and rest and relax!

Unfortunately, the village environment was not as simple as expected. The tentacles of militancy seemed to be creeping in. Voluntary madrassahs are a common part of the village society. A new quomi madrassah was being set up hardly hundred meters from the house where I spent the vacation and it was altogether a different cup of tea! Within six months they got land; built the main single storied dormitory with toilet, washrooms and tube-well. Sixty plus students lived there and it was already functioning! More structures like office and other facilities were being put up; all under the auspices of invisible kind hearted donors! The land was supposed to be a donation, and registered as such; the owner (a needy villager) who donated the land was however given more than the fair price of the land; of course off the record. To expedite the construction, earth for filling, constructing the semi pacca structure all was done at speed with for the unaware like us. On enquiry it transpired that Arabic and Urdu (!) were the main subjects taught! On being pressed, they agreed that Bengali, English and Mathematics were also a part of the curriculum; although no syllabus or books on the subject were seen, or could be produced!

However the ladies of the visiting families were cajoled and impressed by the young welltutored children during house calls, to donate the skins of the sacrificial animals as also some cash for the welfare and education of the needy orphans! Some of us lightened our purse with cash or promises for supporting the needy orphans. I was the sole skinflint among the lot, as the whole edifice appeared questionable to me, and the purpose of the institution apart from producing semi-skilled Arabic and Urdu students appeared a pointless exercise. In contrast the ramshackle state of the nearby high school without such magnanimous and anonymous donors was something to be pitied! I gave my pledged annual donation to the school providing support for a number of needy students of different classes to help their educational effort. However finance-wise, and organisation-wise the High School was no match for the fast developing quomi madrassah with an open purse string!

I would like to share my three decades experience as a General Physician and Dermatologist in a community based Hospital as to the quality of

population of our country. A healthy person is an asset to the nation. The reverse is a burden. In our country we have more burdens than assets. A human being needs proper nutrition, proteins, carbohydrate, vitamins, minerals etc in the mother's womb for healthy development. The mother requires all the above-mentioned elements to give birth to a healthy baby. But what do we see in practice? Most of the mothers give birth to sick, ill-nourished babies due to poverty who become a burden to the family and the nation. The parents cannot afford proper nutrition to the babies in the intrauterine and also first five years of life.

In our practice as Dermatologist we encounter thousands of people with defective growth and development. Skin is an organ, which can be perceived and estimated from outside unlike liver, kidneys, heart, lungs, brain etc. Skin is an excellent indicator of a person's nutrition and development.

Lower and lower middle class people are more likely to contain mal-developed skin than the others. Their skin is either dry or coarse or too thin or 'broken'. A normal skin is shiny, soft, glossy and elastic. In the upper income group we hardly find problems like Dermatitis, which springs from defective development of skin. I feel sorry for those patients and also for our unfortunate country, which is overburdened with a huge population.

What use of those persons in the society and to the country with defective organs, mental dementia etc? They are mostly born in the under-nourished lower income group who constitute majority of our population. It's a vicious cycle. Poverty breeds more poverty. And the population keeps on increasing who are defective with very low productivity or usefulness. They are a total burden.

So, family planning or population control has to be enforced rigidly at this level. There is no scope for complacency or excuse. A mechanism has to be evolved to force the lower and lower middle class to undertake or accept the 'one child' family concept or else we are bound to be doomed as a nation.

> A blanket of fog disrupted road and river communications severely since January 9 playing havoc on thousands of people going to their villages to celebrate Eid-ul-Azha. A shivering cold wave, first in this winter, also paralysed normal life all over the country, particularly in the northern and southwest regions. The weather forecast came true and it continued to deteriorate further.

As reported from Manikganj on 10 January there was an eight kilometre long traffic congestion at both Doulatdia and Paturia ferry terminals as the movement of ferries remained suspended for the whole night due to dense fog on Sunday and Monday night.

The disruption caused untold sufferings to thousands of homebound people from 15 districts of the southwestern region. Five ferries loaded with 18 passenger buses were stranded for the whole night in the middle of the river Padma. To avoid the disrupted ferry services on Doulatdia-Paturia route, most bus operators changed their route and started moving towards Jamuna Bridge to reach the southwestern districts via Paksey in Pabna, which takes a long time.

Post-Sharon Israel

Prime Minister Ariel Sharon of Israel is still in a departure. critical state after suffering a massive stroke. Mr. Sharon will not return to normal life even if he survives. This has serious ramifications for the Middle East and the world. Sharon had completely changed the political scene of Israel by breaking away from the hard line Likud Party that he had founded to recently form a new party-- Kadima. That leaves the Israeli politics in a state of flux. Mr. Bush, who was a big supporter of Sharon, must be worried about the uncertainty his removal from the Mid East scene creates. Palestinian President Abbas has lost control not only of Palestinian government but also of his own group Fatah. The militant wing of Fatah, The Al-Aqsa Martyrs Brigade, is in open rebellion, while the militant Islamic group Hamas is trying to tone down its militancy and is gaining ascendancy.

When Sharon vacated Gaza it was not because he had a change of heart and became a dove. He believed that unilaterally separating from Palestinians after permanently annexing vast areas of West Bank and Golan Heights was the only way of guaranteeing Israel's existence as a Jewish state. This stand would never have led to permanent solution. Sharon's removal from the political scene helps the peace process in the long run.

In the imminent future we might see an interim leader such as Ehud Olmert or Amir Peretz of Labour or even Benjamin Netanyahu coming to power at the head of a coalition government. But soon we might see that, instead of hardliner Nethanyahu who is considered an opportunist, or the inexperienced Peretz, former prime minister Ehud Barak may gain ascendancy. Peretz has been trying to sideline Barak in the party, but only a trusted general who is interested in genuine compromise can fill the void created by Sharon's

Barak may not insist on annexation of large areas of the West Bank and may resume negotiations with Syria. Syria itself may see a more representative if not a democratic government. The winds of democracy are sure to gust stronger in the other Arab countries. The corrupt old guard of the Fatah is on the way out and the Al-Aqsa Martyrs Brigade and Hamas will have to undergo a moderation metamorphosis a la the PLO into becoming political parties acceptable to the pragmatist leadership in srael and the US. After the next presidential elections neo-conservatives, who are the biggest supporters of hardline policies of Likud are likely to lose their clout in the US.

Israel and Palestine started their modern history of coexistence from hardline positions. For 2000 ears, the Jews had suffered the worst persecution at the hands of the Europeans and always dreamt of returning to the land that they believe God gave them for exclusive use. Around the 1890s, when the Zionist movement was founded, the European Jews became powerful enough to influence the imperial and colonial powers in Europe. But they never trusted the European powers and they were proved right when they were almost wiped off the face of Europe by Hitler. The matter of restarting their saga in Palestine was no longer a matter of dream for them but became a necessity for survival

But in their religious zeal and struggle for survival, they did not realise that Palestinians, some of whom claimed ancestry to the people of Canaan, whose presence predates the arrival of the Hebrews in Palestine, would see them as colonisers, especially as the Jewish immigrants and militants had the support of the colonial occupiers. Many Zionists, not only wished that the Palestinians would just disappear; they forced the Palestinians out through

terrorism, expulsions, massacres and wars. For a take its course. Just like war and violence was a hundred years, the Zionist movement and the Israeli government denied the very existence of Palestinian people. Millions of Palestinians still live in camps dreaming of one day returning to their

Israelis and Palestinians now must do what they have done through the last century: that is let history
