50 hurt as employees attack RU teachers

Controversially appointed staff want their confirmation before fresh recruitment

Some 50 persons, including teachers, officials and police, were injured at Rajshahi University (RU) yesterday as the "controversial" 546 employees launched sporadic attacks on them and the vice chancellor's office to stop teachers' recruitment without confirming

The attackers led by 546-Employees' Oikya Parishad conve-nor Rafiqul Islam Sadar ransacked the offices of the vice chancellor (VC), pro-VC and Planning and Development section.

14kg explosives, jihadi books found in Bogra

The Rapid Action Battalion yesterday seized 14kg explosives, huge bomb-making materials, and over 2,000 books on jihad kept underground near the house of a Jama'atul Mujahideen Bangladesh (JMB) operative's relative in Shahjahanpur under the district.

At least 1,000 bombs could be made with the seized explosives and equipment, Rab said

72 including 12 journos hurt as cops swoop on opposition march

Hartal today

At least 20 Awami League (AL) activists and 12 journalists were injured yesterday as police swooped on an AL procession supporting today's dawn-to-dusk hartal called by the 14-party opposition alliance.

Forty others were injured in separate clashes between the police and opposition activists.

Police attacked an AL procession with batons and lobbed at least 50 teargas shells when the procession tried to break through a police barricade enclosing the AL central office on Bangabandhu Avenue around 4:30pm.

The 14-party opposition alliance, comprising the AL, 11-party alliance, Jatiya Samajtantrik Dal (JSD) and National Awami Party, will observe the countrywide hartal demanding Chief Election Commissioner (CEC) MA Aziz's immediate resignation and cancellation of two new election commissioners' appointments.

The clash erupted when AL activists started to hurl bricks at the police, refused to open the barricades letting the procession out of Bangabandhu Avenue.

The police charged batons and chased the AL activists into the central office. They clubbed them indiscriminately. AL activists pelted bricks and stones in return from inside their office and from the rooftops. The agitated AL activists burnt tyres in front of their office after the

IMF, WB start terror financing talks today

International Monetary Fund (IMF) and World Bank (WB) start today a series of discussions with Bangladesh to provide it technical assistance in preventing money laundering and terrorist financ-

A five-member visiting team of the Bretton Woods institutions will discuss the issues with the Bangladesh Bank (BB), commercial banks, and Attorney General's Office. The meetings are expected to go on till February 1.

Comprised of Maud Bokkerink, Marlene Manuel, Cheong-Ann Png and Maureen Sanders of IMF and Mark Butler of WB, the team will discuss with the BB a wide range of issues including the draft money laundering act.

The act titled anti-money laundering and terrorist financing act, 2005 however has returned from the cabinet recently and is likely to undergo a number of amendments aiming to curb the authority of the central bank, sources said.

The activities of Financial

tions and the situation regarding Transaction Reports and Cash Transaction Report of the commercial banks among others will also come up for discussion.

The team is expected to sit down with the representatives of nationalised commercial banks, private banks, foreign banks, money changing institutions, and post office as well to discuss the antimoney laundering and terrorist financing issues.

4 carjackers killed in 'shootout' with cops

Four carjackers were killed in a 'shootout' with police at Durgapur on the outskirts of the district town early yesterday.

They were identified as Jahangir Alam alias Zakir, 30, son of Joynal Abedin of Chandpur, Alamgir Hossain Kalam, son of Abdul Karim of Narayanganj, Suja Mia, son of Chan Mia, and Ershad, son of Moslem Mia, of Sherpur.

Police said they arrested two of the gang from Comilla on Thursday night with a hijacked microbus.
