# JMB planned a 'major' bomb attack in Gaibandha

## Arrested 'regional leader' Reaz tells police

REZAUL HOQ, Gaibandha

Arrested JMB 'regional commander' and suicide squad member Reaz confessed to police yesterday that the Isamist militant outfit had a plan for a 'major' bomb attack in Gaibandha.

He told police during interrogation that he and five others came to Gaibandha, for a 'major bomb attack' like the August 17 serial blasts, police sources said.

Ziaur Rahman Badar alias Reaz Ahmed, 22, JMB 'regional commander' for Gaibandha and Joypurhat, was arrested by Rab (Rapid Action Battalion) during a raid on Ayub Ali Ansari Jame Mosque in front of Gaibandha circuit house in the early hours of Monday. A Rab team from Bogra made the raid, acting on a tip-off.

Reaz further told police that they (including three militants from Lalmonirhat and Kamal of Shaghata) were involved in the serial bomb blasts in Gaibandha on August 17. They were planning a second major bomb attack'.

They were in a discussion on their planned attack when Rab personnel raided the mosque and arrested him. The other militants including Kamal managed to flee.

Police suspect that other members of JMB suicide squad are also carrying bombs for heir planned attacks in the district. Police are now on high alert and hunting for the militants who escaped from the

Shaghata upazila in Gaibandha was a den of JMB activities. Locals said that two years ago, JMB and JMJB (Jagrata Muslim Janata Bangladesh) held regular meetings

and arranged training sessions for its activists in different mosques and madrasas. The two banned Islamist militant outfits recruited a large number of youths, mostly from poor families, from different areas in the district, earlier reports

They fled away from the dens after the government launched a crackdown on them, but are regrouping again, police sources

Meanwhile a court here dropped the names of alleged JMB activists from the August 17 serial bomb blast case in Gaibandha. They are Bangla Bhai's matchmaker Abdul Jalil of Akanderpara Nooh Hakkani of Kholahati in

Suspecting that the pirates might be hiding in the Indian portion of the Sundarbans, BDR at a flag meeting held on Saturday at the Zero Point on Kalindi river sought BSF help to recover the arms and arrest the pirates. BDR has proposed a joint drive with BSF in the Sundarbans, sources

BDR Subedar Abdul Khaleq led the BDR team at the meeting.

# 10 doctors against 33 posts, 5 available

SOHRAB HOSSAIN, Patuakhali

Treatment of patients is being greatly hampered at Patuakhali General Hospital due to shortage of doctors and other facilities. The government hospital that is

supposed to meet the needs of about 16 lakh people has 33 sanctions posts of doctors, but only 10 are posted now. Of them hardly five are available at the hospital, patients alleged while talking to this Correspondent during a visit there on Sunday.

Besides, beds and supply of medicine are two inadequate to the needs of patients.

Three hundred to 400 patients come to the hospital from different areas of the district daily, hospital sources said.

But about half of them return home disappointed without getting any treatment, it was gathered from patients and other sources at the hospital.

Between 11 am to 1 pm, this correspondent counted about 200 patients including women and children waiting at the outdoor, where only three doctors were seen. A total of 210 patients were given tickets on the day for treatment, but only 130 had the opportunity to meet doctor.

Luki Begum of Khalisakhali village said she came to the hospital for treatment of her sick four vearold son Khokon, but could not The court was supposed to | meet a doctor till 1 pm.

Sonali of Gazipur village earlier came on Saturday with his twoyear child Suman, suffering from fever. She returned failing to see a doctor and came again on Sunday, she said.
