# Meandering tragedy

#### 1 million rendered homeless over 3 decades as the mighty Brahmaputra-Jamuna widens

Around one million people have been rendered homeless due to river erosion in the country over the last three decades as the mighty Brahmaputra-Jamuna continues to widen due to decrease in its depth for heavy rush of sediments from the upstream and poor erosion management in the downstream.

Official statistics show that the Brahmaputra-Jamuna, a major river system in Bangladesh, has widened to 11.8 km now from 8.3 km in the early 70s, eroding about 87,790 hectares of land.


The Centre for Environmental and Geographic Information Services (CEGIS), an independent analysis wing of the water resources ministry, in a recent study said the widening process of the Brahmaputra-Jamuna still continues owing to long-term effects of the 1950 Assam (India) earthquake of 8.6 magnitude on the Richter scale.

Experts said nearly 800 square kilometres of valuable floodplains have been lost due to erosion along the Brahmaputra-Jamuna's total length of 240 km in Bangladesh.

Around 10 lakh people have become homeless and infrastructures destroyed due to riverbank erosion in the Brahmaputra-Jamuna," said Knut Oberhagemann, team leader of the Jamuna-Meghna River Erosion Mitigation Project (JMREMP), while taking to The Daily

The rate of erosion becomes high and the flow of water strongly hits the river banks when huge quantities of sediment are mixed with water, experts noted.

'Assam earthquake delivered approximately



Brahmaputra-Jamuna river and its tributaries in the Assam valley, raising the riverbed by three metres," said CEGIS Morphologist Maminul Haque Sarker. He conducted a research titled Prediction for Bank Erosion and Morphological Changes of the Jamuna and Padma Rivers 2005'.

Around 60 to 70-square km land is being devoured by the Brahmaputra- Jamuna, leaving 60,000 to 75,000 people landless every year, said a research report of Water Resources Engineering department of Bangladesh University of Engineering and Technology

"Depth of the Brahmaputra-Jamuna continues to decrease and its width increases. At present, from 100 to 500 metres of land is being eroded from both banks of the river due to lack of river training," said Professor M Monowar Hossain, who conducted the research identifying three causes of expanding width of the Brahmaputra-Jamuna.

Hundreds of small shoals have emerged changing the course of the river as it carries a huge quantity of sediment from the upstream, Monowar told The Daily Star.

"The mighty Brahmaputra deposits large quantities of fertile alluvial soil as it flows for 1,800 miles (2,900 km) from its source in the Himalayas. Sand, stone, mud and varieties of trees merge with water as the river passes through Tibet in China and Arunachal and Assam states of India," he said.

The river also gets widened as it has less slope and carries most of the sediment at bottom level

The cabinet yesterday approved Bangladesh Telecommunications (Amendment) Act 2006, providing for control on the use of mobile phone as a measure to break crime

A meeting of the cabinet held in the conference room of the Prime Minister's Office with Prime Minister Khaleda Zia in the chair, gave the approval for amending the law with the phone-control provision.

In the wake of violent crimes

across the country, particularly serial bombings by Islamist militants, the government has taken the move to check such syndicated

The president recently promulgated an ordinance with a provision for tapping phones to check "the misuse of mobile phone for committing criminal act".

## Bid to dismantle running plant to set up new ones

Govt bows to donor pressure to get funds

Under pressure from the Asian Development Bank (ADB), the cash-strapped government is set to dismantle a functional 50 megawatt power plant to install in its place two 120 megawatt 'peaking' power units at Siddhirganj power projectsite.

The government's power experts had initially resisted this move on the ground that the 88.5acre project site has adequate free space for setting up several new powerunits

But such arguments have been brushed aside and the government has floated a tender for dismantling the existing plant and install new ones there, sources said.

"This is because the government has no option but to accept the ADB conditions to get funds for the new project," explained a power ministry source.

The ADB will provide \$77 million loan for this project. It justifies its conditions arguing that the 50 MW plant is 35 years old, which needs to be discarded very soon. By dismantling the plant and selling out its old equipment, the total project cost for the new plants can

be reduced by several million

But according to the Power Development Board (PDB) and the newly formed Electric Generation Company Ltd (EGCB), the old plant still generates 30 MW power. Considering the level of load shedding in the country, it will be unwise to dismantle the plant right away. The new plant will take two years to install even if all factors are

The EGCB, formed according to an ADB condition to unbundle the country's state-controlled power generation system, is currently evaluating two bids for this new

Chinese company Harbin and Indian Bhel in their bids have offered to dismantle and procure the old plant, and install the new units. The two bidders have offered prices ranging between \$90 million and \$110 million. "But we cannot exactly pinpoint the price right away as there are many aspects of their bids that are being evaluated by our consultant," said an EGCB

agreement in April. By that time we should be able to pick and sign agreement with our lowest bidder. It will take another 17 months to install the plant," said another EGCB official.

He is likely to get posting after the ceremonial march past of police training completion scheduled to be held on February 22.


