
Poor visibility due to a sudden fog disrupted ferry movement from 6:00am to 10:00am at Maowa ferry ghat yesterday.

Three people died on the spot and five were injured when a Bograbound coal-laden truck coming from Chittagong skidded off the road and fell into a ditch as the driver lost control over the steering at 7.30am at the western side of the Nalka bridge on Dhaka-Bogra

highway. One of the dead has identified as Akkas Ali, 45, son of Goher Ali of Chandail village in Dupchachia upazila of Bogra district. Two others' identities could not be known immediately. The injured were

RIYADH ROAD ACCIDENT

Identities of 11 Bangladeshi victims confirmed

Bangladesh Embassy in Saudi Arabia has confirmed identities of 11 Bandladeshi construction workers killed in a road accident in Riyadh on

Atotal of 15 Bangladeshis died in the tragic incident, according to the Bangladesh Mission in Riyadh.

The embassy in a press release yesterday said it is trying to get the details of four others from Saudi police authority.

The detail identities of eleven deceased are given below:

Nur Uddin, son of Lalu Miah of Dolargaon village in Sylhet, Ahmed, son of Salauddin of Bawsia village in Munshiganj, Manzurul Huq, son of Mozammel Hug of Uttam Hazirhat in Rangpur, Habibur Rahman, son of Kamiz Uddin Howlader of Doaser village in Madaripur and Moznu Mollah, son of Chanda Mollah of Gendu Mollarhat village in Faridpur, Jamal Ahmed, son of Rafiqul Huq of Boro Kafon village in Sylhet, Tawhidul Islam, son of Abdur Rahman Mandal of Mirza Nagar village in Kushtia, Abdur Rob, son of Sheikh Ali Matbar of Bhangidangi village in Faridpur, Shelon Biswas, son of late Fafor Biswas of Shaheb Nagar village in Faridpur, Zamir Uddin, son of Rezwan Karim of Umirgaon in Sylhet and Sheikh Uddin, son of Adar Ali of Dolargaon village in Sylhet.

The tragic accident left 15 Bangladeshis killed and 14 others injured near Riyadh in Saudi Arabia. Of the injured 11 people were admitted to Al Iman Hospital in Riyadh while three were released from the hospital after first aid.

They were travelling by a bus in the morning to join their work.

The driver was also a Bangladeshi.

BEATING ROOMATE JU JCD female activist ordered to leave dorm

The authorities of Jahangirnagar University (JU) ordered a female activist of Jatiyatabadi Chhatra Dal (JCD) and resident of Nawab Fazilatunnesa (NF) hall to immediately leave the dormitory for beating her roommate.

The order was issued on Shamsun Nahar (Rekha), a student of the Department of History and general secretary of JCD NF hall unit, on Sunday after the probe body recommended for her punishment as the body found the allegations against her true.

Rekha beat up his roommate Gouri Basak, a student of the Department of Pharmacy, in presence of her (Gouri) mother about a week ago and threatened to oust her from the campus.

The authorities also find her Tk 50 for the incident as per the code of student discipline conduct.

Sunnydale School donates Tk 1 lakh to Cancer Hospita

NATIONAL WOMEN DEVELOPMENT POLICY Call for cancellation of amended version

Women's rights activists yesterday reiterated their demand for cancellation of the amended version of the National Women Development Policy, saying that it would wipe out the achievements of women's movement during the last three

They also demanded restoration of the original policy formulated n 1997 in the light of the Convention on the Elimination of All Forms of Discrimination (CEDAW) and Beijing Platform of Action.

The Karmojibi Nari organised the discussion at the Jatiya Press Club to protest the changes brought to the policy. It said the government has violated women's rights by dropping the provisions of equal rights to economic policy and inheritance and equal participation in employment.

Karmojibi Nari President Shirin Akhter said the government has brought the changes only to serve the interest of a vested quarter.

misleading, says Indian HC The High Commission of India in


Dhaka yesterday termed the recent news reports on the Indira-Muiib Accord inaccurate and misleading, says a press release.

In a statement, the High Commission said an impression is being created in Bangladesh that India's non-ratification of the Indira-Mujib accord is holding back its implementation. But the fact is that legislative requirements in India necessitate that the process of boundary demarcation be completed before ratification by the Indian Parliament, it added.

India's ratification of the Accord has so far not taken place because the process of boundary demarcation remains incomplete due to non-agreement on 6.5kms of boundary, it said. In the case of Bangladesh, while it is a fact that the LBA was ratified soon after signature in 1974, it is pertinent to note that this ratification can come into effect only after demarcation of boundary has been actually completed. Therefore, de facto, India and Bangladesh are in the same position, it added. India's consistent position has

been to resolve at the earliest the outstanding elements in the Indira-Mujib accord pertaining to boundary demarcation, exchange of enclaves and adverse possessions, the statement said. It is with this objective that government of India had conveyed to the government of Bangladesh a "composite package proposal" on these issues during the last meeting of the Joint Boundary Working Group (JBWG) in March, 2002. Even after a passage of four years, we are still awaiting a response from Bangladesh to these proposals, it added. On the issue of exchange of

enclaves and adverse possessions, India has pointed out that a joint survey needs to be carried out, the statement said. The government of India has written to the Bangladesh Foreign Ministry in June 2005, conveying details of the logistics required to complete such a joint survey. Once again, there has been no response from the government of Bangladesh till date, it added.




