# Nabuat zealots hold rallies for mosque capture on Feb 10

Members of the Ahmadiyya community at Dhanikhola village in Trishal upazila are passing days in panic as the International Khatme Nabuat Movement, Bangladesh (IKNMB) is campaigning in the area in favour of its programme to 'capture' the Ahmadiyya mosque in the village on February 10.

Over 200 people of the community in the village are now virtually confined to their homes, apprehending trouble on February 10. Children have stopped going to schools and elders do not move out, even for days' work, locals said yesterday

Trishal police station. Central and local leaders of the community at a press conference here on February 3 also demanded steps by the local administration for security of their life and property.

Mymenisngh Police Superintendent Abdullahel Baki, the Officer-in-Charge of Trishal thana and the Upazila Nirbahi Officer (UNO), visited Dhanikhola village and Ahmadiyya mosque yesterday. The SP assured the villagers security of their life and property and

urged people of all communities in the area to keep patience and maintain peace Advocate Monzur Anam told this

correspondent over phone yesterday that local leaders of IKNMB are on a campaign to motivate people, specially teachers and students of madrasas in the area. to join their grand rally on February 10 morning and help them capture the mosque.

They are holding small rallies and distributing leaflets to make their programme a success, he said. Sharifuddin Trafder, chairman of Dhanikhola Union Parishad said that any move to disturb peace in the area will be resisted.

Ahmadiyyas have been living in the village since 1964 and the mosque was build in 1965. "We live here in peace and with amity", he added.

Two convicts in the sensational Chanpa Murder Case have surrendered to court Monday noon, court sources said.

The two convicts. Nasiruddin Jamal and Zillur Bari are brotherin-laws of the victim. Each of them was awarded seven years rigorous imprisonment (RI).

The main accused. Zahirul Alam Kamal, another bother-inlaw of the victim, was sentenced to life term RI in absentia.

Immediately after their surrender, District and Sessions Judge Md Safiuddin ordered the authorities concerned to send them to prison

Court sources said Fawzia Akter Chanpa, 26, an educated housewife and mother of a baby boy was murdered at the house of her industrialist father-in-law on the Fakirbari Road in the city on October 18 in 1989. During the incident, victim's husband Shahidul Alam was

abroad in connection with his business After her murder, some human rights organisations launched agitation for punishment to the

murderers. Court sources said the District

Judge Court sentenced all the three accused to life term RI. Following an appeal to High Court. two of them were acquitted of charges.

Later, a revision appeal was filed with the Supreme Court. Reviewing the lower court order, the Supreme Court maintained the order of life imprisonment of main accused Kamal and reduced punishment of Jamal and Zillur's to seven years RI.
