He mentioned that four secretaries have been changed during his three-year tenure.

Cabinet Secretary ASM Abdul Halim's presence and speech at a political meeting at Islampur in Jamalpur on December 31 last evoked sharp reaction in the administration. Rumours are afloat that Halim will contest the next elections on BNP ticket. His contractual service will expire in August.

A former cabinet secretary preferring not to be named, noted that such activities are a gross violation of government service rules. "Neutrality of the administration is destroyed in these ways. If a government employee wants to join politics, he must quit job or go into retirement," he said. But many of the high government

officials are found to engage in extra-administrative activities that are political in nature.

Meanwhile, the number of contractual appointments is also increasing and it now stands at more than 240. Most of such appointments and extension of contracts are being made on political grounds.
