Another Ctg worker dies

Death toll in Ctg garment fire rises to 55

Another worker injured in Thursday's fire at the KTS Textiles and Garments Industry died yesterday at Chittagong Medical Collage Hospital (CMCH), pushing the death toll to 55.

The dead was identified as 19year-old Monowara Begum, who vas undergoing treatment at the CMCH with severe burns.

Blocked road leads to severe snarl-up

TEIGAON BUILDING COLLAPSE

Another body dragged out, search on

One more dead body and two living workers were pulled out yesterday from the debris of the multi-storey building at Tejgaon that collapsed on Saturday as rescuers removed around one-fifth rubble 36 hours

day while clearing the rubble at the west corner of the collapsed structure. Details about the victim could not be known.

Meanwhile, one Abdul Barek, a mason rescued on Saturday, succumbed to his injuries at his Badda residence yesterday, raising the death toll to 18 until yesterday

Rescuers led by the army removed parts of debris from all sides of the building's top floor until last evening. They dug three holes through the concrete slabs of the next three floors but did not find anyone alive or dead in and

Waking up in grave

Sumon wakes up in a grave-like darkness. A construction worker, he was working on the ground floor when the building caved in with a boom, throwing him into a blackout. As he instinctively gropes around, he finds the roof hanging just two feet above, making it impossible to sit, let alone stand-

"Thank God," he thinks, "I have no major injuries and the surrounding space is empty, too." He crawls and gropes looking for a way out. After some 15 minutes, he arrives on the first floor, not much higher than the ground.

As if in a dream, he searches for a break in the wall through which he may get out. After several hours of fumbling and peering around in the debris, he comes upon a water bottle. By now he is drained of the last iota of strength and the water

Farmers' fury boils over

They agitate for fertiliser, power

Persistent fuel and power crises fanned further agitation among the fertiliser-hungry farmers as they continued barricading roads and hemming local government offices in several districts yesterday in the peakboro season.

Agitators in Tangail, Khulna, Satkhira, Rajshahi and Kishoreganj, among other districts, staged demonstrations demanding fertiliser and in protest against

As many as 10 people were injured in an attack during fertiliser distribution in Mollarhat upazila in Bagerhat. Awami League (AL) leaders clashed with police while laying a siege to the deputy commissioner's (DC) office in Satkhira.

In Tangail, hundreds of farmers along with common people besieged the Mirzapur Pally Bidyut

Samity office and barricaded Dhaka-Tangail Highway in the morning. They marched in a procession in front of the Pally Bidyut office around 10:30am.

Protesting the ongoing crises of power, fuel, fertiliser, and price hikes of essentials, speakers at a rally urged the government to initiate immediate move to deal

with the situating.

Participants of the rally blocked
Dhaka-Tangail Highway at 11:30am, disrupting vehicular movement for half an hour. Hundreds of buses, trucks and other vehicles were stranded on both sides of the road until the barricade was lifted.

A large number of leaders, activists and supporters of Krishak League laid a siege to the offices of Dumuria upazila nirbahi officer (UNO) and local agriculture in Khulna, demanding urea at a rea-

The agitators held a rally on the UNO office premises where they alleged the government is patronising dealers loyal to it for hoarding urea and selling it at higher prices.

They further alleged nine of the 15 dealers in connivance with the UNOs in the district have created an artificial crisis of fertiliser.

A source in the Department of Agriculture said they have already initiated probes into the matter with the help of intelligence agen-

The district needs 44,000 tonnes of urea annually, but only 16,340 tonnes were so far allocated in the current fiscal year, said a source in the DC office.

Bangladesh Chemical Industries Corporation is yet to allocate the full quantities of urea required to meet the demand of the SEE PAGE 15 COL 8

Rajuk in dark about Bill passed to sloppy buildings

The government's sloppy monitoring on the booming construction sector has once again come into focus with yet another building collapse in the city on Saturday. There are 4,376 buildings six to

22 stories in 66 localities of the city but Rajuk has no idea how many of these structures were built follow-ing proper construction rules, Rajuk sources said.

Unable to crosscheck docu-ments due to theft of over 250 files from its archive, Rajuk sources said t would not be possible to verify the legitimacy of many structures unless a door to door survey is

According to top officials of the Public Works Department (PWD) and Rajuk, the entire city is dotted with buildings which were either built without any approval of Rajuk or in total violation of proper construction rules. Officials said over 95 percent of all Rajuk approved structures in the city have been built deviating from original plans.

PWD officials said a large section of landowners, developers, engineers and architects are

involved in doing this. Rajuk, the sole authority to approve building plans and to monitor construction, is riddled with corruption where anyone can get anything done through a gang of highly influential and well-linked middlemen. For approval of a high rise build-

For approval of a high rise building, above six stories high, the developer has to seek clearances from 16 different service providers including, Department of Environment, Wasa, Desa, DCC, Caab and Titas gas. According to a developer who built a ten-storey structure recently in Kamal Ataturk Avenue, the clearances are readily Avenue, the clearances are readily available through Rajuk middle-men for a fee of Tk 1 lakh to 2 lakh. "We all know these papers are issued without any inspections or questions asked by any authorities but for the sake of an approved plan we have to buy them," said the developer requesting anonymity,

Once the construction work begins, in most cases the developer wilfully makes his own deviations because he knows the Rajuk construction inspectors would come just to collect the bribe from him. "When we start construction we
