'Molla Omar' supplied the bombs that killed judges

JMB explosives expert Molla Omar alias Shakil had made and handed over two bombs to suicide bomber Mamun who killed two judges in Jhalakathi on November 14 last

Mamun was also trained by Molla Omar, killed in a Rab (Rapid Action Battalion) operation in Comilla on Monday.

Molla Omar visited Barisal in mid-October last year along with JMB kingpins Abdur Rahman, Siddiqul Islam alias Bangla Bhai, Awal, Ataur rahman Sunny and Khalid. They plotted the Jhalakathi suicide bombing at a secret meeting. Two bombs were later handed over to Mamun to kill judges Sohel Ahmed and Jagannath Pandey in Jhalakathi

Mamun had blasted one bomb, killing the judges. Seriously injured Mamun was caught with another bomb from the spot.

Shakil's name was mentioned as Molla Omar for the first time in the charge sheet of the explosives case lodged in connection of judges' murder. A murder case was also filed in connetion with the iudaes' killina.

In the explosives case, Barisal Speedy Trial Tribunal in its verdict delivered on February 20, gave 40 years' rigorous imprisonment to Shakil and seven others. The seven are JMB kingpins Abdur Rahman, Siddiqul Islam alias Bangla Bhai, Abdul Awal, Ataur Rahman Sunny, Khaled Saifullah alias Amzad and Mamun

Dealers queue up for 'rationed' fertiliser

The Zia Fertilizer Factory (ZFF) in Ashugani has introduced 'rationing' of fertiliser, keeping dealers with trucks and barges waiting for days to lift their quota.

The factory has no stock and the dealers are being supplied from the daily production of 1200 tonnes, sources in the ZFF and dealers told this correspondent yesterday.

This correspondent yesterday saw long queues of trucks of dealers from different districts on the road in front of the factory. Many of them said they were waiting for a week for their turn to come.

If the factory goes out of operation due to any technical fault, there will be a serious crisis of urea in the eight districts under its jurisdiction, the factory sources said. The eight districts are Brahmanbaria, Comila, Chandpur, Kishoreganj, Netrakona, Gopalganj, Faridpur and Madaripur.

Tripping of the factory is not unlikely as it went out of operation 20 times during the current financial year, causing a total production loss of about one lakh tonnes. This is also one of the reasons for no buffer stock and rationing, they said.

The supply position tightened and rationing was introduced as Gopalganj, Faridpur and Madaripur districts were brought under its command area this month while it had no buffer stock due to earlier production disruptions, factory

sources said. The three districts were brought under the ZFF following production disruption in urea factories in Jamalpur and Ghorashal, it was gathered.

According to sources, 841 dealers now lift their quota from the factory every month.

The dealers are divided into two categories according to their areas, one getting 50 to 60 tonnes and the other 30 to 35 tonnes per month. But they are given these quantities in 2-3 installments in a month as urea is delivered from daily production, some dealers told this correspondent. As there is rationing, anomaly

Association, claimed the factory can not supply more than 1150 tonnes of urea daily now. He said 2500 to 3000 tonnes were supplied daily during the peak season last year. Factory sources said they can deliver 70 to 75 truckloads of urea

daily. About 400 tonnes are sup-

plied in barges and 80 to 90 tonnes

in railway wagons. When contacted, a high official of the factory seeking anonymity admitted that the buffer stock has been exhausted as three more districts were brought under its

After marriage, he started an electronics workshop at Delduar Sources said learning about Shakil's efficiency in electronics, the JMB highups assigned him to its bomb unit under Salahuddin, a member of the JMB Mailish-e-Shura.

Salahuddin trained Shakil in bombmaking at Baropakhia Kawmi Madrasa in Delduar. Within a few days, he acquired such expertise in the field to be called by his associates as "Mollah Omar" after the second top

most Taliban leader Shakil led setting up of several training camps in different parts of the upazila, including Baropakhia, Lawhati, Bhurbhuria and Elachipur. JMB chief Abdur Rahman and his younger brother Ataur Rahman Sunny used to visit these training camps and directed the training programmes.

In his first operation for the JMB, Shakil along with Sunny exploded a bomb at a Jatra Pala programme at Tukchandpur village in Delduar on

Meantime, he was appointed the JMB's Narayanganj district commander. Shakil had also supplied the explo-

sives which were used for killing two iudges in Jhalakathi on November 14 last vear. Hearing the news of Shakil's death

his mother Sufia Begum burst into tears. His father Ashraf Ali told The Daily Star at the Delduar Police Station that JMB chief Abdur Rahman misguided his son, engaged him in militancy and finally destroyed him in the name of "Jihad"

Nazrul Islam, officer-in-charge of Delduar Police Station, told The Daily Star that the police had been hunting for Shakil and had conducted several drives to net himsinceAugust17lastyear.

"Delduar police are still hunting for at least 30 listed JMB cadres in the upazila," he said.

DEVELOPMENT OF BHOMRA LAND PORT

Plan to acquire homesteads triggers protest

People of Laxmidari village facing eviction for development of Bhomra land port at a press conference yesterday said they are becoming victims of a conspiracy by some vested quarters.

They said authorities had earlier selected nearby croplands for acquisition for expansion and development of the land port. The decision was changed and their homesteads have been targeted at the behest of some influentials. A section of land department officials are also involved in conspiracy, they told the press conference.

Over 150 families, most of them of Hindu community, are residing in the villages for generations, local Union Parishad Chairman Shamsul Haque said at the press conference held at Satkhira Reporters Club.

Bangladesh Hindu Bouddha Cristian Oikya Parishad General Secretary Prof. Dr. Nim Chandra Bhoumik of Dhaka University and local Hindu community leader

Monoranjan Mukherjee also spoke. They said they earlier sought the prime minister's intervention to save them from eviction from their ancestral homesteads.

Responding to their appeal, the PM's office in a letter (memo no. 2005 (part-2) 299 dated 22.08.05) asked the Satkhira Deputy Commissioner's office to submit an elaborate report. But since then no action has vet been taken while land department has given them eviction notices, they said.

They urged the authorities again to stick to their earlier decision to acquire croplands, sparing their homesteads and threatened of tougher agitation programmes for non-compliance.

The programme will include hunger strike and sit-in on the zero point of Bangladesh-India border, ey said.

The government is acquiring lands to build parking area and warehouses for Bhomra land port.

The 150 families of the villagers have been agitating since notices were given on October 21 last year that their homestead would be acquired for the land port.

During a visit to the village on January 20, District Land Acquisition Officer Saidur Rahman told villagers that the government will have to pay a huge amount as compensation if homesteads are acquired instead of the earlier selected lands, they said
