being placed before the House. "What can we do if the speaker does not want the bills to be tabled. We have done our part by scrutinising and submitting reports recommending that the House permit the bills to be placed," Justice Mozammel Haque, chairman of the parliamentary standing committee on private members' bills and reso-

lutions, told The Daily Star yesterday. The committee at yesterday's meeting decided to meet the law minister to discuss the issue.

Irked by the law minister's instructions, the parliamentary standing committee on September 4 met the speaker to resolve the crisis. But the speaker refused to allow the bills to be tabled, upholding the ministry's say.

Since then, the parliamentary body has not convened a meeting until yesterday when it met after a recess of six months to discuss a new bill. Sources said the committee

members at the meeting expressed frustration over the stalemate. "There is no need to hold meet-

ings at the expense of public money when the speaker does not allow the private members' bills in parliament," committee member and Jatiya Party lawmaker TIM Fazle Rabbi Chowdhury told the meeting.

Echoing the view. Awami League (AL) lawmaker and committee member KM Jahangir said it is meaningless to keep the committee since the speaker does not accept its [committee's] recommendations "At first, the bills should be allowed to be placed. It should be left to the discretion of the House whether a bill should be passed or not," he argued. BNP lawmaker Abu Yousuf

Khalilur Rahman at the meeting proposed to meet the law minister, meeting sources said.

The committee chairman said they have decided to meet the law minister to discuss particularly the Code of Criminal Procedure Act (amendment) bill. The other issues including the fate of the other bills will be discussed in general, he added.

Instead of giving his (speaker's) nod to place the bills in parliament, Speaker Jamir Uddin Sircar in a letter on October 27, 2003 sought the law minister's recommendations on private members' bills.

After the law, justice and parliamentary affairs ministry consented to the bills, the speaker had asked the Parliament Secretariat to send the bills back to the law ministry for further scrutiny, delaying the process of tabling the bills in parliament.

Although the speaker later gave go-ahead to 11 bills, the law minister's letter on February 3 stopped the process

LAWMAKERS' VIEWS

BNP lawmaker Adbul Mannan and JP deputy GM Quader have piloted two bills regarding amendment to article 70 of the constitution that prevents the lawmakers from floorcrossing and forces them not to speak against the party decisions. The article also discourages the lawmakers from criticising the party's decision in parliament, even

if he or she considers the party stance wrong. A lawmaker loses membership if the party expels them for going against its decision.

Both Mannan and Quader have proposed to amend article 70 to ensure individual freedom of the lawmakers in the greater interest of parliamentary democracy.

They proposed that a Member of Parliament, elected as a candidate from a political party, shall vacate his seat if he voluntarily resigns from the party or votes in a motion of noconfidence in the cabinet against his

A lawmaker's seat should not fall vacant in case of being expelled from the party that nominated him for election, said both the lawmak-

BNP lawmakers Mannan Rustam Ali Farazi and Jamaat-e-Islami lawmaker Shah Mohammad Ruhul Quddus have moved three separate bills proposing tightening the relevant rules so that the lawmakers and political parties cannot boycott parliament at will.

The existing constitutional provision says a lawmaker will lose their seat in parliament if they remain absent from the House proceedings for 90 consecutive days. The three lawmakers have proposed cutting the time to 60 davs

Another BNP lawmaker Ali Newaz Mahmud Khaivam however has proposed to make it 30 days. Abdul Mannan has piloted

another bill seeking amendment to the constitutional provisions regarding the election and removal of the speaker and the deputy speaker.

The existing provision says the speaker and the deputy speaker are elected through simple majority and they can be removed also by simple majority. But Mannan proposed that two-thirds majority should be

required in both cases He has moved another bill for constitutional amendment in order to deter the judges of the Supreme Court from feeling 'embarrassed'. In the bill, he asked for constitutional provisions for strengthening the

oath of the judges. GM Quader has submitted another bill where he proposed fixing the tenure of the chief justice at five years from the date he assumes office. The existing provision says the chief justice can remain in office until he is 67 years

old Another bill by Farazi seeks a constitutional provision barring the candidates from contesting the parliamentary election from more than two constituencies. Although there is no specific constitutional provision on this, an ordinance promulgated during the Ershad regime barred a person from con-

On the proposed governmentopposition discussion. Hasina said. 'Agenda for the discussion must be clear first. The two sides will then discuss what part of proposed reforms could be accepted or where it could be changed."

The leader of the opposition mentioned that they placed the reform proposals in parliament but the leader of the House proposed formation of a committee to discuss it without saying whether they (govt) would accept the proposals or not.

The prime minister's proposal also did not specify if the committee would be a parliamentary one or comprise political leaders, showing the government is not sincere about it. Hasina said.

"The prime minister is talking about dialogue for reforms and at the same time she is turning down reform proposals one after another." the AL chief said. "We have demanded that the armed forces are to be under the control of the caretaker government chief during his tenure but the prime minister at a recent rally said they would be under the president.'

The AL chief said the 14-party opposition combine will continue its movement to force the government to accept the reform proposals. People now want an end to the coalition government's misrule and they are wanting for a change, she added.

"The BNP-Jamaat government has completed all sorts of election engineering to rig the next general elections. That is why it does not want to implement the opposition's reform proposals.'

Aktel has installed 23 base stations, CityCell five and Banglalink three such stations along the border, the regulator said.

"These base stations are too close to the border and they emit signals inside the Indian territory, says the BTRC letter.

"It makes communicating from India with anyone in Bangladesh very easy, hindering the antismuggling and anti-terrorist operations." the regulator claimed.

The BTRC in the letter summoned all operators yesterday and demanded decommission of their respective network infrastructures within eight kilometres of the border. The operators have. however,

Sources said a special superintendent of police at the Criminal Investigation Department (CID) heads the home ministry probe committee while a BB representative and a Rapid Action Battalion official are the members.

"We'll decide our action after aetting report of the committee. State Minister for Home Affairs Lutfozzaman Babar told The Daily Star vesterday

The government is determined to take drastic action to root out militancy from the country, he said, referring to the process of formulating an anti-terrorist act.

"We're ready to take action as soon as we get any information regarding the militants' financial sources and network," said the minister

He also said: "We made the CID special superintendent as head of the committee as he has received training in dealing with money laundering cases."

Following the arrest of militant kingpin Abdur Rahman and seizure of some banking documents from his busted Sylhet hideout on March 2, five BB teams probed three branches of Islami Bank, and one

each of Rupali and Janata Bank. The seized documents are related to Rupali Bank's Pallabi Branch in Dhaka, Janata Bank's Brahmanbaria Branch and Islami Bank's Lal Dighirparh Branch in Sylhet.

The probe teams found some lapses in banking norms and suspicious transactions with three Islami Bank branches in Sylhet, Gazipur and Savar, said sources.

The three branches of Islami Bank violated some of the regulations specified in the Anti-Money Laundering Act, specially the section called 'Know Your Customer (KYC)'.

Despite the fact that there were some "dubious" transactions in its Sylhet branch, the Islami Bank did

not report it to the central bank as demanded by law, the sources added.

One Sabbir Ahmed opened the account with the Lal Dighirparh Branch, but it was operated by Saidur Rahman, former Habiganj district ameer of Jamaat-e-Islami. The account with Rupali Bank's Pallabi Branch is in the name of Saidur.

The BB on Tuesday served a show-cause notice to the chief executive of Islami Bank on the alleged irregularities in the dubious accounts and asked him to reply within 10 days.

Sources said the probe report sent to the home ministry does not have any recommendation -- it only shows the findings. The account holders, account numbers and others who had done transactions with those accounts have been mentioned in the report.

Terming Khaleda Zia's state visit to India 'highly important,' he said the prime minister would discuss the placing wreaths on his portrait at the entire gamut of bilateral issues with her Indian counterpart Dr Manmohan Singh.

> Apart from the security issue, trade imbalance, removal of nontariff and para-tariff barriers to Bangladeshi products and sharing of water of common rivers including Teesta, will come up for discussion during the Khaleda-Manmohan talks in New Delhi on March 21, Morshed Khan said.

"Our relations with India is very important economically, geographically and strategically too," the foreign minister said adding that the prime minister wants strong relationship with India for the benefit of the people of the two countries as well as for economic development. Dhaka will also try to explore new areas of cooperation during the visit, he said.
