Jama'atul Mujahideen Bangladesh (JMB) Ehsar members Arifur Rahman Hasib alias Akash and Jahirul Islam alias Zahir have confessed to their involvement in bomb blasts in Gazipur on November 29 and on August 17 respectively.

They gave confessional statements before First Class Magistrate Hasanul Matin in Tangail under Section 164 on Wednesday.


In Sherpur, JMB district commander Mujahidul Islam Sumon was placed on three days' fresh remand when he was produce before court on Thursday on expiry of his 10-day

Akash of Chackpara village in Sreepur upazila in Mirzapur district was arrested in Chittagonj.

He was shown arrested in Tangail after police, acting on his confession, on February 1 arrested Jahir and JMB cadres Shahadat Hossen alias Imran from Namasola village in Kaliakair upazila in Gazipur district and Mahmudur Rahman alias Russel from Asgana village in Mirzapur upazila in Tangail and recovered two grenades along with four detonators and 33 lead splinters from a bush near Russel's house.

On the same day, SI Tapash Chandra Pandit of Mirzapur police station in Tangail and SI Shakil Ahmed of Gazipur Sadar police filed two cases accusing the five militants.

Akash admitted that he took part in bomb blasts at Gazipur Bar

Association office on November 29.

Jahir confessed to his involvement in the August 17 serial bomb blasts at Gazipur road-intersection

Jahir told the court that he was recruited by Gazipur JMB commander Nizam Uddin Reza and become an Ehsar member of JMB within few days. Reza is also a charge sheeted accused in Gazipur bomb blast case.

Earlier, Imran and Russel in confessions before a magistrate court under Section 164 said they got bombs from Reza and blasted those in Gazipur on August 17. Reza is yet to be arrested. Police said they are hunting for Reza hailing fromf Mollarhat upazila in Bagerhat dis-

Imran and Russel said they were students of Kaliakair Senior Fazil Madrasa

Quoting the arrested JMB cadres, sources in Gazipur and Tangail police said militants were trained in . 14 dens in Tangail and Gazipur

These were in Asgana, Kanchanpur, Taktarchala, Kalian, Namasola, Ashulia, Bhati Khalpar, Media, Solai, Rashidpur, Mazidpur, and Telina villages in Mirzapur and Sakhipur upazilas in Tangail district and Kaliakair upazila in Gazipur.

They said JMB leader Enayetullah alias Jwel, arrested from Joydevpur with a huge quantity of bomb making materials few months back, had recruited a large number of militants from the areas

staying at a rented house at Balla in Kalihati upazila in Tangail district. Jwel hailed from Kotalipara upazila in Gopalgani district.

In Sherpur, arrested Sumon told interrogators that he was an aide to JMB kingpin Abdur Rahman. He was arrested from Gourdar village in Nokla upazila in Tangail on March

Police said they got important information from Sumon but declined to give details for the shake of investigation

On August 17, six bombs were exploded at five points in Sherpur town including the office premises of the Deputy Commissioner and the District Judge. Police recovered an

Forest officials arrested four deer hunters with a gun and ammunition and recovered a slaughtered deer from their possession on a boat on Arpangashia river in the



Potato yield lowest in 5 years

30pc space in cold storages to remain empty in N-dists

Potato production in Nilphamari this year would be around half of last year's quantity and at least 30 per cent space in clod storages will remain empty.

The production has been the lowest in five years due to massive attack by 'late blight' disease in plants, Agriculture Extension Department (AED) officials said. The situation is the same in all the eight districts in greater Rangpur and Dinajpur, they said.

The slump in production has already hit markets. The wholesale price is Tk 700- 800 per 84 kg bag against last year's Tk 350-300. In the Tk 10 per kg against Tk 4-5 last year. The prices will soar further, traders and cold storage owners said.

The cold storage are also facing

potato crisis. Immature potatoes collected from lands are rotting.

Farmers cultivated potato on 16,495 hectors of land in Nilphamari, which is 1,475 hectors more than that Immediately after sowing, farmers

faced a severe blow when it rained heavily in the later half of October. Farmers in most areas in Nilphamari prepared lands again and sowed seeds. But when plants matured, it was late Most potato fields were attacked with 'late blight' a wild virus that destroys plants in three-four days. AED Plant protection specialist

plants turn yellowish and die within 3-4 days, most potatoes under the ground remain immature. After collection, immature potatoes start rotting with ifteen days and cannot be preserved.

tion of potato was around 14 tonnes per hactare, which came down to arounf seven tonnes this year.

Managing Director of Mukta Cold Storage in Jaldhaka, Sayed Ali, said at least 30 per cent of his cold storage will remain empty this year as farmers ad traders are not giving reservation orders.

He said immature potatoes collected from lands would rot in cold storage within a short time.

Sylhet int'l trade fair uncertain

Students oppose use of MC college, ministry orders probe into alleged irregularities

Holding of the International Trade Fair in Sylhet by Sylhet Chamber of Commerce and Industry (SCCI) at MC College ground has become uncer-

The ministry of commerce in a letter sent to Sylhet Deputy Commissioner has asked the administration to probe the allegation of corruption by fair organisers in selecting the 'event management firm'. The letter reached the DC office on Wednesay.

On getting a complaint from Bangladesh Moslin and Jamdani Foundation, the ministry asked the Deputy Commissioner to stop the fair and look into the irregularities and corruption in selecting the firm. The DC has been asked to send the probe report within seven days, official sources said

The Sylhet Chamber of Commerce and Industry (SCCI) had earlier announced that the fair would open on March 23. To organise the fair, it had selected an 'event management firm'

from Chittagong. Accordingly, work began at the MC College ground, which sparked commotion among students as HSC

annual examinations are nearing. As the students protested, the college principal also withdrew the permission for holding the fair two weeks ago and asked SCCI to stop

preparing the field for the fair. Students in banners of different organisations and forums held rallies and handed over memorandums to

the principal for stopping the fair. Meanwhile, seeing students' commotion, the administration also showed a lukewarm response to the

SCCI initiative A meeting of the fair advisory committee held last week with Divisional Commissioner in the chair could not take any decision about holding the fair on the MC College ground

However, SCCI President Faruque Ahmed Misbah told The Daily Star yesterday that he did not get any letter from any quarter to stop preparations for the fair.

"I saw the news (about the fair) in some local newspapers. The ministry has just asked the DC to make an inquiry. We will try to make our position

clear if there is any inquiry", he said. "We talked to students and the principal and hope things will be alright soon", Misbah claimed.

He alleged that some vested quarters were provoking students not to allow the fair on the college. "We hope to start the fair in the first

or second week of April". Misbah

added. However, some student leaders told this correspondent that they would not allow the fair on the college ground.
